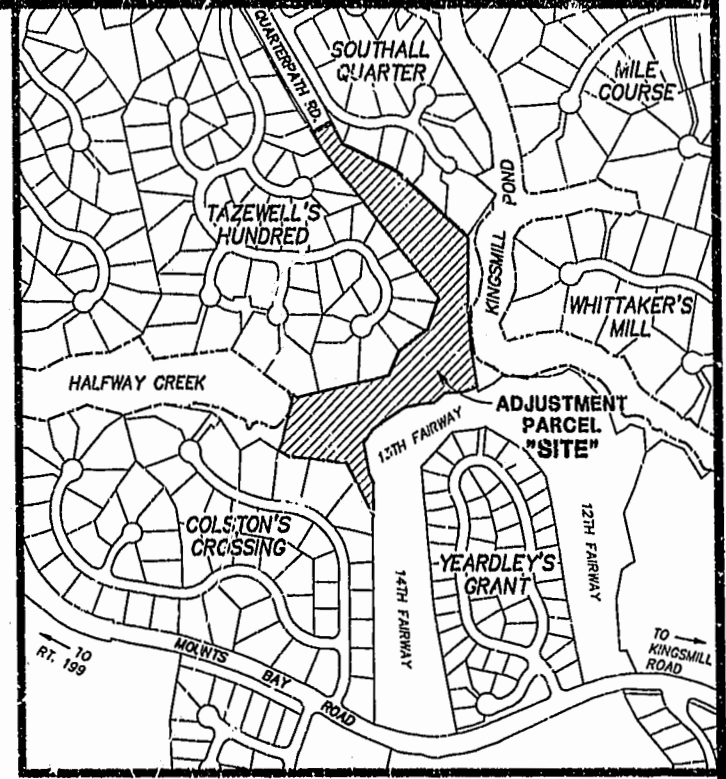

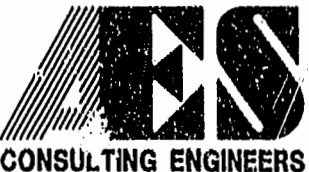
LOCATION MAP 1"=500'
