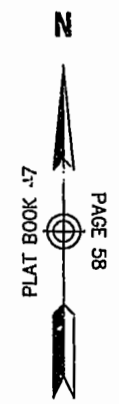
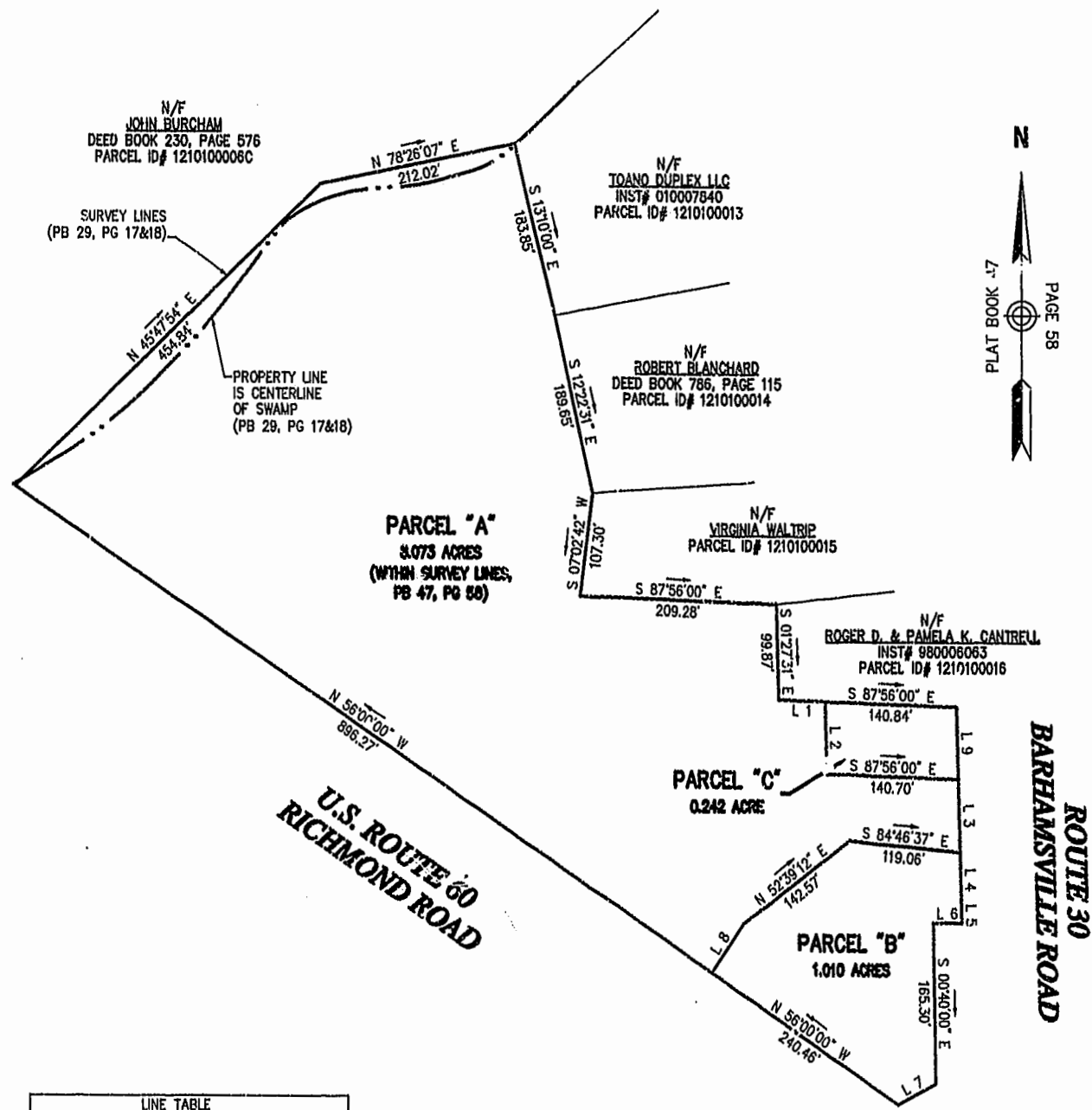
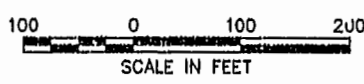


VICINITY MAP
