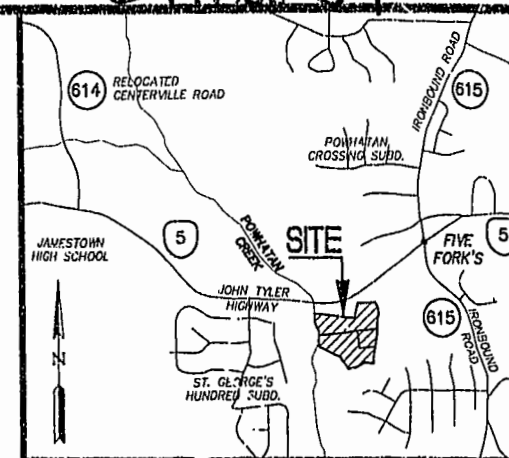

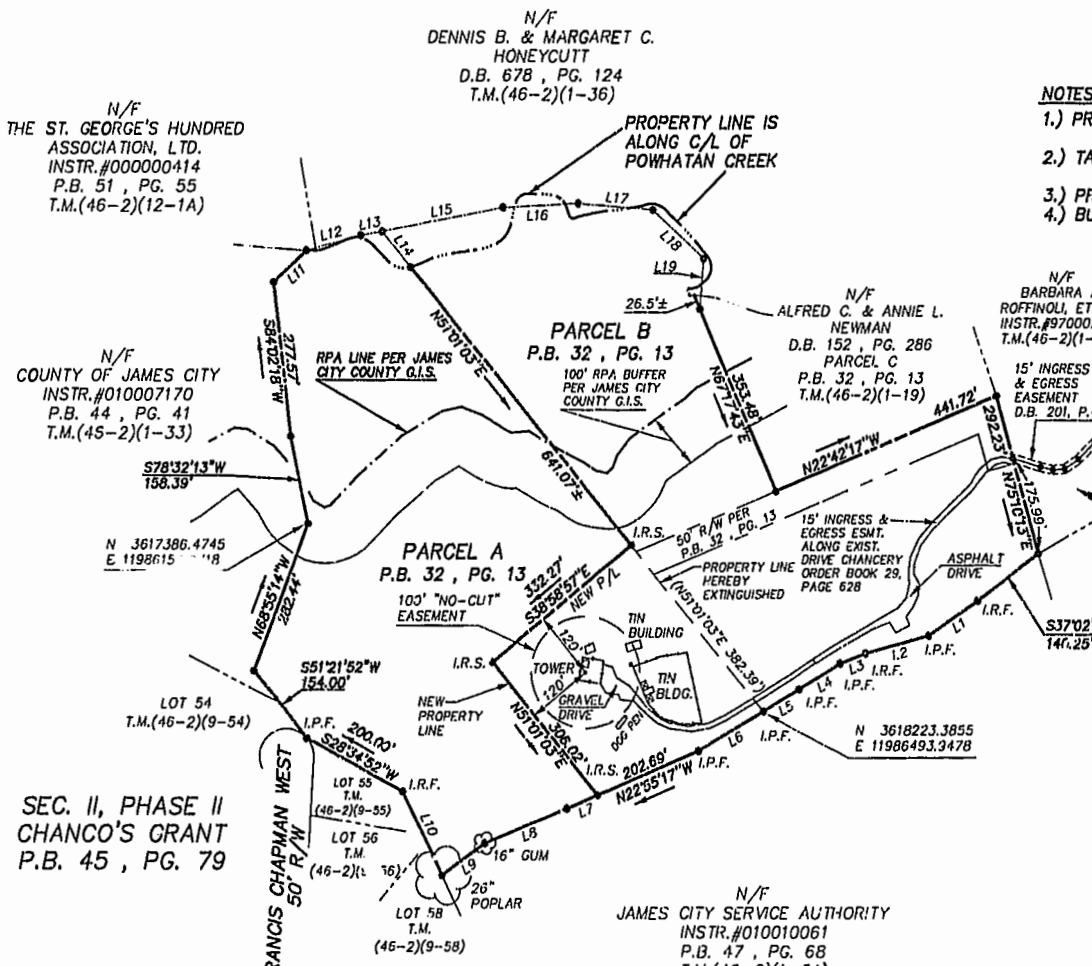

GEODETIC CONTROL MERIDIAN



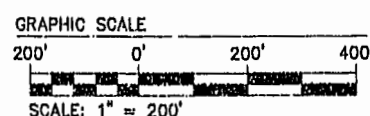
VICINITY MAP

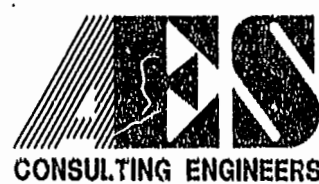
