



GENERAL NOTES

- 1. PROPERTY IS ZONED R 4 RESIDENTIAL PLANNED COMMUNITY
- 2. ALL UTILITIES ARE TO BE PLACED UNDERGROUND.
- 3. PROPERTY IS SERVED BY PUBLIC WATER, PUBLIC SEWER, AND PRIVATE STREETS.
- 4. THESE LOTS ARE PARTLY IN THE 100 YEAR FLOOD PLAIN. THE 8.5 ELEVATION FLOOD PLAIN IS SHOWN ON THE PLAT.
