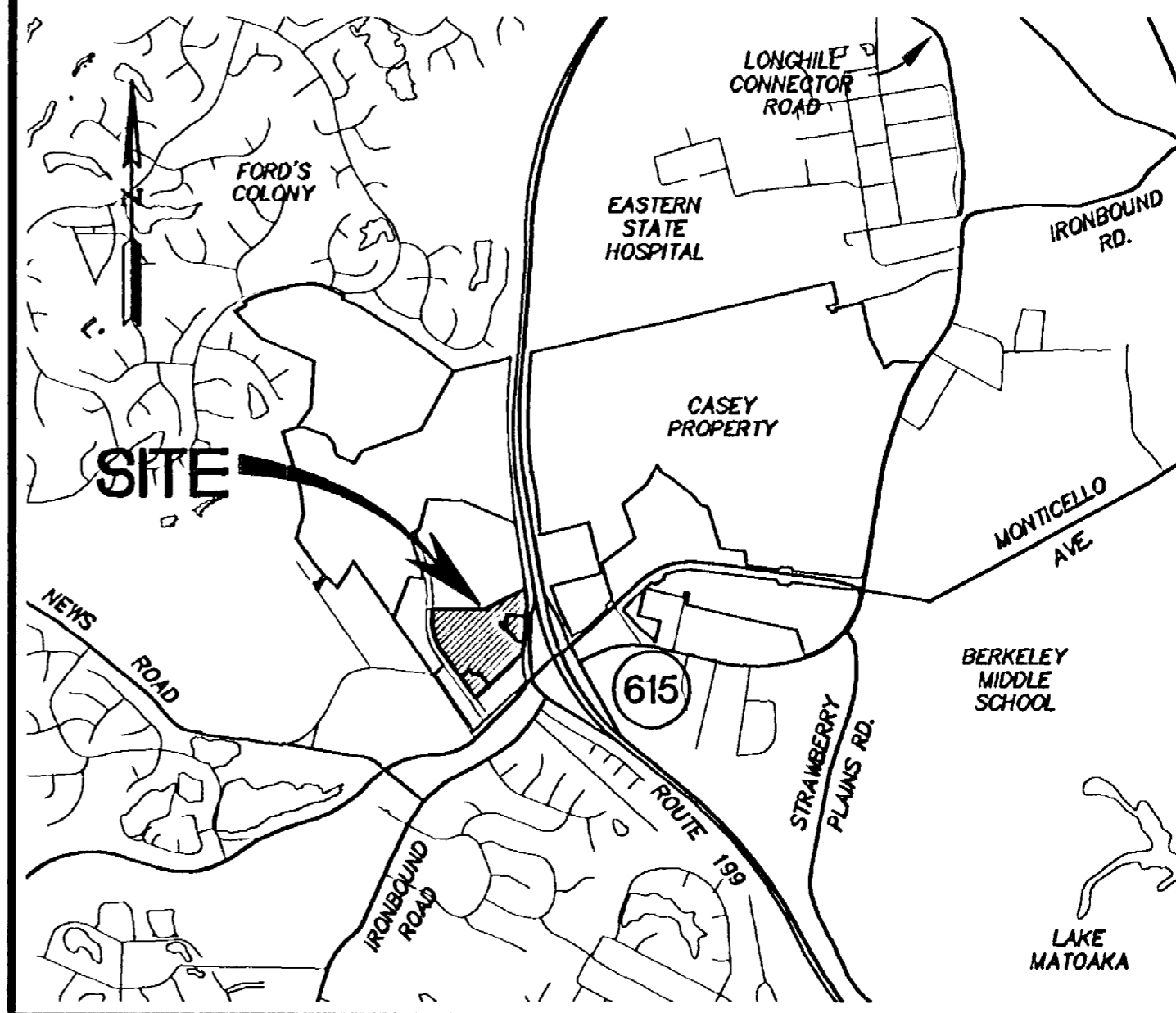

1. PROPERTY IS ZONED MIXED USE WITH PROFFERS (FOR PROFFERS REFERENCE JCC CASE NOS. Z-03-01, MP-02-97, Z-05-03, AND MP-08-03.
2. THIS PLAT WAS REVIEWED BY THE NEW TOWN DESIGN REVIEW BOARD ON NOVEMBER 18, 2004 IN ACCORDANCE WITH THE WINDSORMEADE MARKETPLACE PROFFERS.
3. THE PROPERTY TAX PARCEL NUMBER AND ADDRESS FOR PARCEL 1 HAS NOT BEEN ASSIGNED.
4. SETBACKS AND BUFFERS WILL BE AS SET FORTH IN THE PROFFERS AND AS IDENTIFIED FOR MIXED USE IN THE JAMES CITY ZONING ORDINANCE.

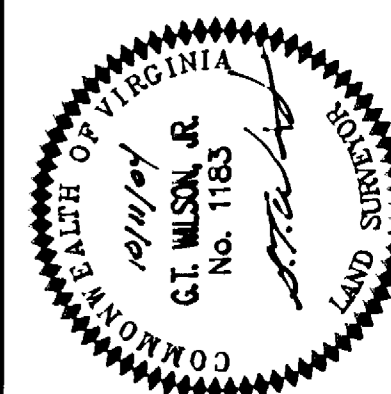
