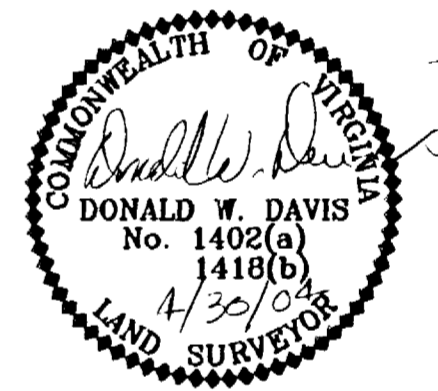

- THE DRIVEWAY TO BE CONSTRUCTED ALONG THE CENTER OF THE SHARED ACCESS EASEMENT IS TO BE A PAVED SURFACE AT LEAST TEN FEET WIDE AND THREE INCHES DEEP.
- GRINDER PUMP SHALL BE INSTALLED TO SERVICE LOT 3 AT DEVELOPERS EXPENSE. THE PUMP SHALL BE CAPABLE OF DELIVERING 15 GPM AGAINST A RATED TOTAL DYNAMIC HEAD OF 0 FEET (0 PSIG) AND 9 GPM AGAINST A RATED TOTAL DYNAMIC HEAD OF 138 FEET (60 PSIG).
