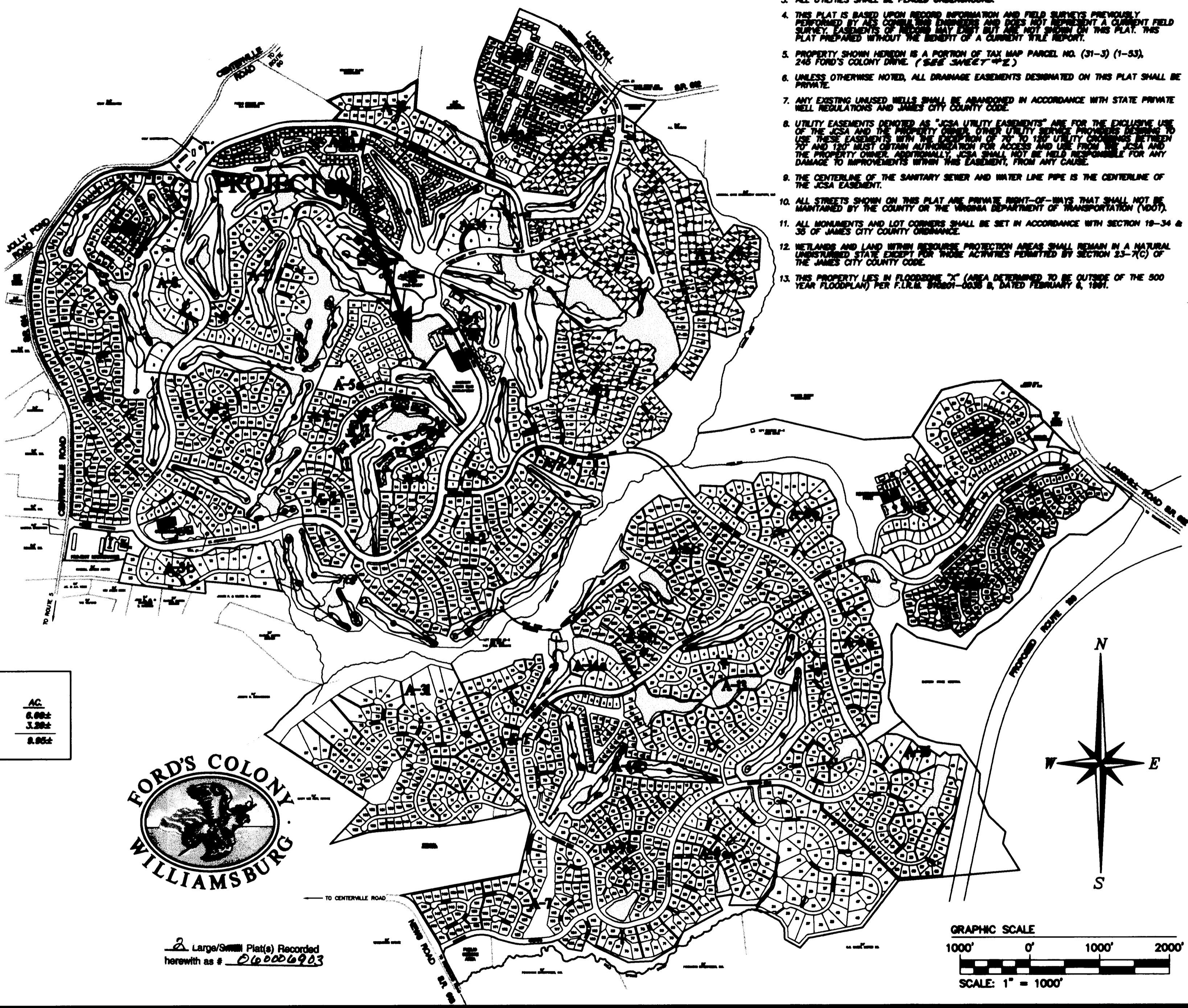

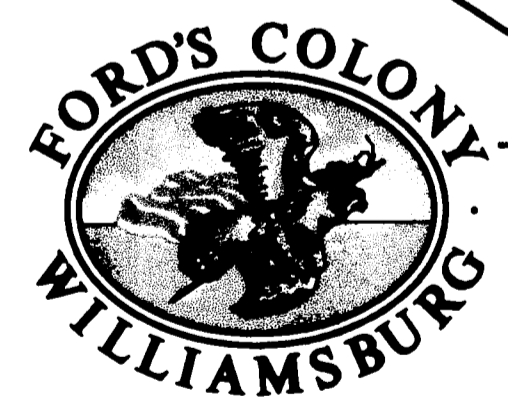

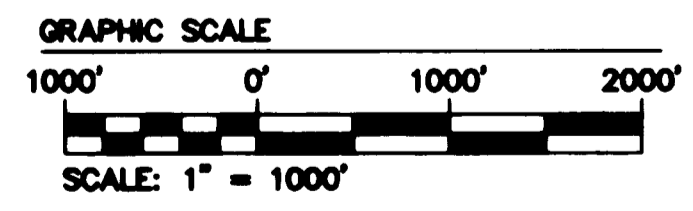

 2. ALL LOTS ARE SERVED BY PUBLIC WATER AND SEWER.
 3. ALL UTILITIES SHALL BE PLACED UNDERGROUND.
 4. THIS PLAT IS BASED UPON RECORD INFORMATION AND FIELD SURVEYS PREVIOUSLY PERFORMED BY ASS. COMB. ENG. SURVEYORS AND DOES NOT REPRESENT A CURRENT FIELD SURVEY. EASEMENTS OF RECORD MAY EXIST BUT ARE NOT SHOWN ON THIS PLAT. THIS PLAT PREPARED WITHOUT THE BENEFIT OF A CURRENT TITLE REPORT.
 5. PROPERTY SHOWN HEREON IS A PORTION OF TAX MAP PARCEL NO. (31-3) (1-53), 245 FORD'S COLONY DRIVE. (SEE SHEET #12)
