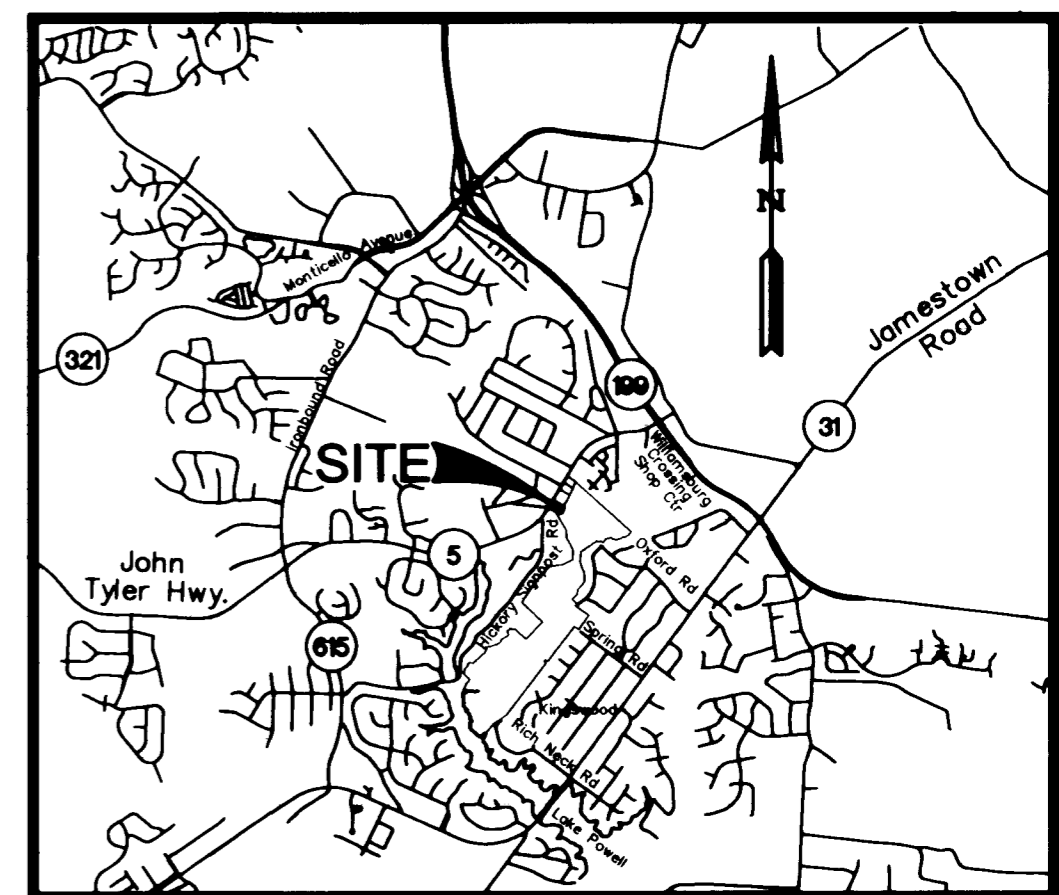

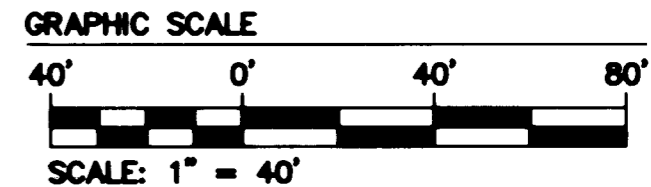
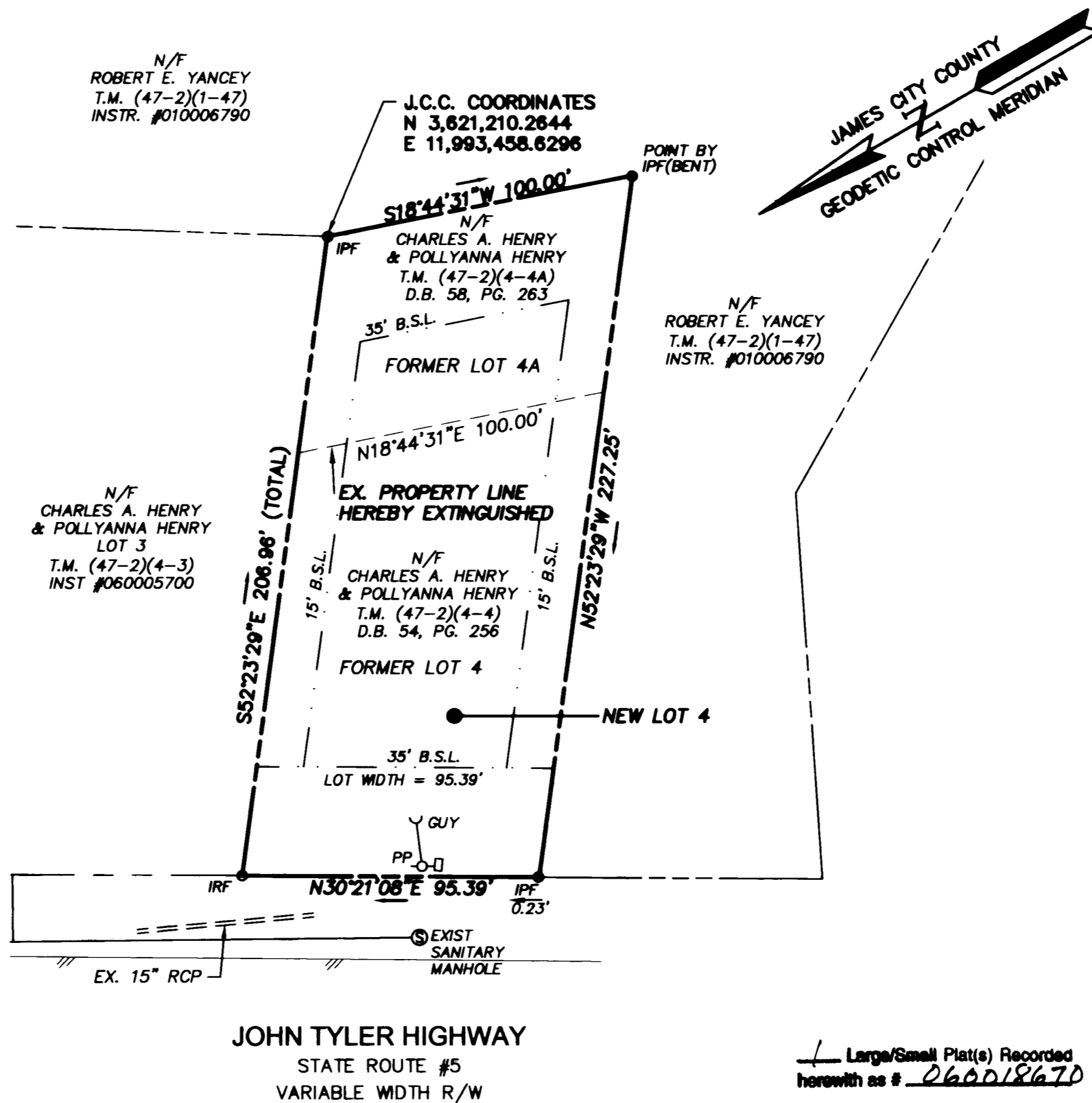
**GENERAL NOTES**

2. SETBACKS:

3. LOTS SHALL BE SERVED BY PUBLIC SEWER AND WATER.
4. MONUMENTS SHALL BE INSTALLED IN ACCORDANCE WITH SECTIONS 19-34 THROUGH 19-36 OF THE JAMES CITY COUNTY SUBDIVISION ORDINANCE.

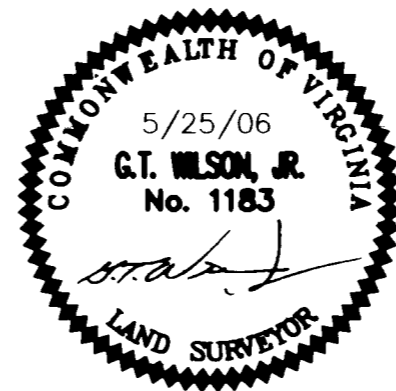
