## SCHEDULE "A"

City

ALL that certain lot, piece or parcel of land, lying and being in James County, Virginia, known as 8435 Hicks Island Road as shown on a plat of survey entitled "Improvement Location Survey of 0.94 Acre Parcel Located at #8435 Hicks Island Road James City County" (the "Plat") prepared by AES Consulting Engineers, dated April 10, 2009, and attached hereto and to which plat reference is hereby made for a more particular description of the property conveyed.

BEING the same real estate conveyed to John T. Hannah and Lucille H. Hannah husband and wife, as tenants by the entirety with the right of survivorship as at common law, by Deed from Matilda W. Lewis and Alice Florine Bruffey, dated February 11, 1976, and recorded February 18, 1976, in the Clerk's Office, Circuit Court, James City County, Virginia in Deed Book 166, page 410 and by Deed of Correction dated March 29, 1976, recorded July 7, 1976, in Deed Book 169, page 585, wherein the last names of the Grantees were corrected to Hanna. The said Lucille H. Hanna died November 4, 2005 thereby vesting fee simple title in John T. Hanna by operation of law.

Together with a non exclusive, perpetual easement for ingress and egress over the existing dirt drive shown on the Plat as "exist. dirt drive" and the existing dirt drive as it crosses the remaining land of the Grantor. Grantor reserves the right to relocate this easement on the remaining property of the Grantor provided the condition of the new drive within the relocated easement is constructed to at least the condition of the drive as it exists at the time of relocation, all at the sole cost and expense of Grantor. Grantor further reserves to himself, his successor and assigns an easement for ingress and egress over the "exist. dirt drive" where it crosses the property herein conveyed and is used to access Grantor property to the west of the property herein conveyed.

Together with all the right title and interest of the Grantor in and to the easement of ingress and egress over the existing road that has been used by Grantor, his predecessors in title and other property owners to the north and east of the property of the Grantor, from the property of Grantor to the state maintained road.

The parties hereto and their successors and assigns shall maintain the dirt drive in proportion to the number of owners that use any portion of the dirt drive.
