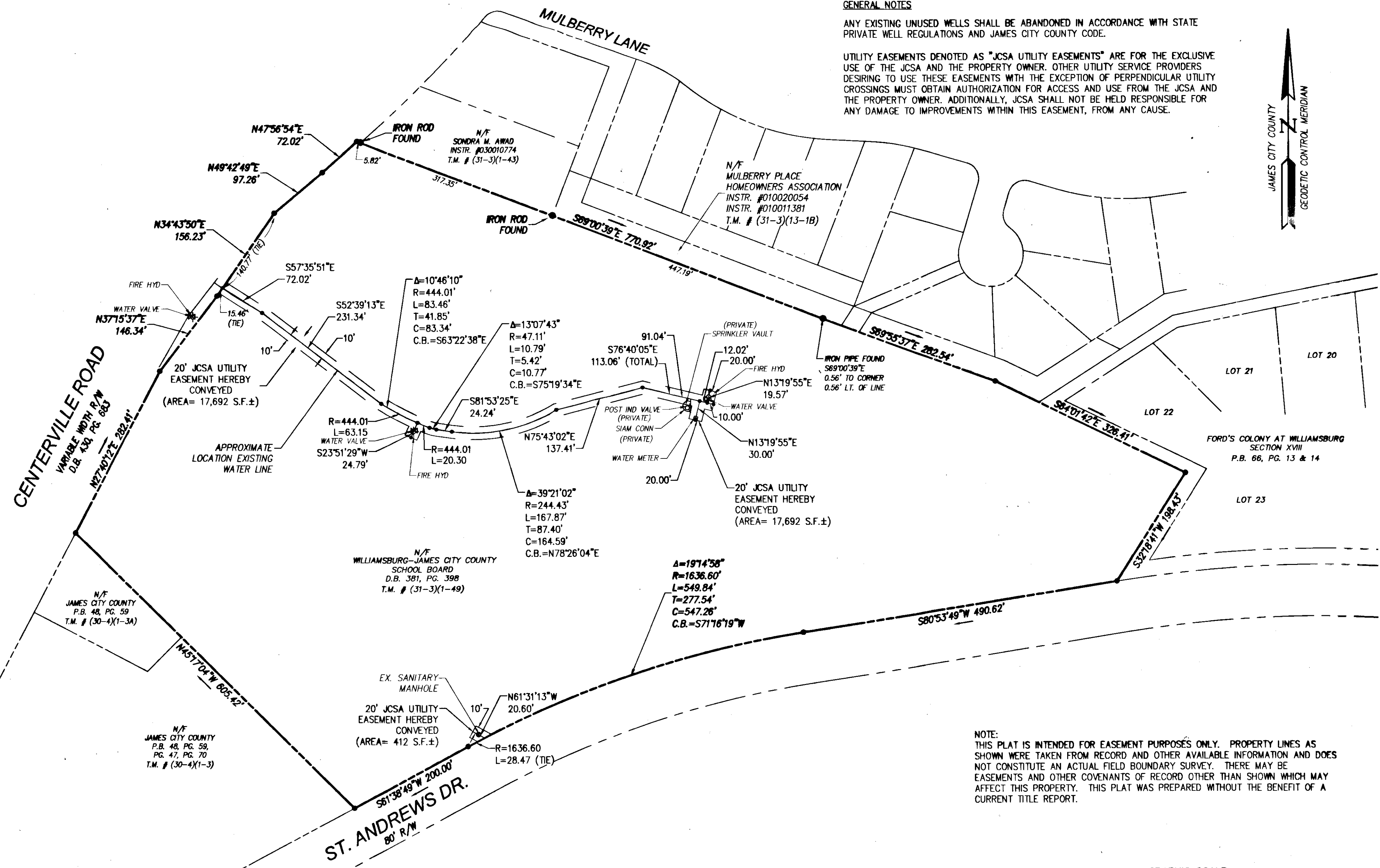
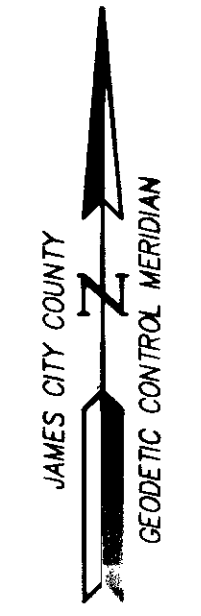

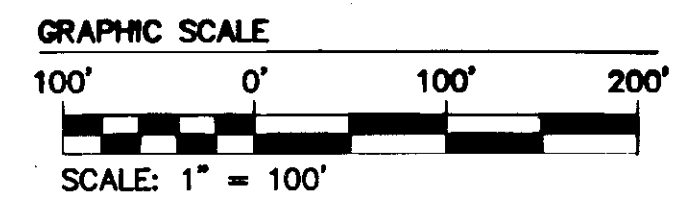
**GENERAL NOTES**

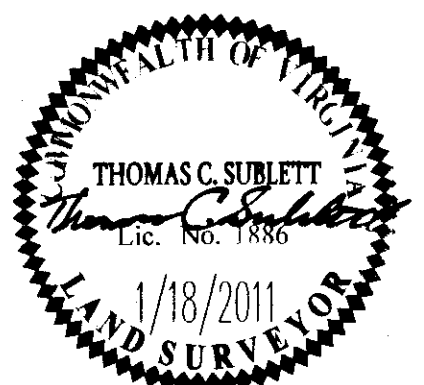
