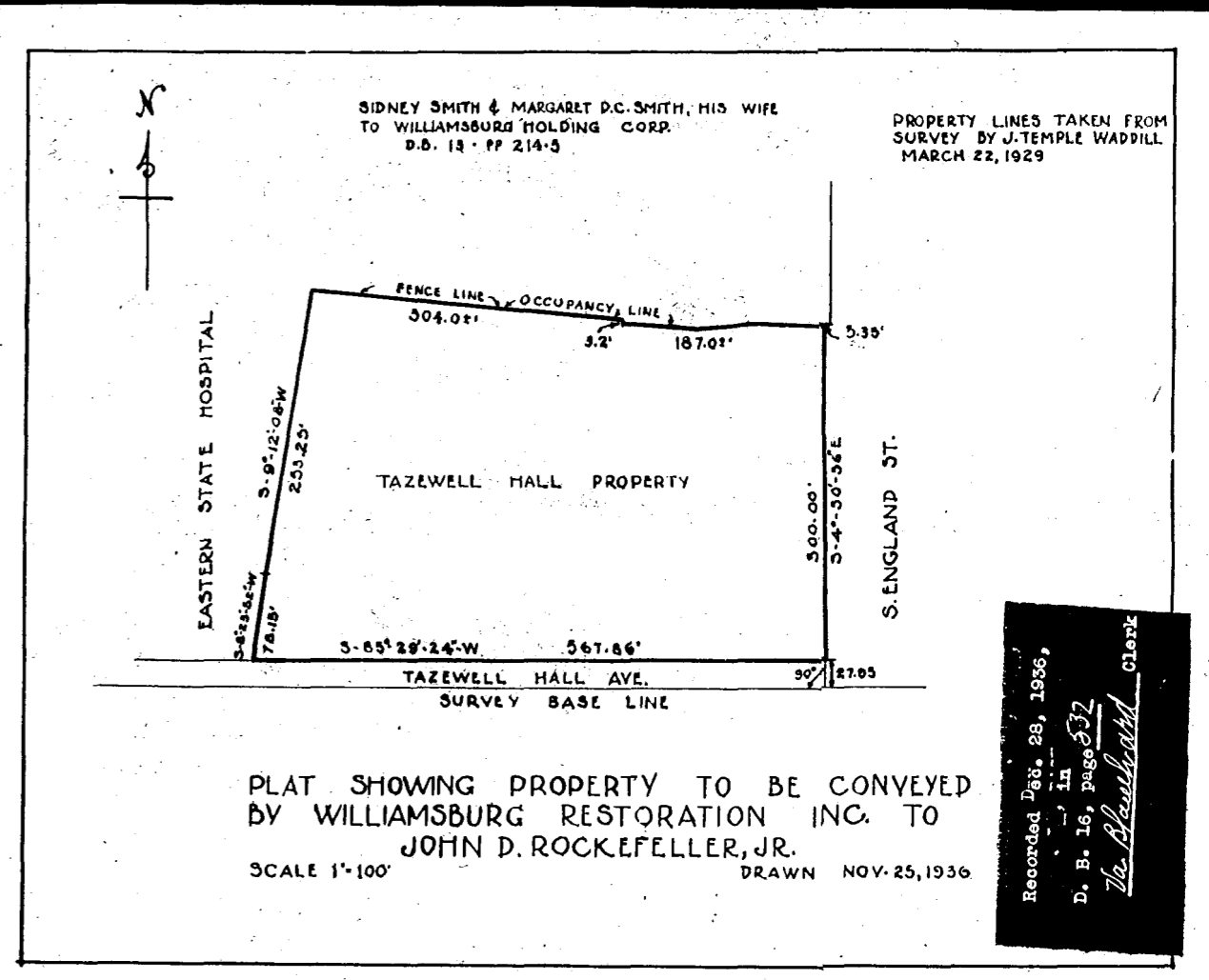

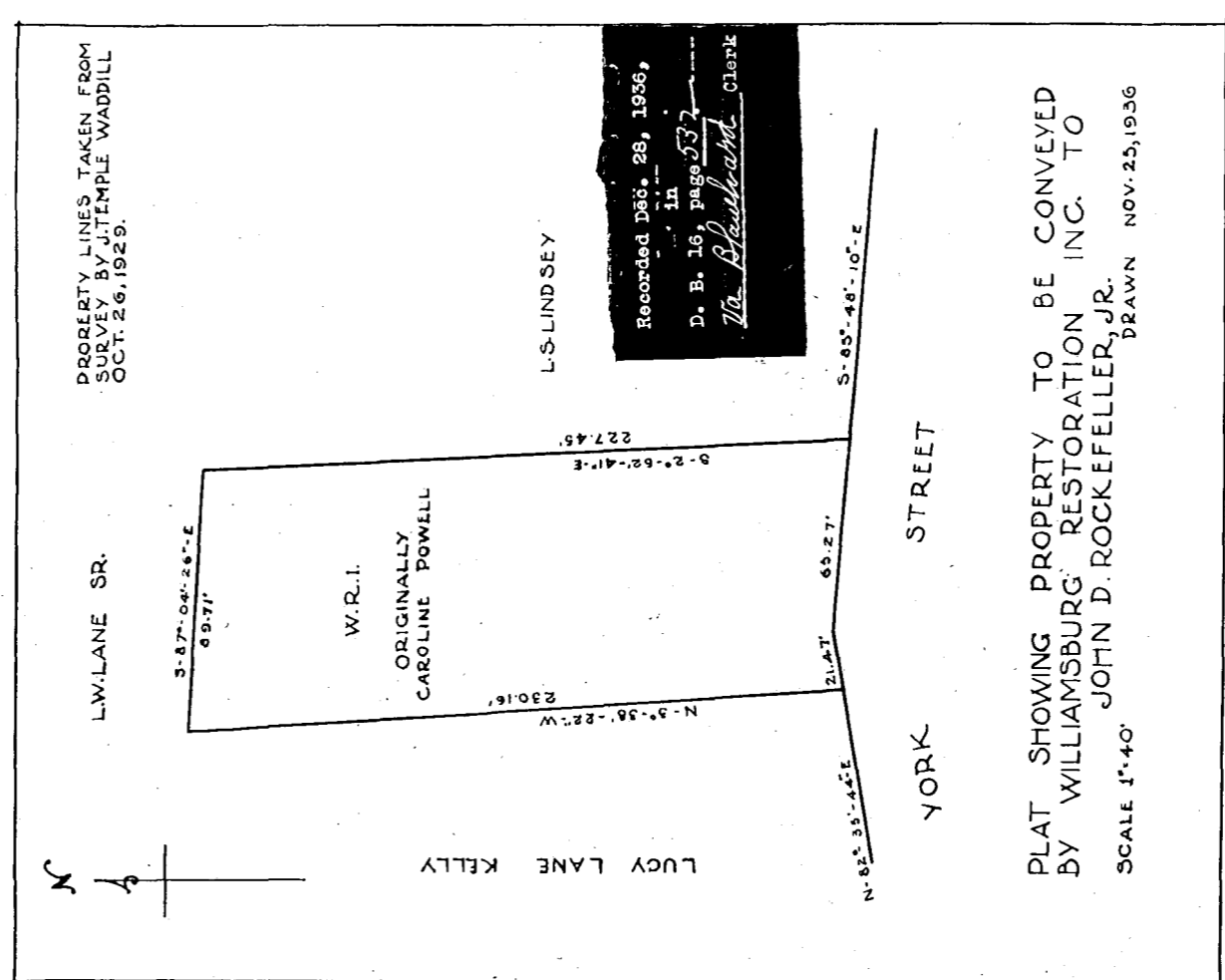

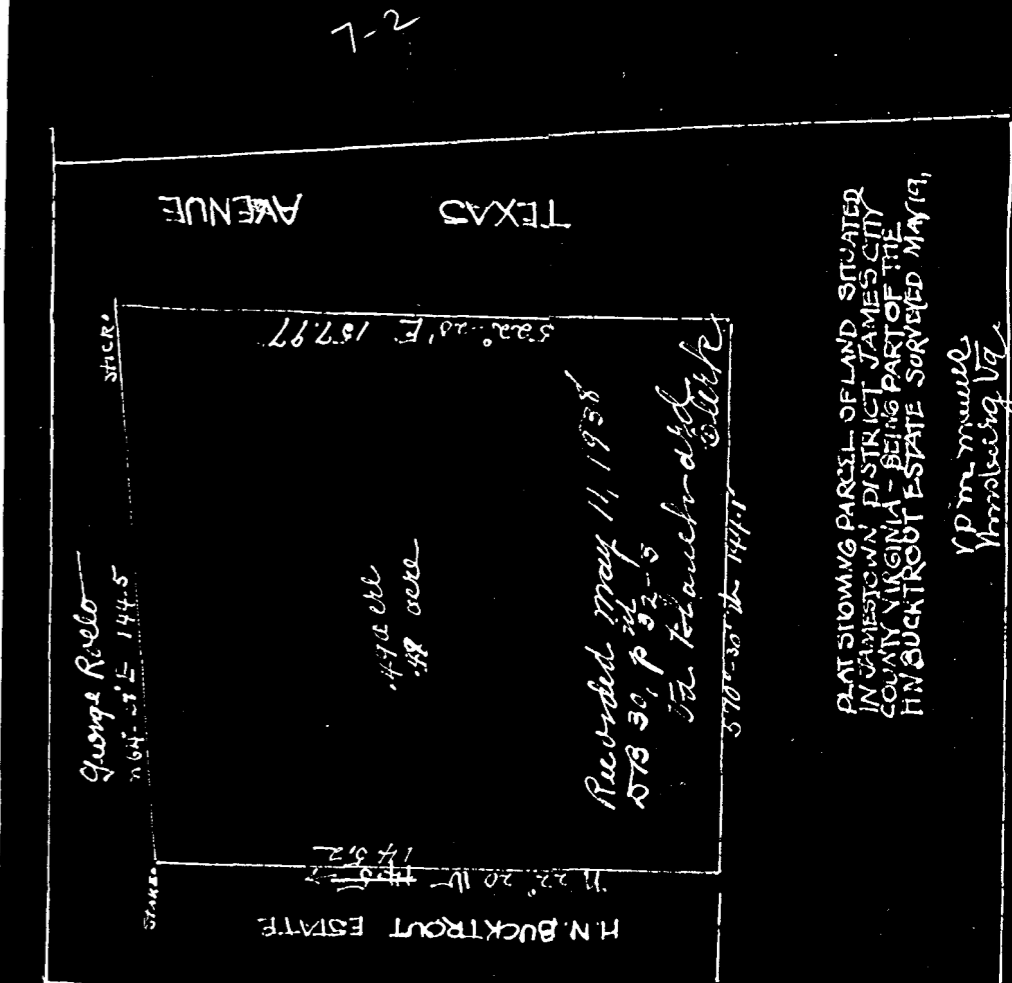
PLAT SHOWING PROPERTY TO BE CONVEYED
