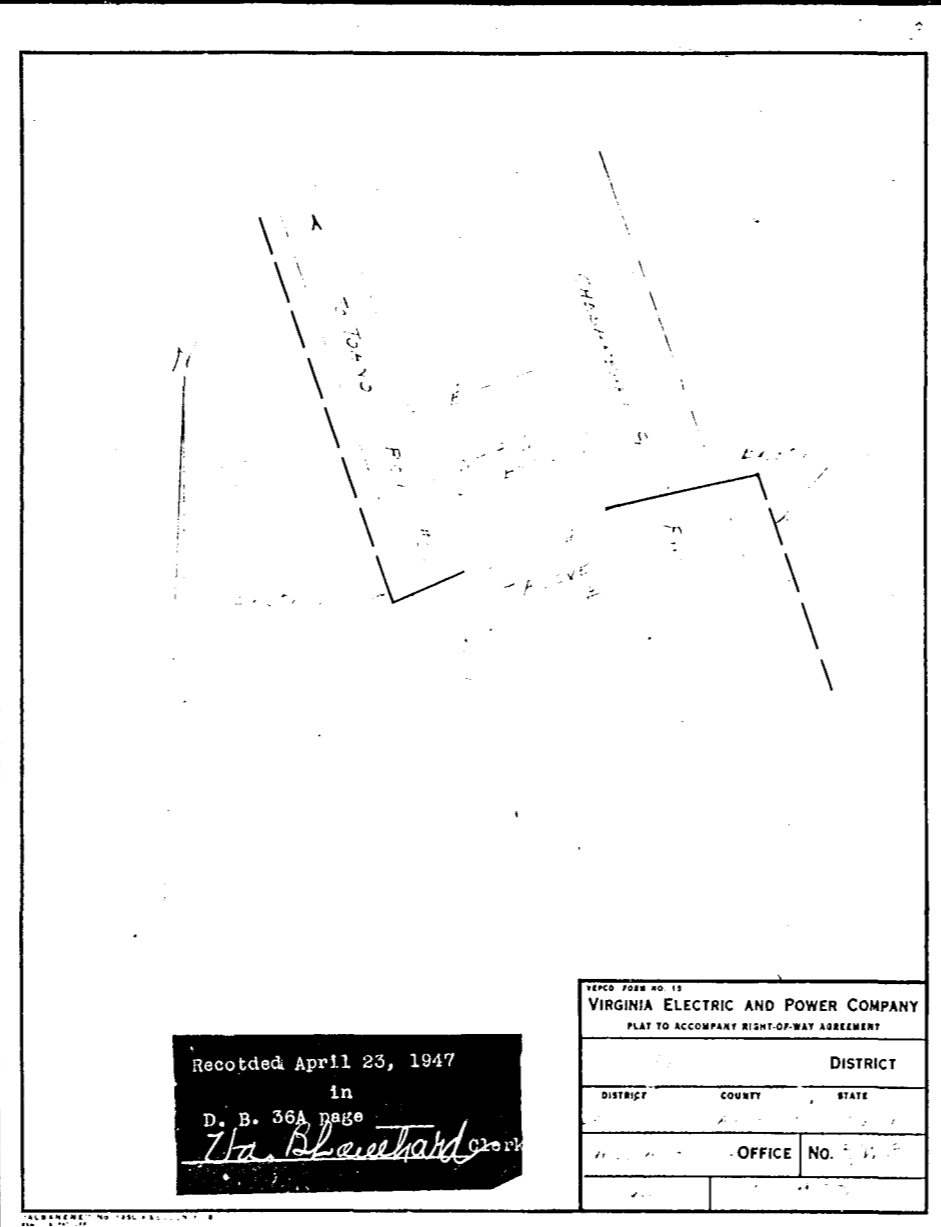


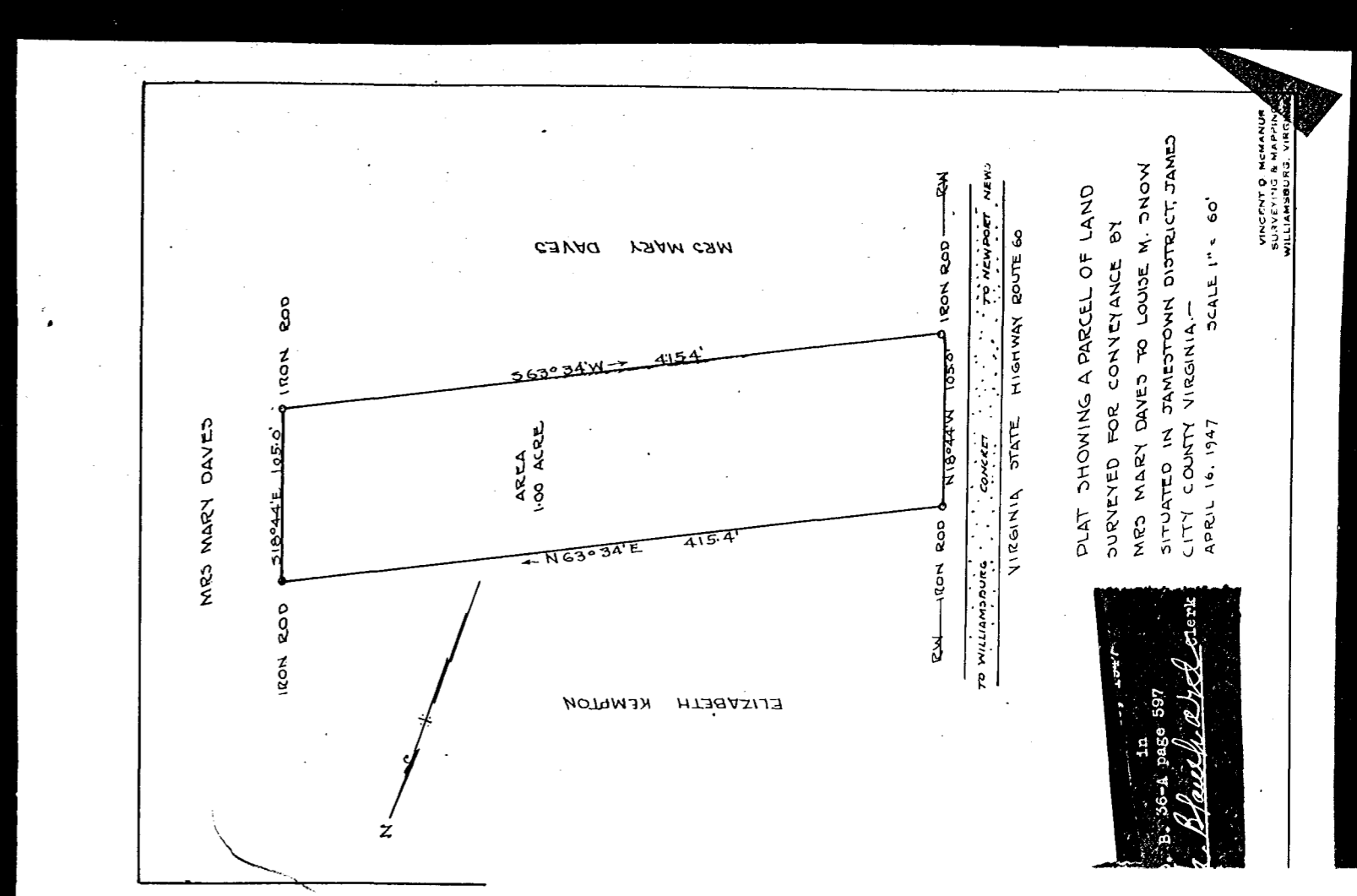

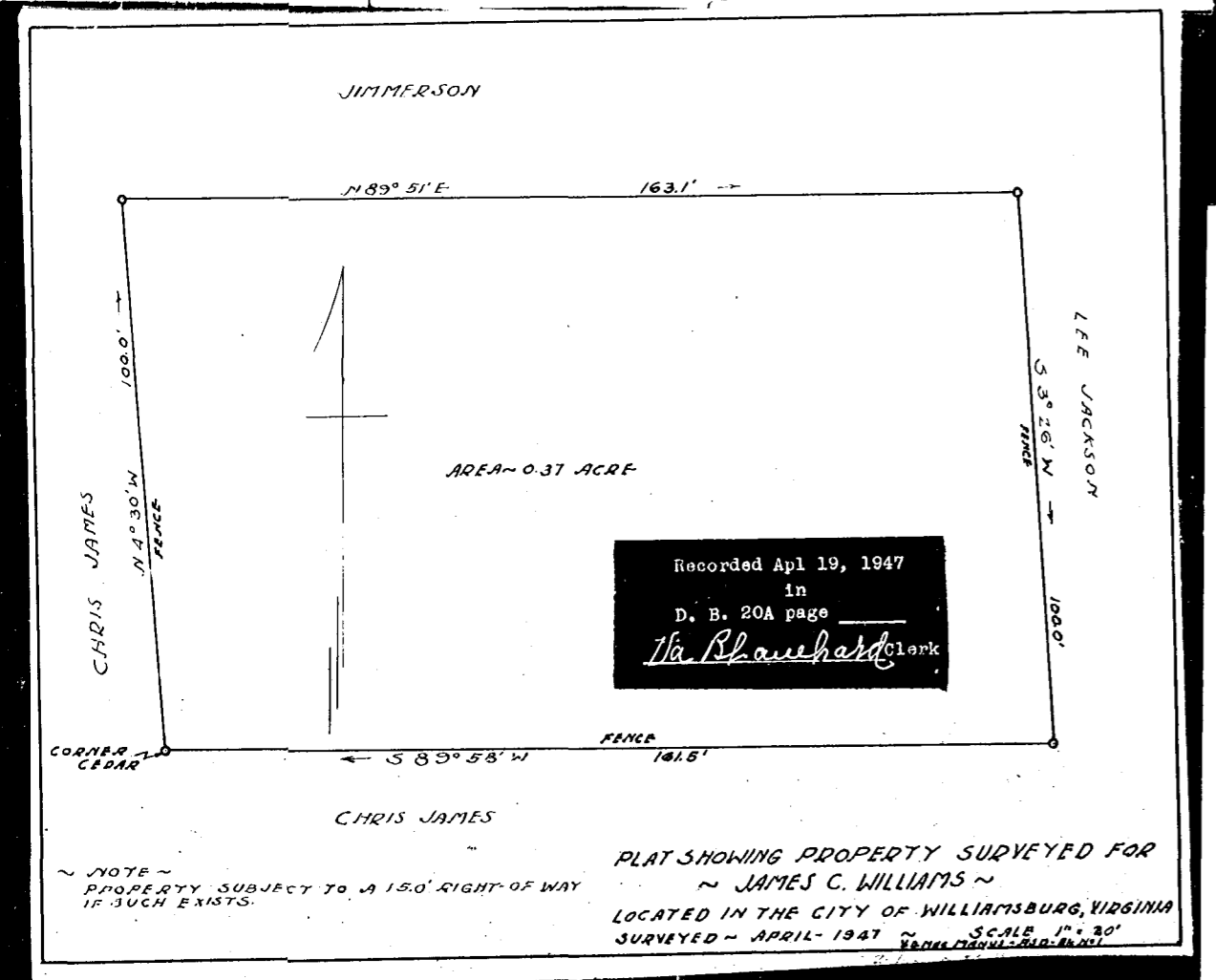

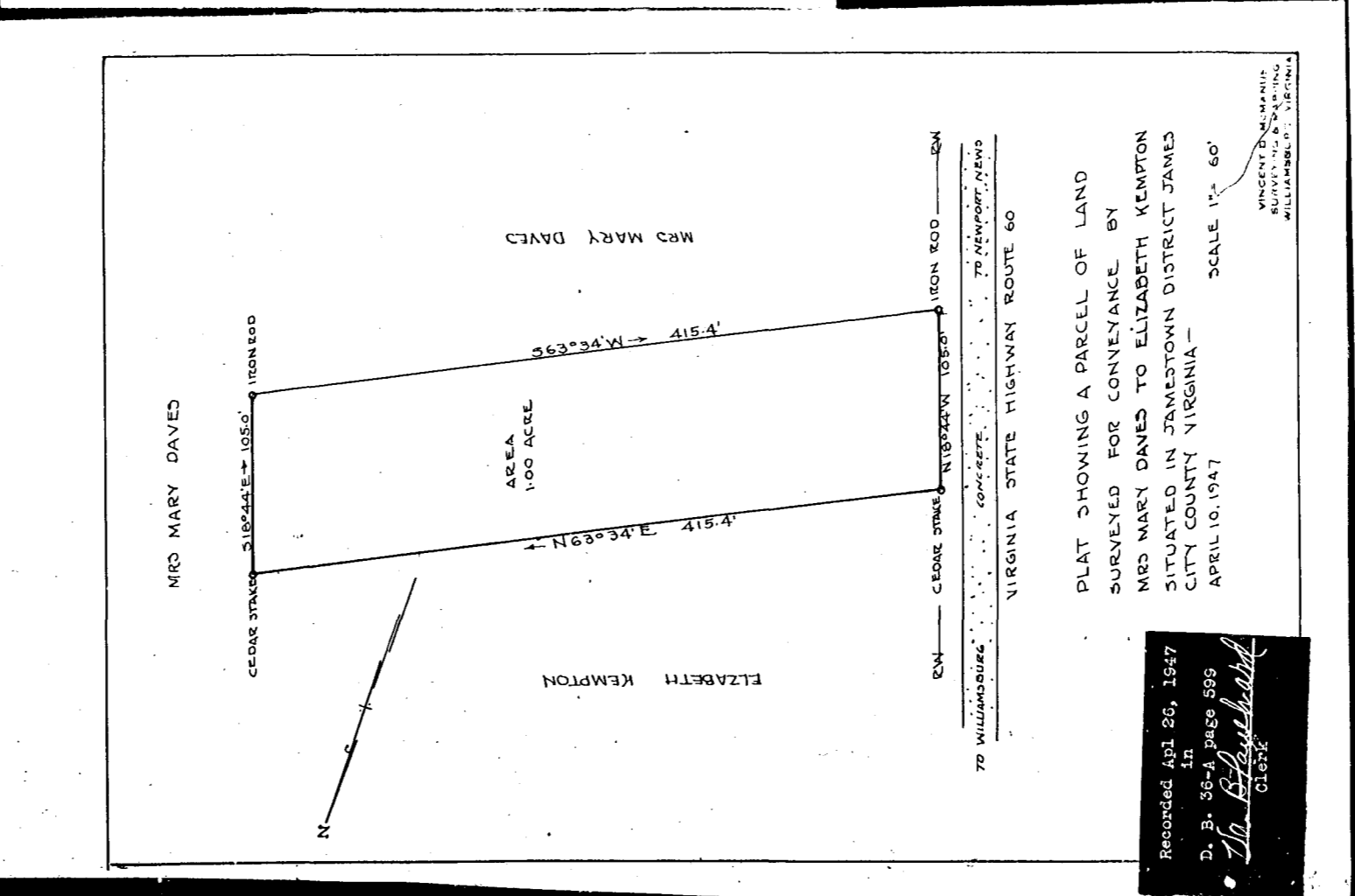

 SURVEYED - APRIL - 1947 SCALE 1"=30'

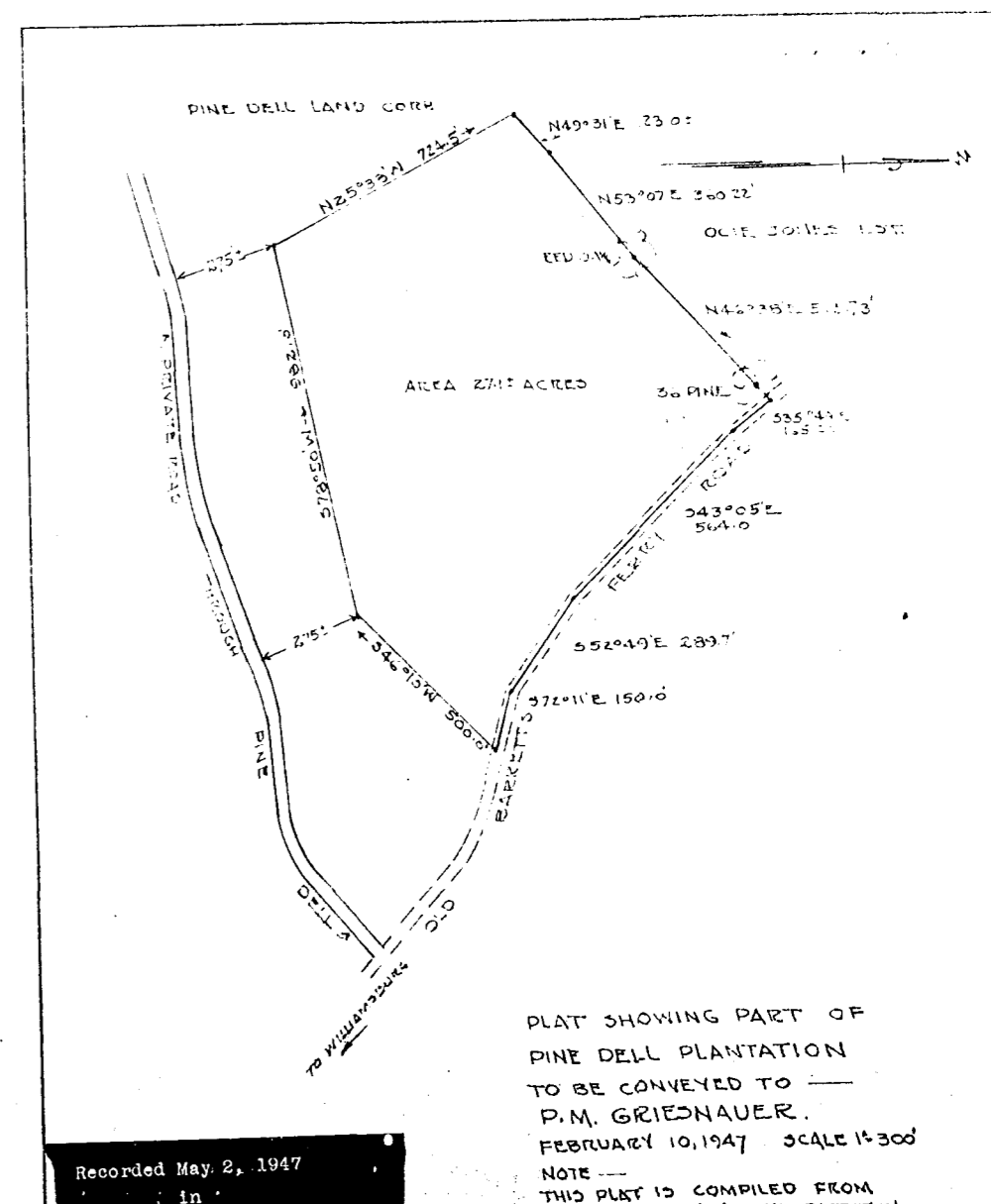
