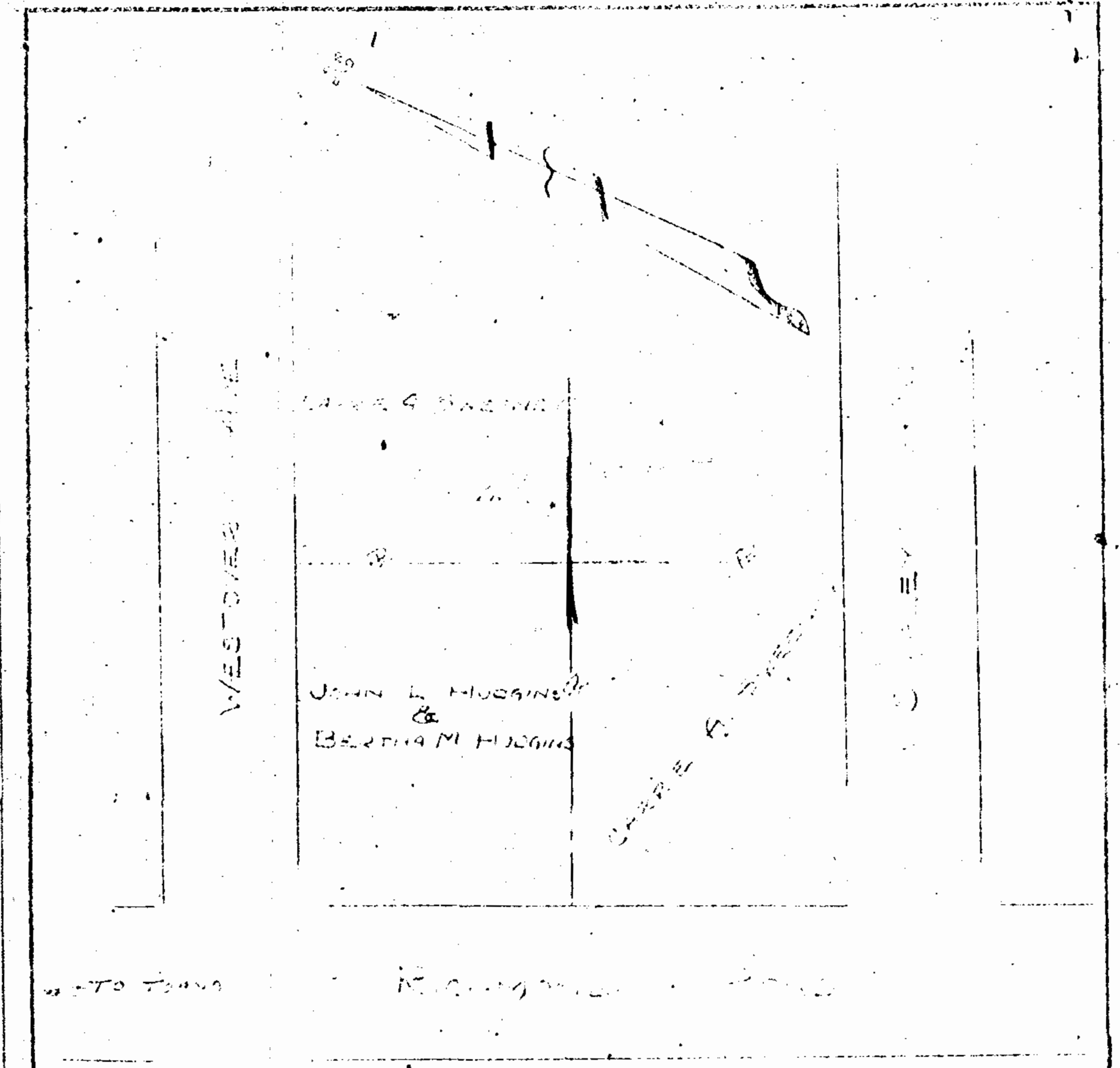


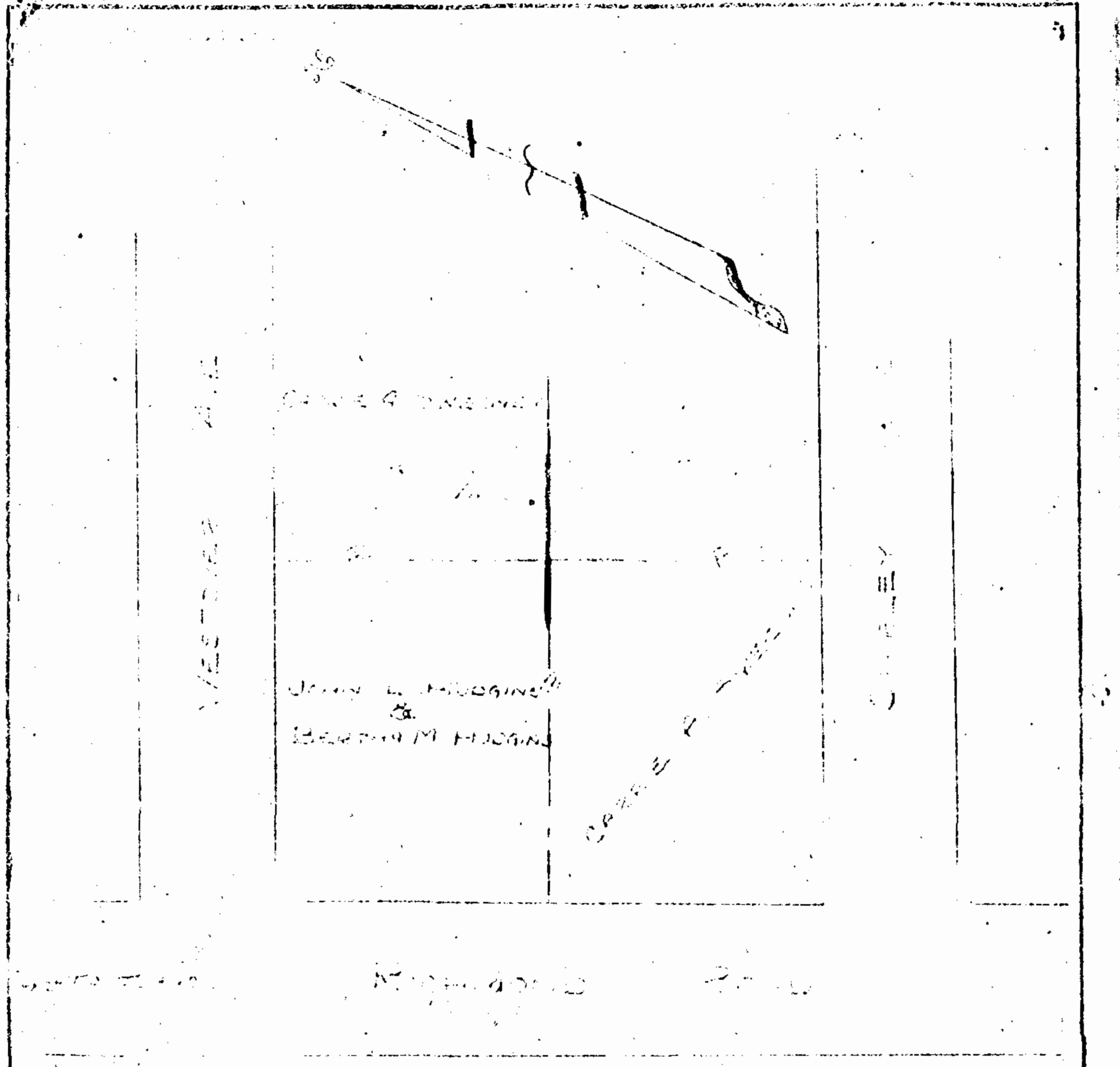
Plat showing parcel of property subdivided for B & E Gaddy, located in James City Co, Va. Surveyed April, 1947 Scale 1" = 20'
