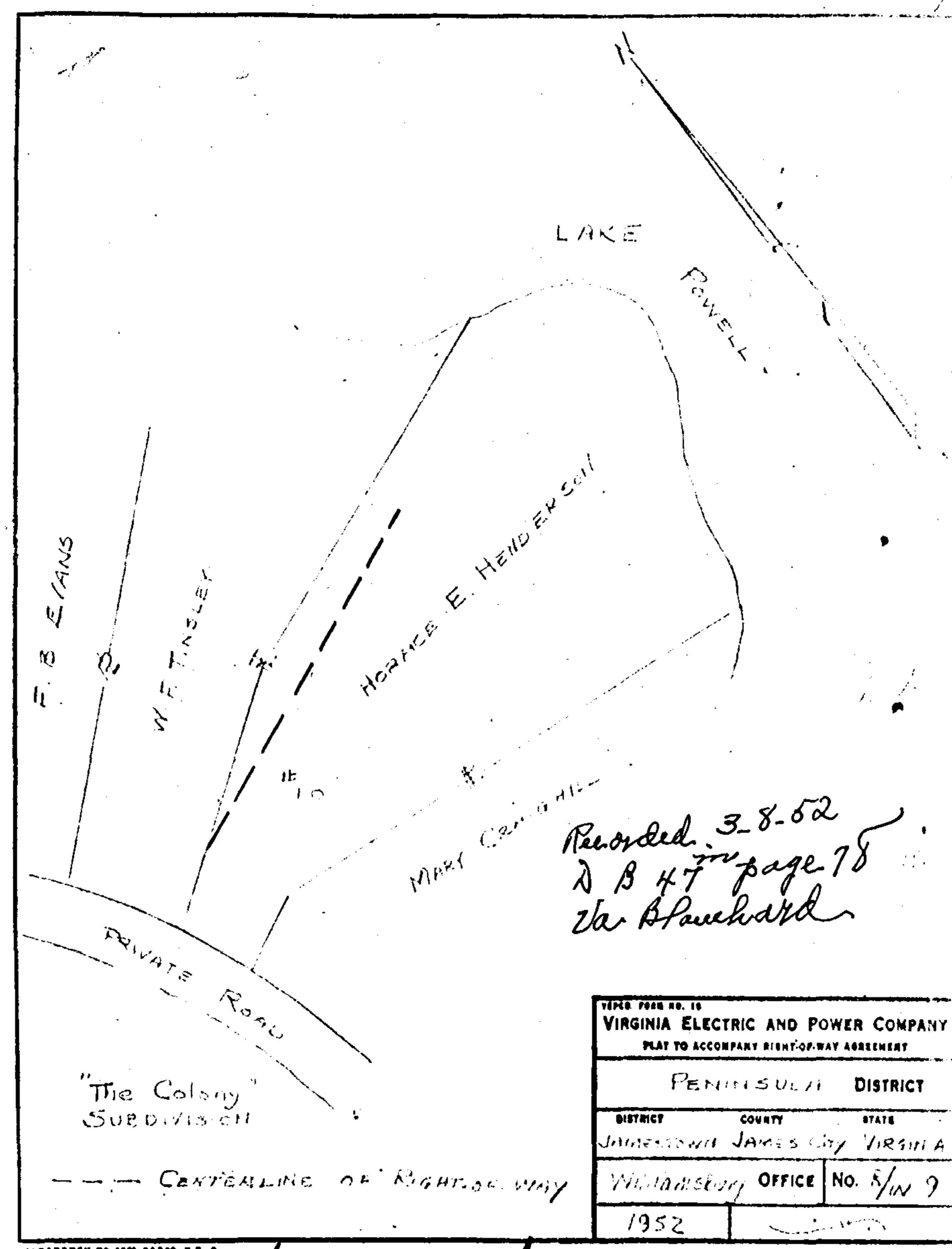


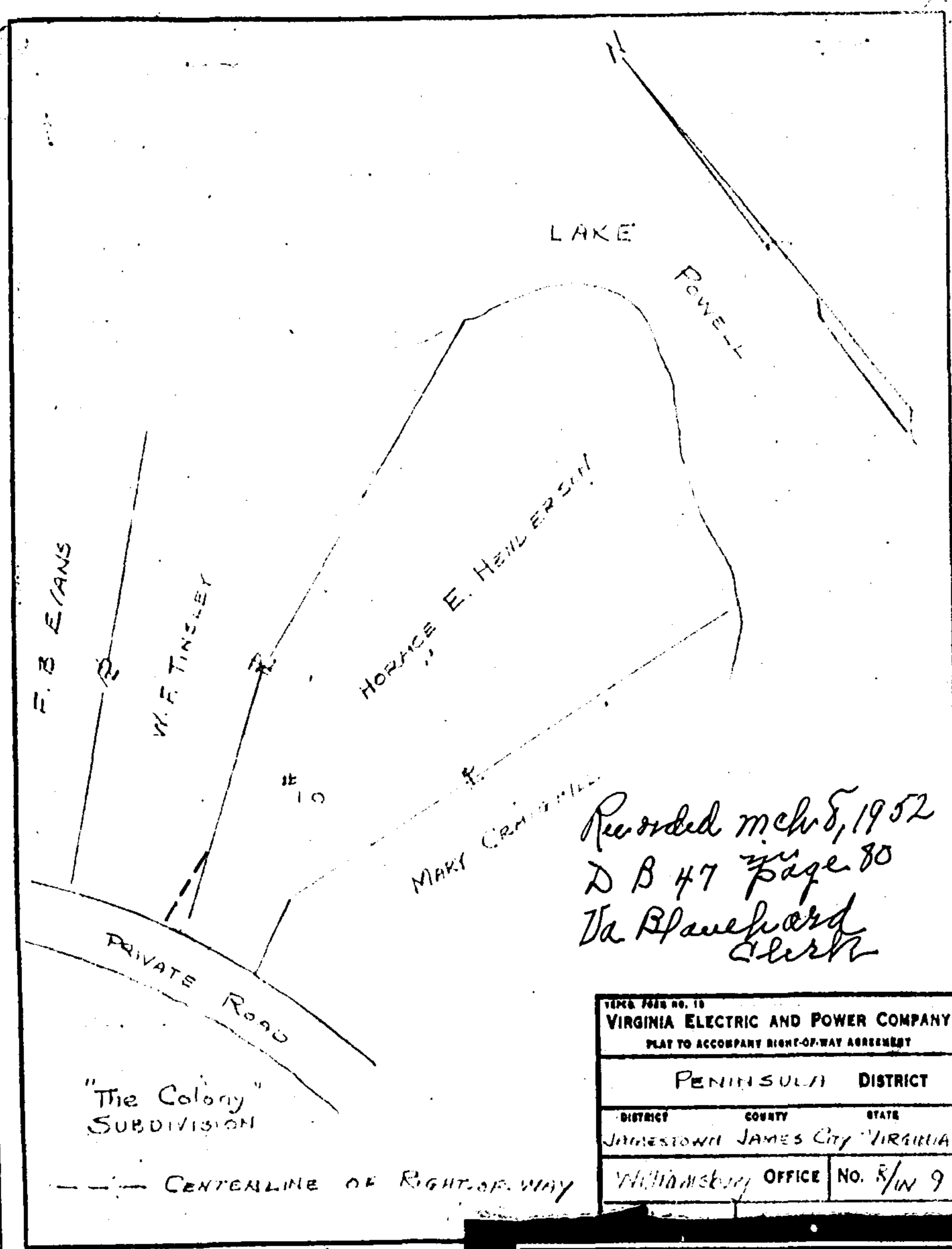

 JANUARY 1950 SCALE 1" = 50'



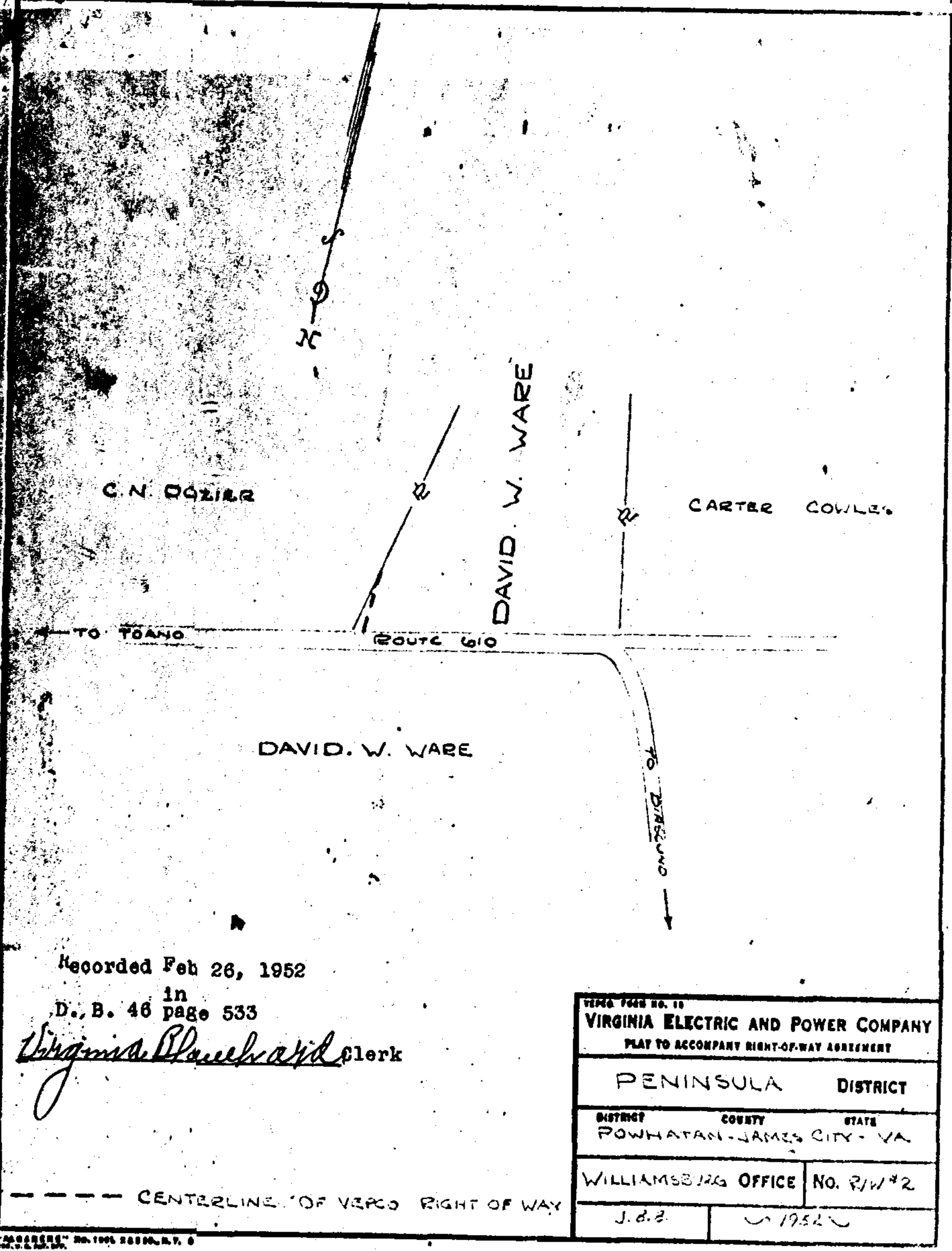

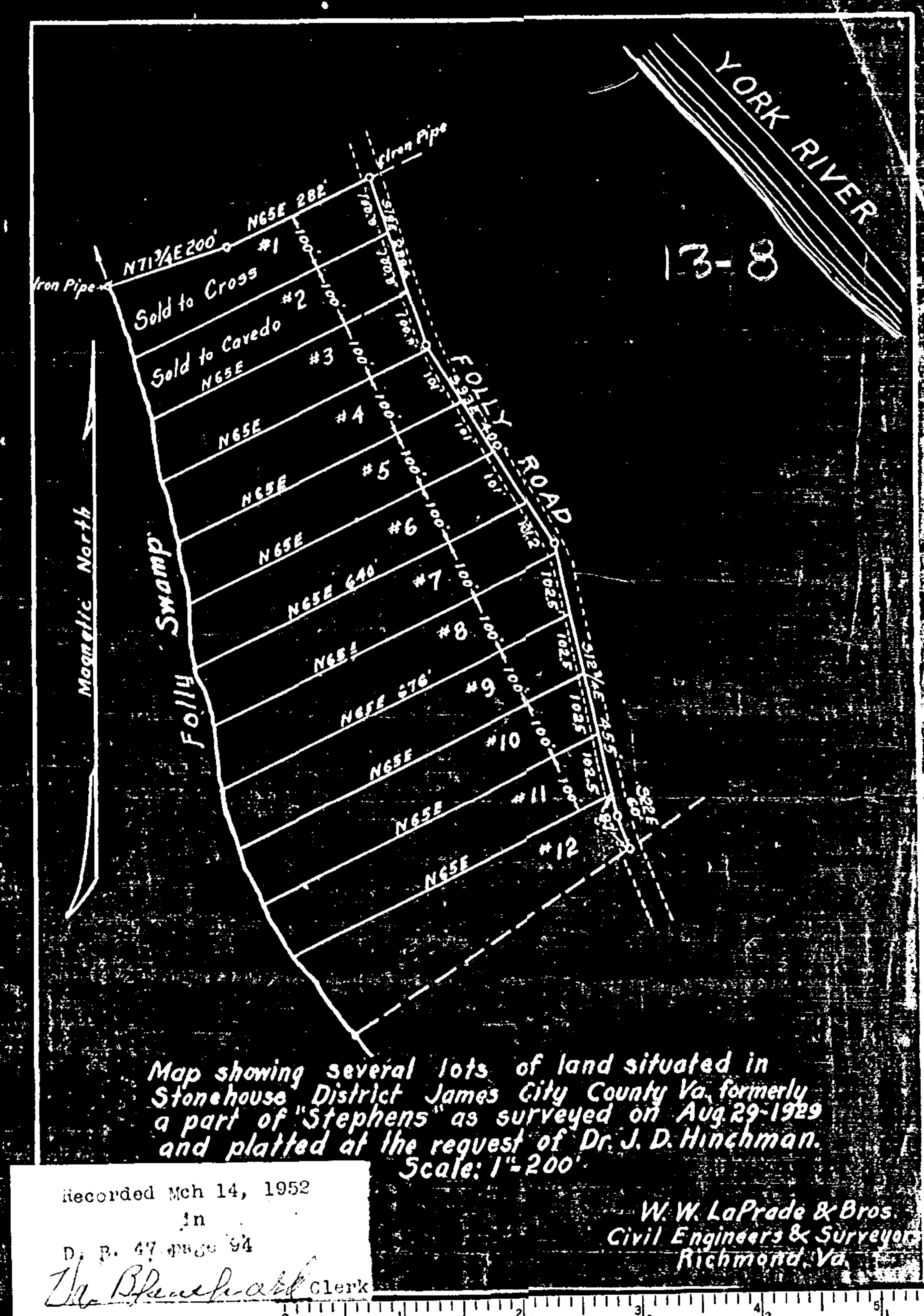
