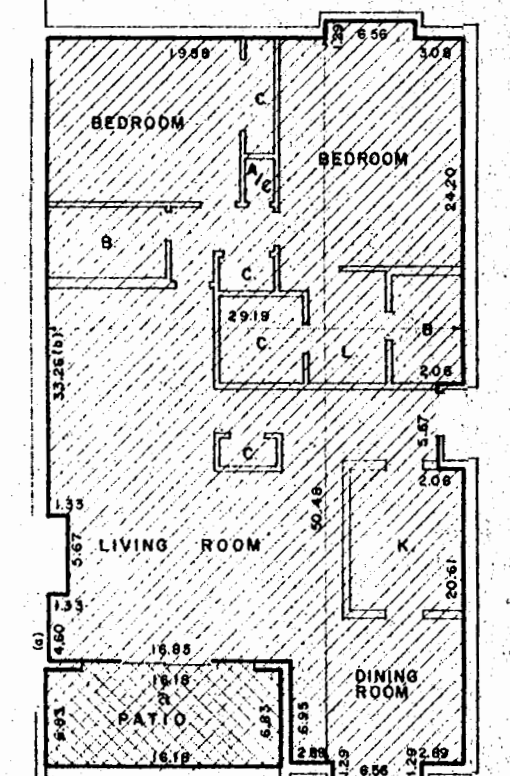
TYPICAL PLAN - TYPE AS

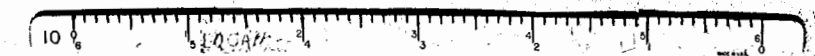
