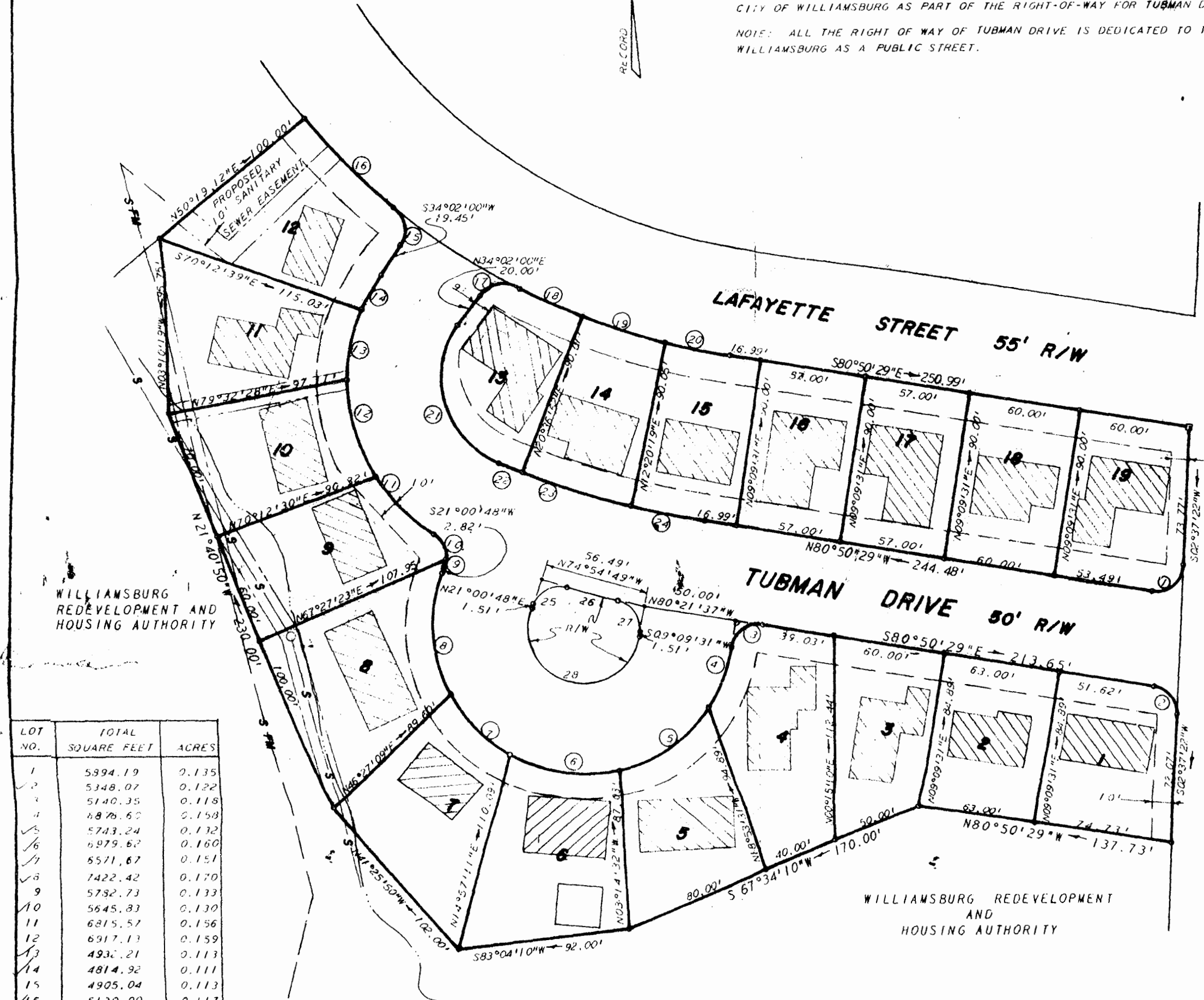
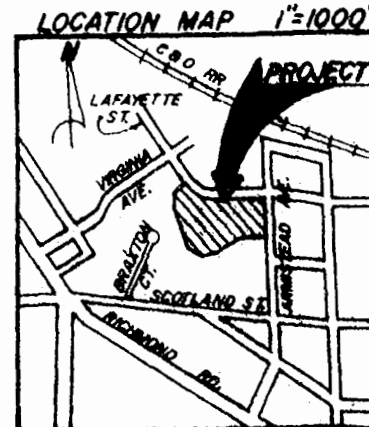
CRISPUS ATTUCKS PLACE
