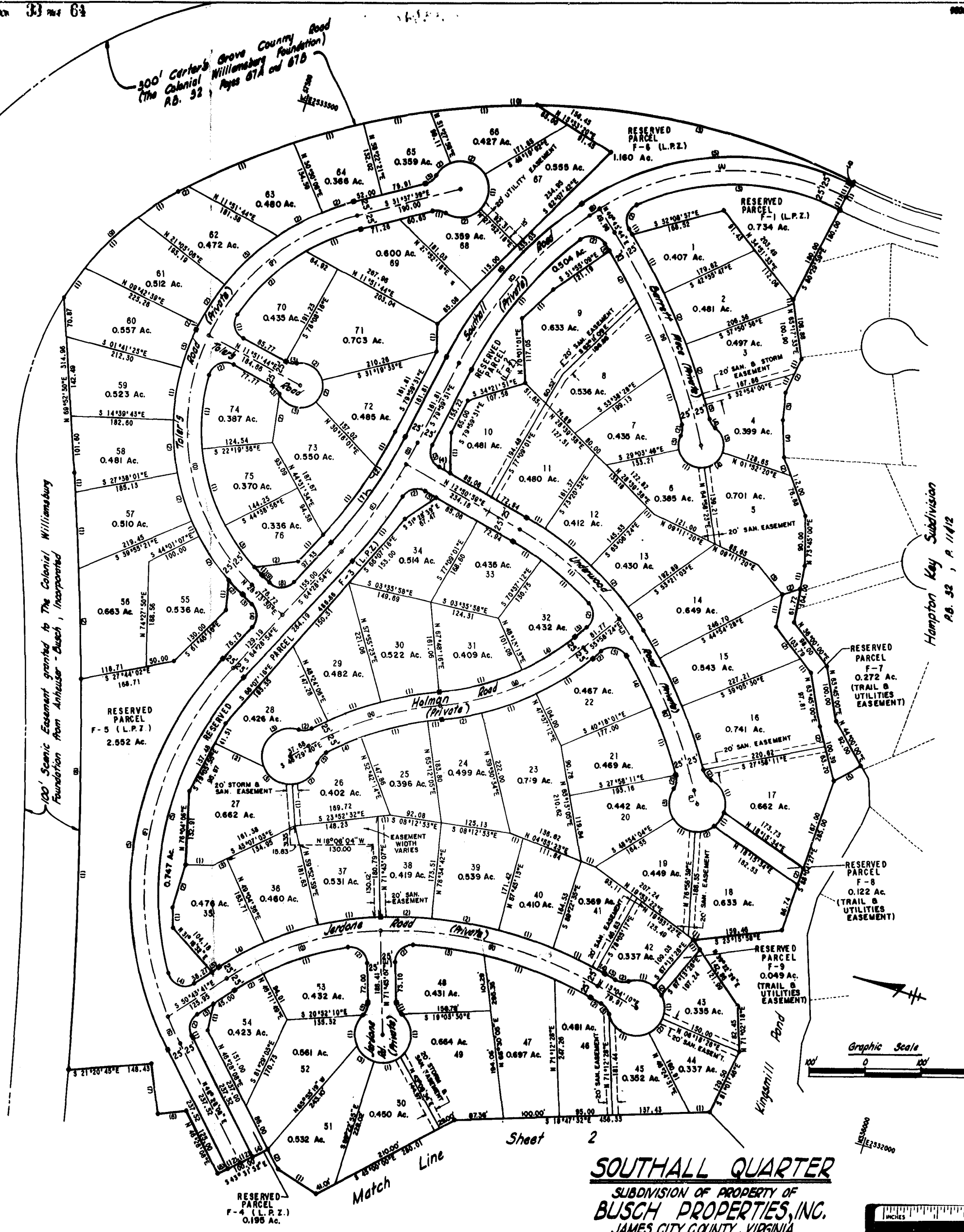

LANDSCAPE PROTECTION ZONE (L.P.Z.)

In areas designated Landscape Protection Zone (L.P.Z.) no trees may be cut without prior approval of the Environmental Preservation Board (E.P.B.), or a committee designated thereby and no permanent structures may be created whether on private property and Common Areas, without prior approval of the E.P.B. provided that in the case of private property and Common Areas the following shall not be deemed to be structures: (a) bicycle, equestrian and pedestrian paths or trails, or related facilities such as retaining walls, rain shelters, benches, signs, light fixtures, bridges and stairs, and (b) boat ramps and docks, and provided further that in the case of private property only, the following shall not be deemed to be structures: (a) cantilevered portions of buildings, (b) columns or post supports of decks, and (c) terraces and patios. It should be noted that the Conditions, Covenants and Restrictions contain additional restrictions on property improvements.

Notes:
1. All subdivision roads and Reserved Parcels are part of Common Areas, owned and reserved by Busch Properties, Incorporated, and will contain easements for James City Service Authority, City of Newport News, Chesapeake and Potomac Telephone Co. and Virginia Electric and Power Co.
2. A 7 1/2 foot drainage easement is hereby reserved by Busch Properties, Incorporated on each side of each lot line.



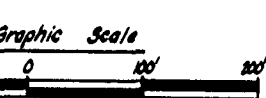
