SCALE: 1" = 3,500'

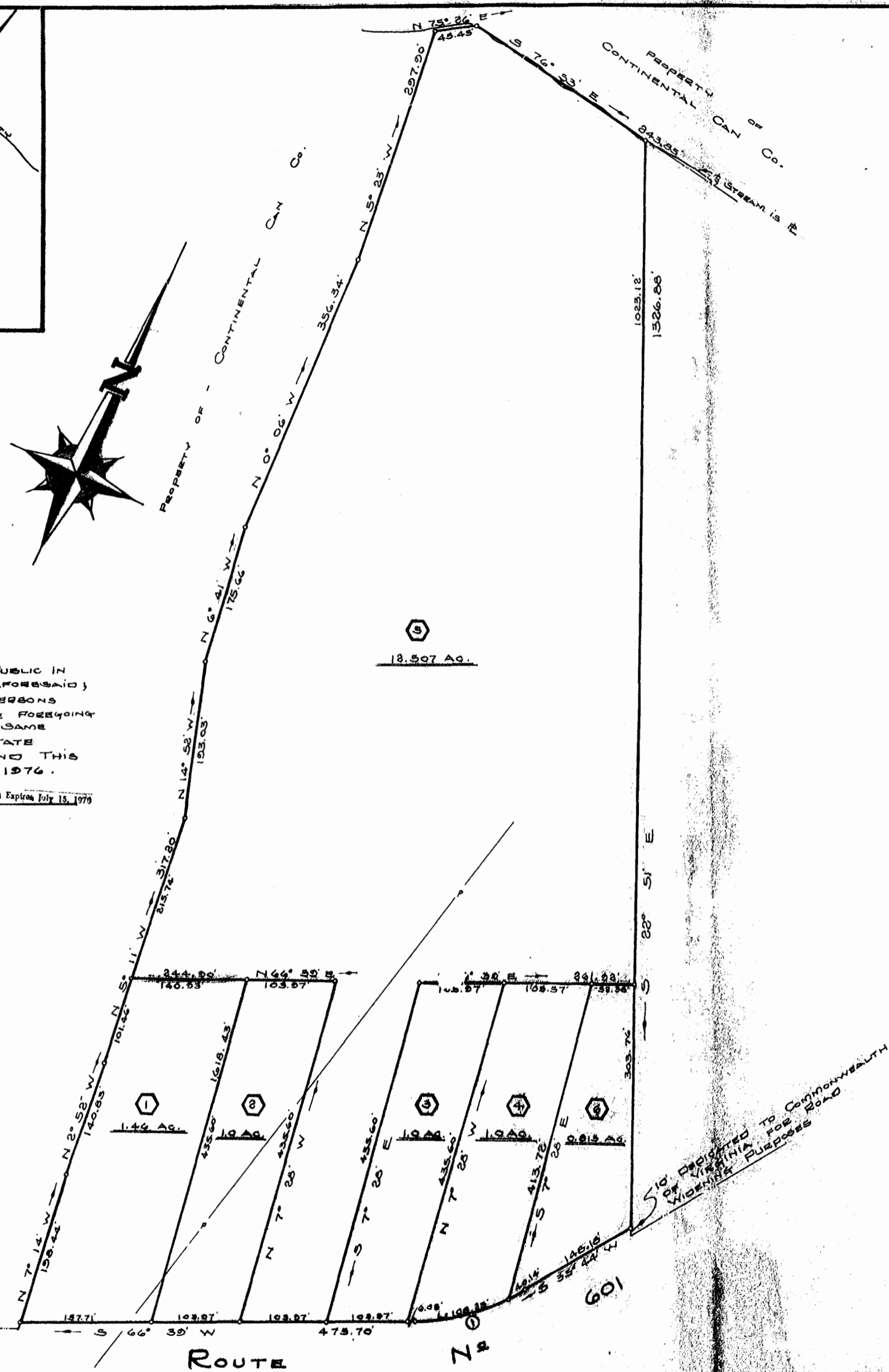
