



DESCRIPTION OF A PORTION OF THE LAND OF WILLIAMSBURG COMMUNITY HOSPITAL, INC. WILLIAMSBURG, VIRGINIA.

THAT CERTAIN LOT, PIECE OR PARCEL OF LAND SITUATED IN THE CITY OF WILLIAMSBURG, VIRGINIA, AND BOUNDED AND DESCRIBED AS FOLLOWS: BEGINNING AT AN IRON PIN ON THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE LOCATED 31.79 FEET IN A DIRECTION SOUTH 31°53'30" EAST FROM THE POINT OF CURVATURE AT THE INTERSECTION OF THE SOUTHERLY RIGHT-OF-WAY LINE OF MONTICELLO AVENUE, AND THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE, AS DEDICATED OF RECORD IN THE CITY OF WILLIAMSBURG, VIRGINIA, THENCE RUNNING FROM SAID POINT OF BEGINNING ALONG THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE SOUTH 31°53'30" EAST 82.40 FEET TO AN IRON PIN; THENCE CONTINUING ALONG THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE ON A CURVE TO THE LEFT HAVING A RADIUS OF 527.50 FEET AND A CHORD BEARING SOUTH 36°08'00" EAST THE ARC DISTANCE OF 78.10 FEET; THENCE CONTINUING ALONG THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE SOUTH 40°22'30" EAST 501.64 FEET TO AN IRON PIN; THENCE CONTINUING ALONG THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE ON A CURVE TO THE LEFT HAVING A RADIUS OF 377.50 FEET AND A CHORD BEARING SOUTH 44°42'17" EAST THE ARC DISTANCE OF 57.05 FEET TO AN IRON PIN; THENCE DIVERGING FROM MOUNT VERNON DRIVE AND RUNNING SOUTH 49°37'30" WEST 25.00 FEET TO AN IRON PIN; THENCE SOUTH 35°52'30" EAST 218.00 FEET TO AN IRON PIN; THENCE SOUTH 43°32'39" WEST 276.71 FEET TO AN IRON PIN; THENCE SOUTH 34°33'53" WEST 145.00 FEET TO AN IRON PIN; THENCE NORTH 65°26'07" WEST 498.00 FEET TO AN IRON PIN; THENCE NORTH 40°26'07" WEST 202.00 FEET TO AN IRON PIN; THENCE NORTH 19°33'53" EAST 438.00 FEET TO AN IRON PIN; THENCE NORTH 19°20'17" WEST 81.49 FEET TO AN IRON PIN; THENCE ON A CURVE TO THE RIGHT HAVING A RADIUS OF 163.47 FEET AND A CHORD BEARING OF NORTH 26°07'19" EAST THE ARC DISTANCE OF 122.61 FEET TO AN IRON PIN; THENCE NORTH 47°36'13" EAST 164.00 FEET TO AN IRON PIN ON THE WESTERLY RIGHT-OF-WAY LINE OF MOUNT VERNON DRIVE, THE POINT OF BEGINNING. SAID PROPERTY CONTAINS 11.407 ACRES OR 496,892.24 SQUARE FEET.
