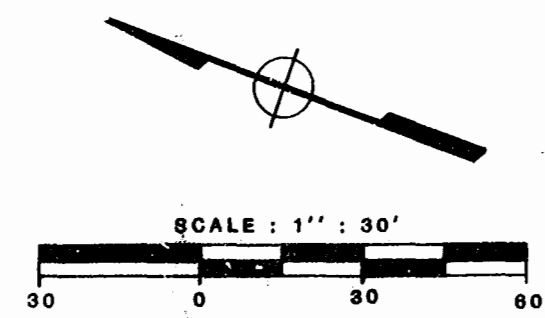


VICINITY MAP

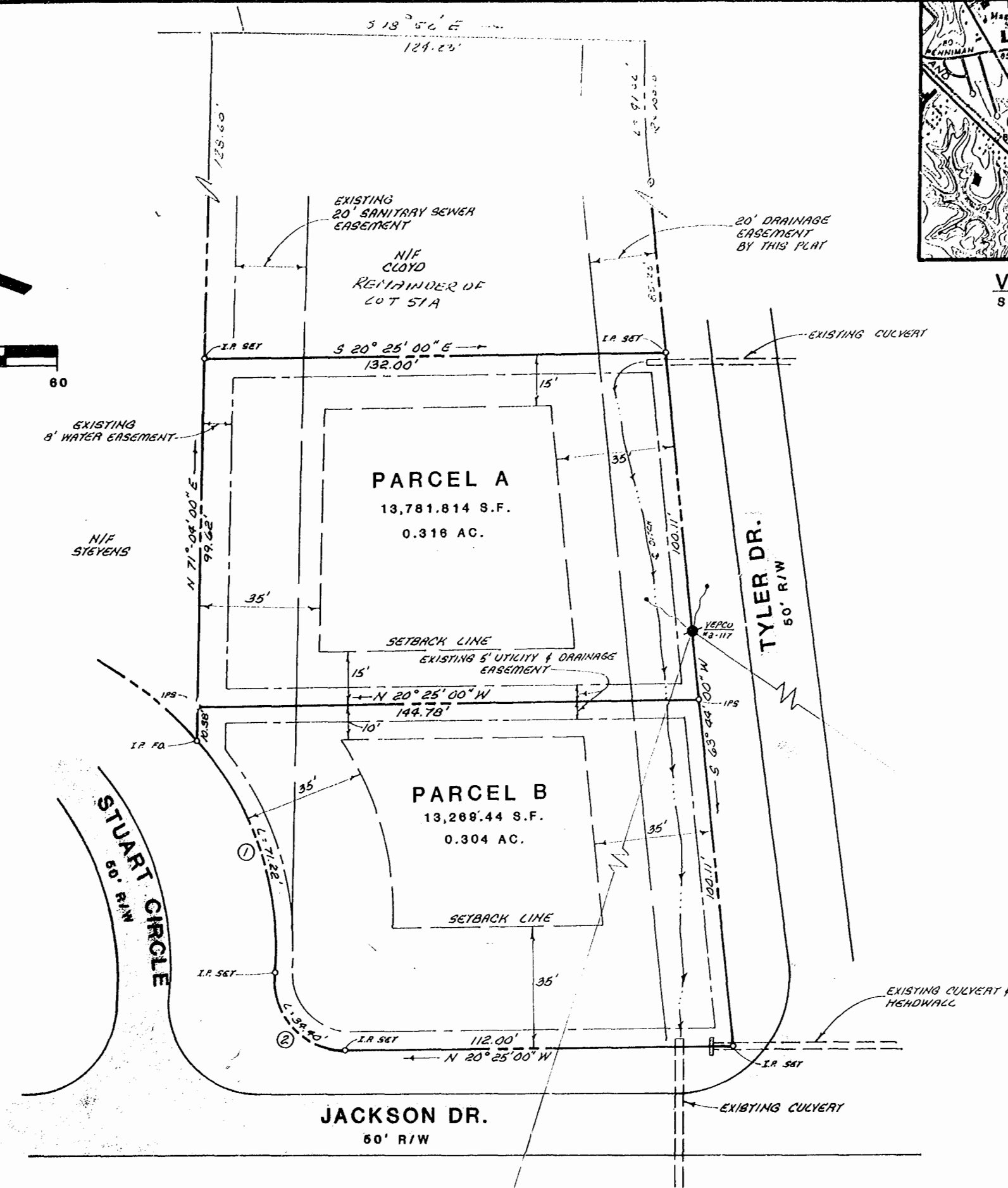

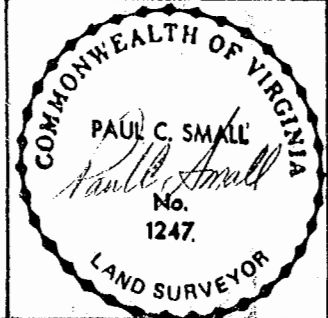
