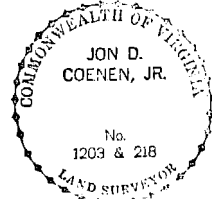


VICINITY MAP

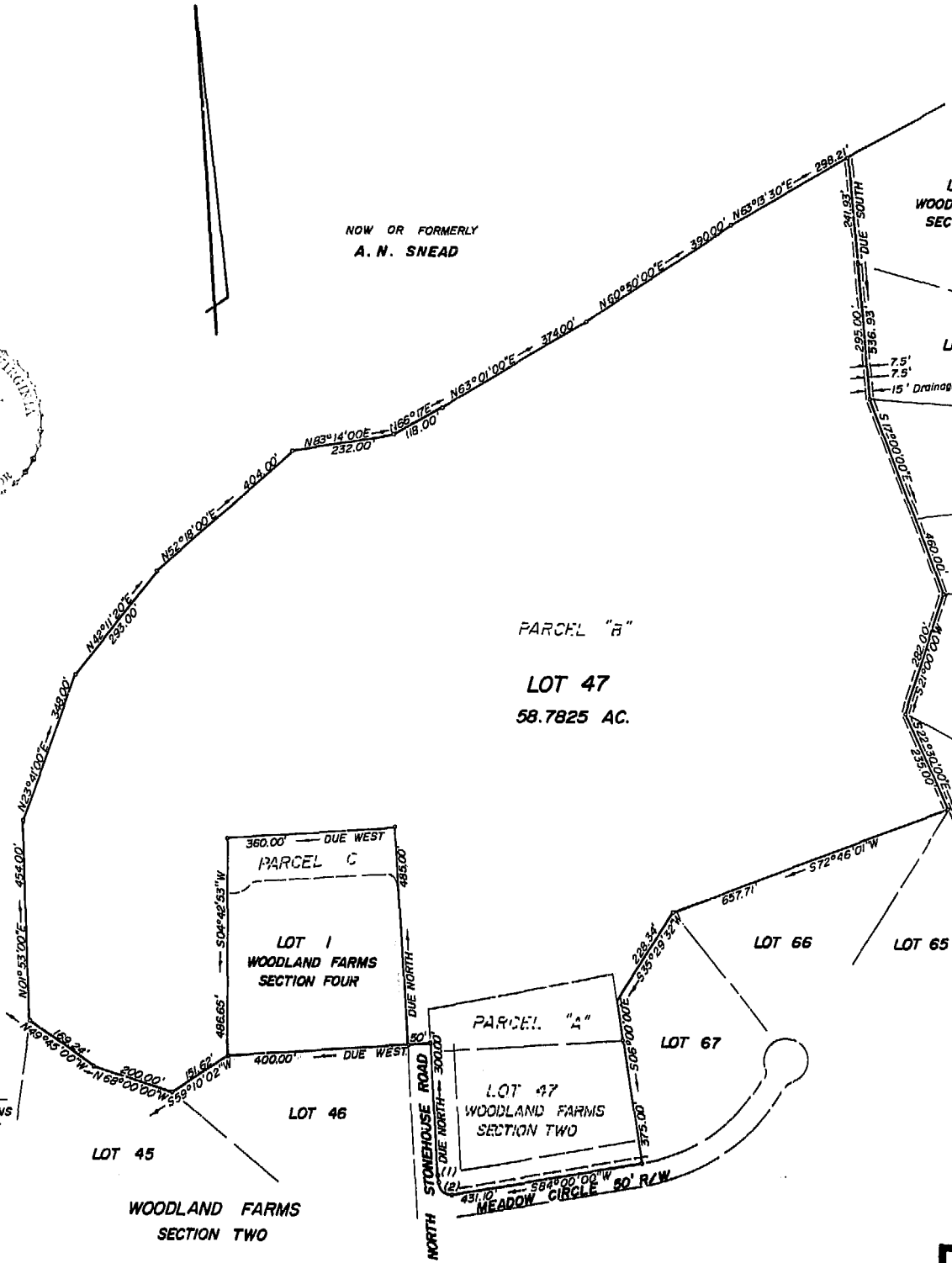

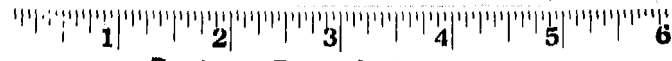
