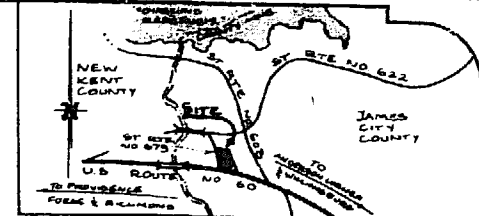

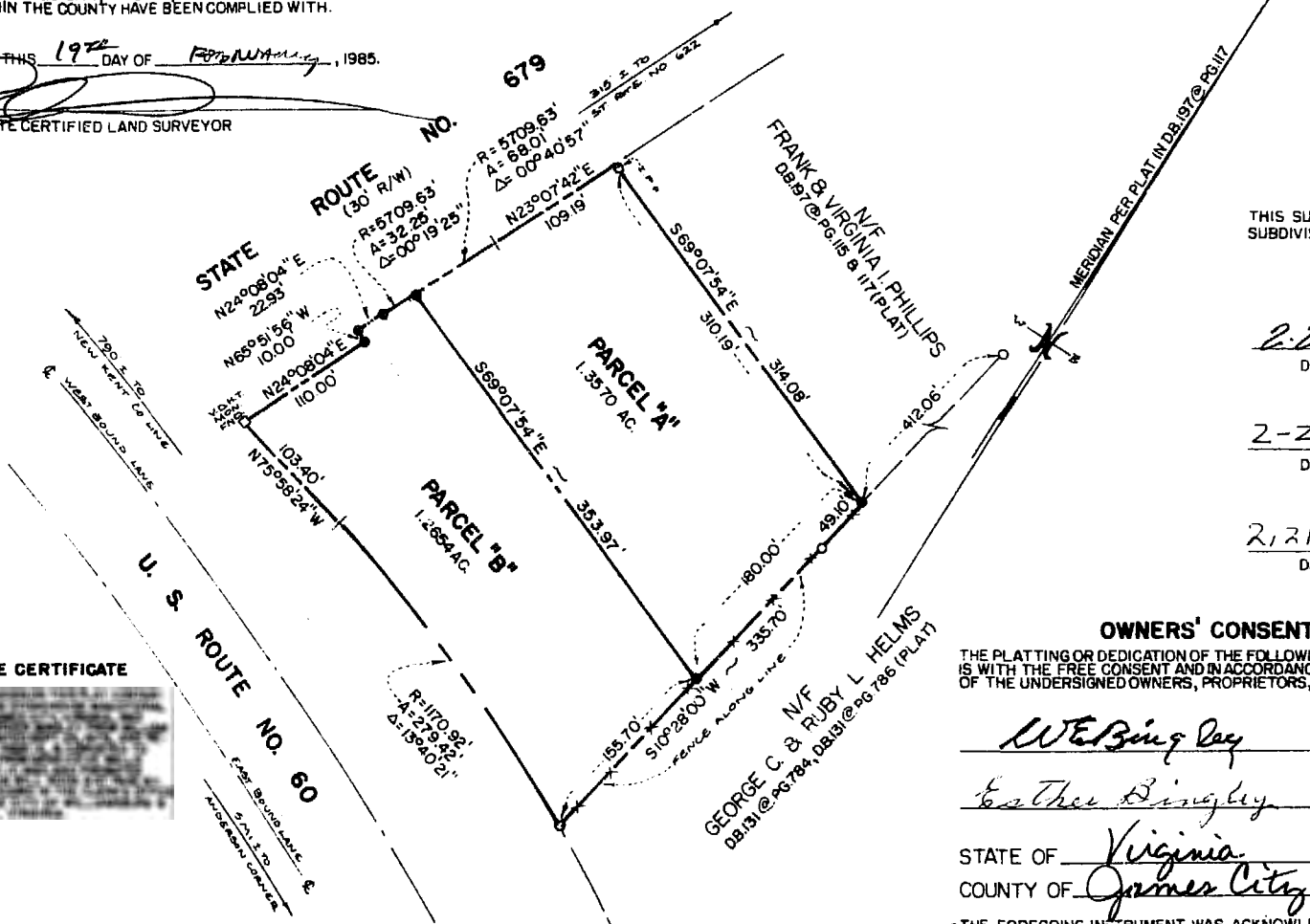

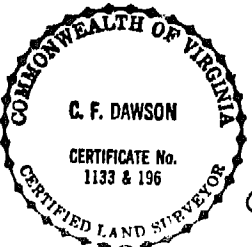
PLAT
