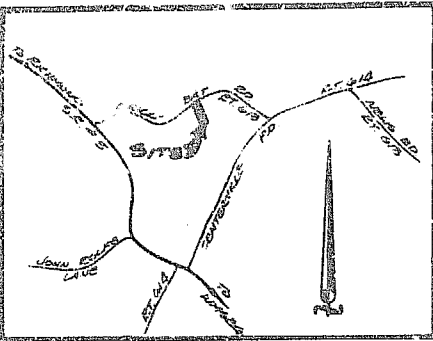


SOURCE OF TITLE:

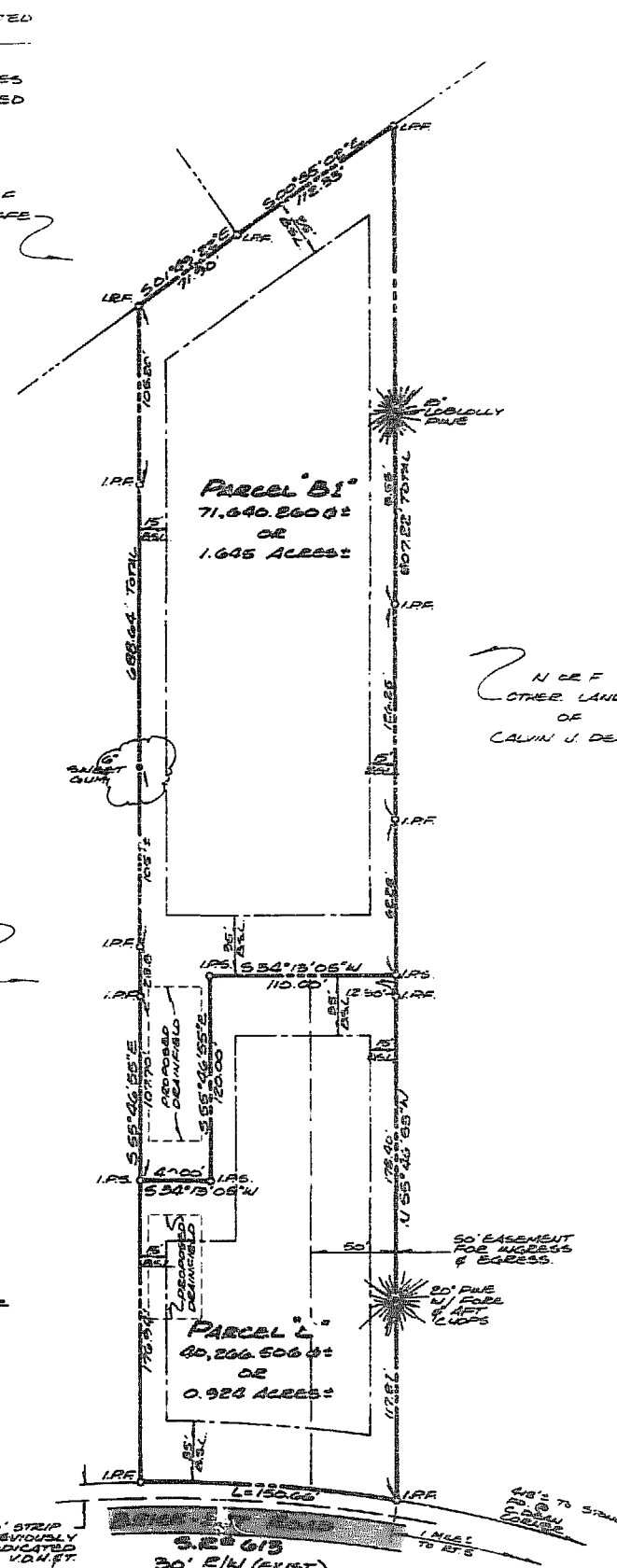
