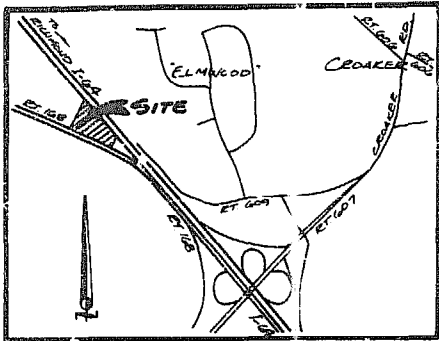


SOURCE OF TITLE:

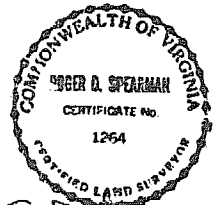

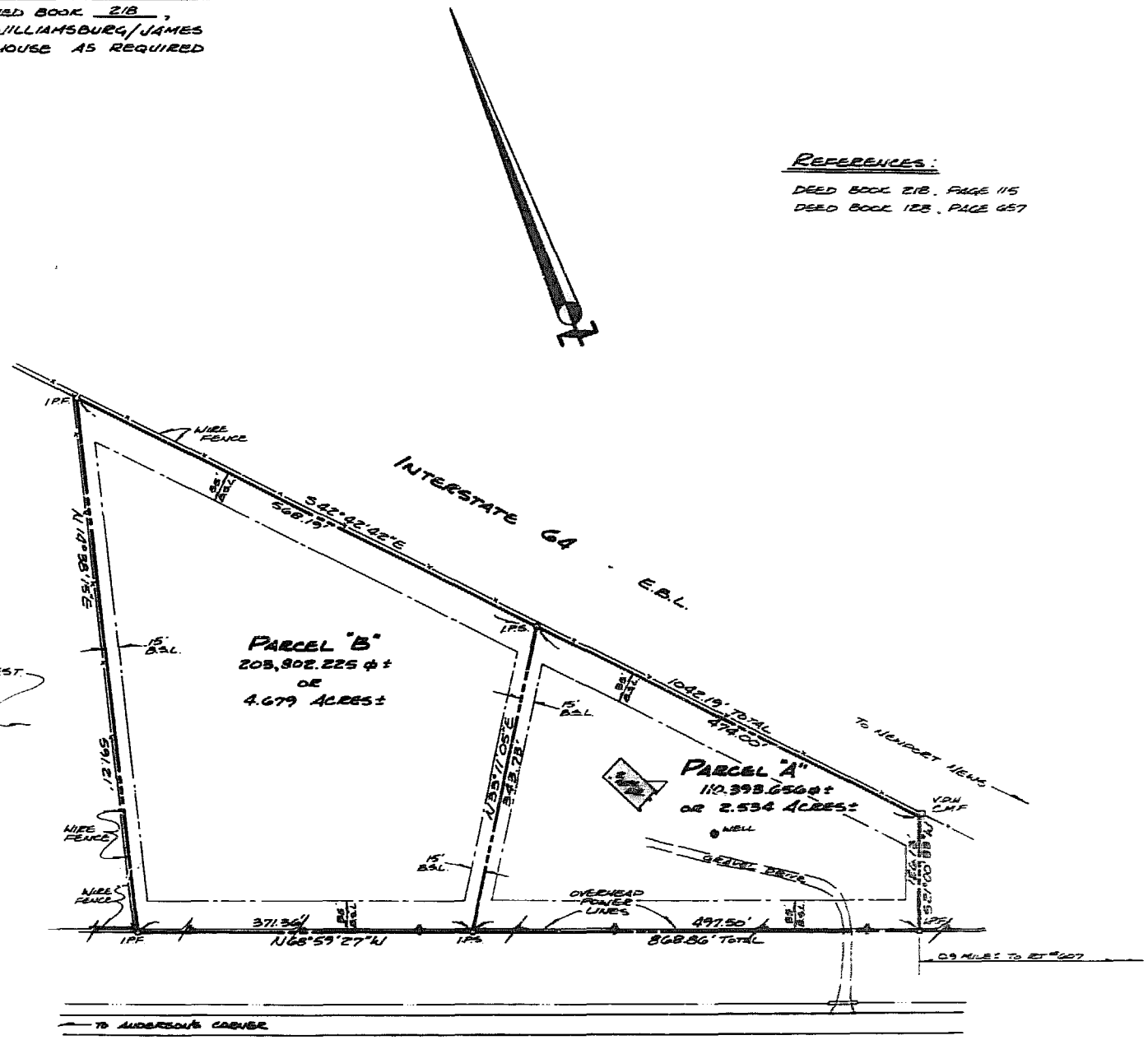
