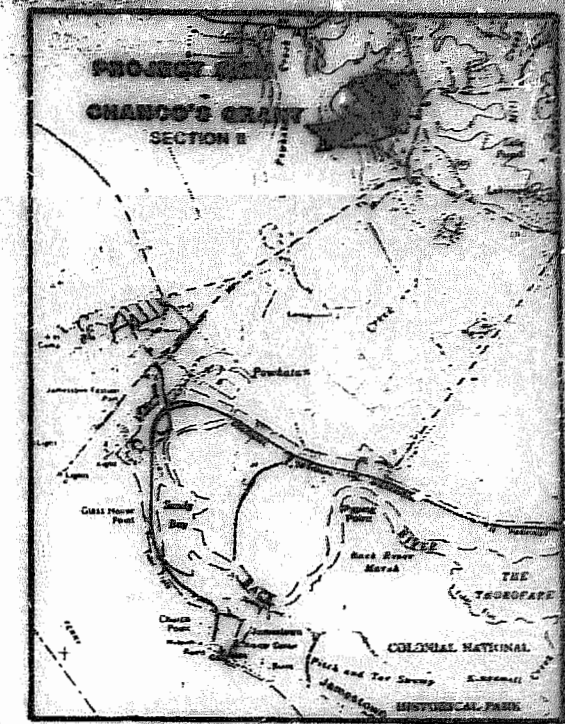

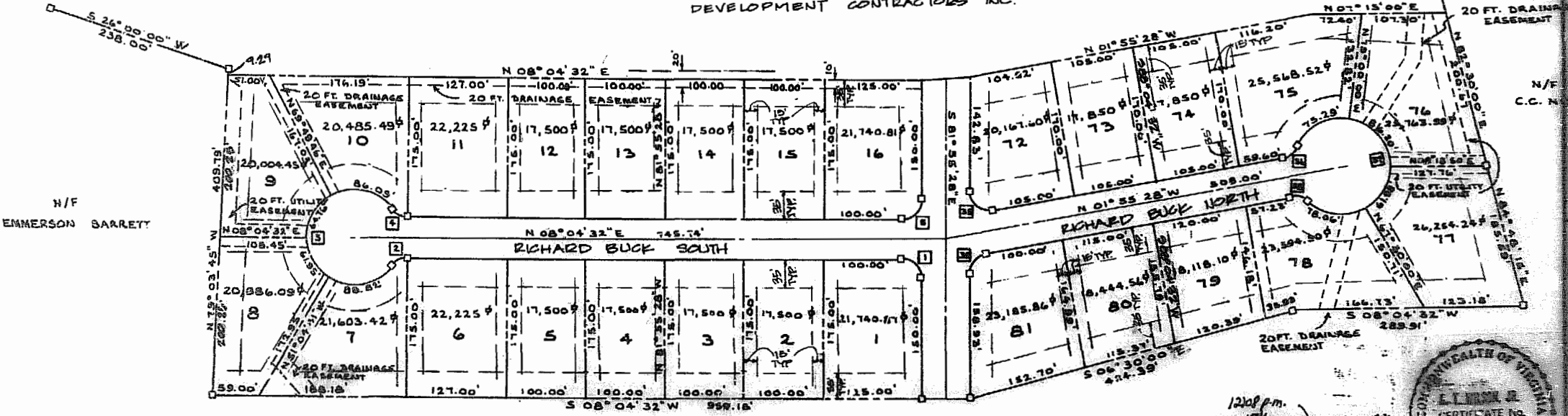


VICINITY MAP 1" = 8000'
