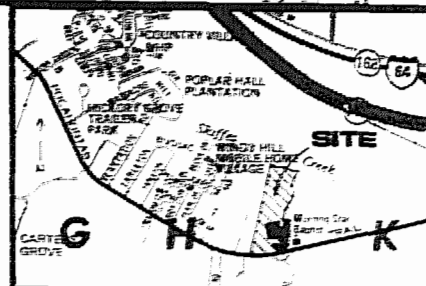

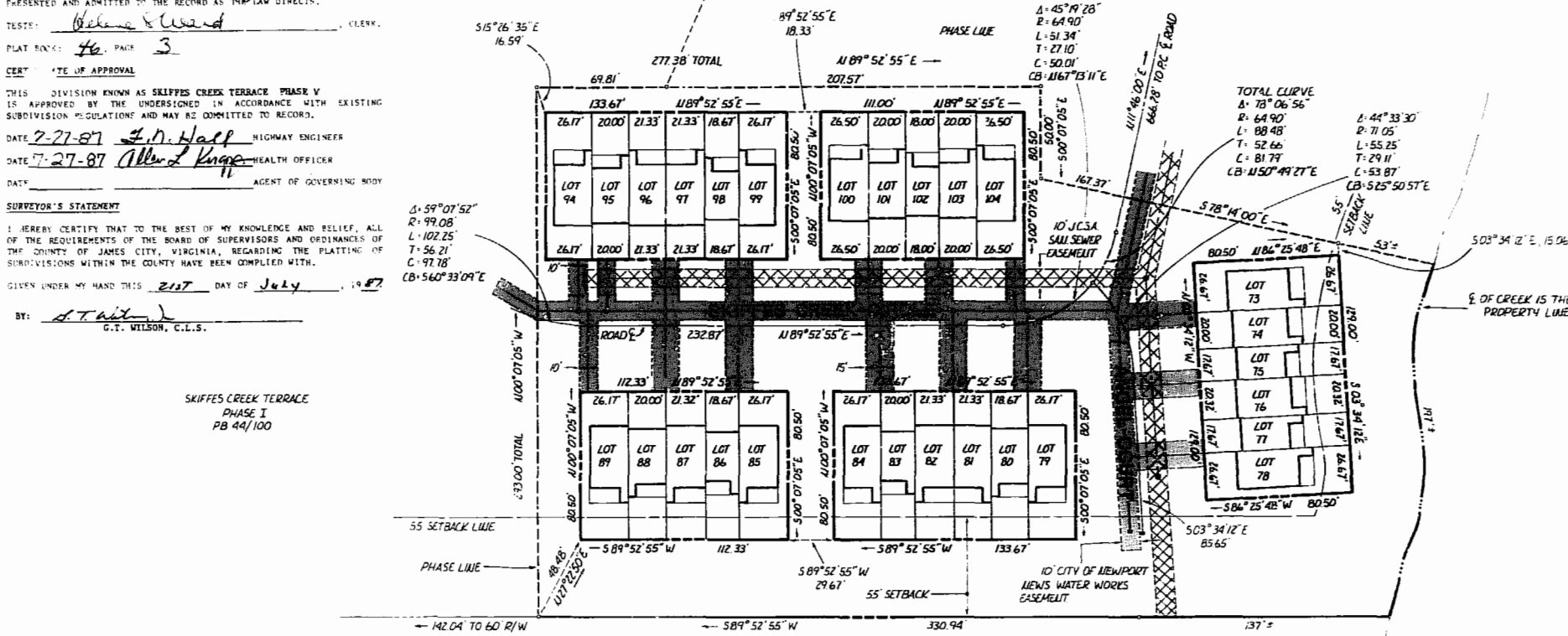

XXXX DENOTES CITY OF NEWPORT NEWS WATER WORKS EASEMENT

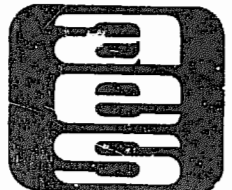

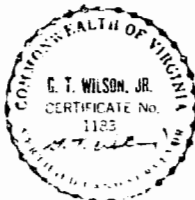
