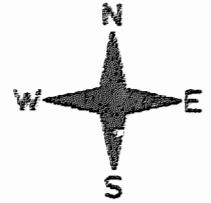
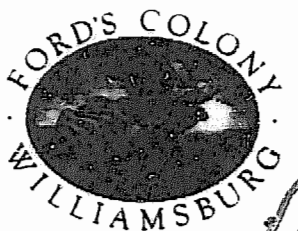


LOCATION MAP

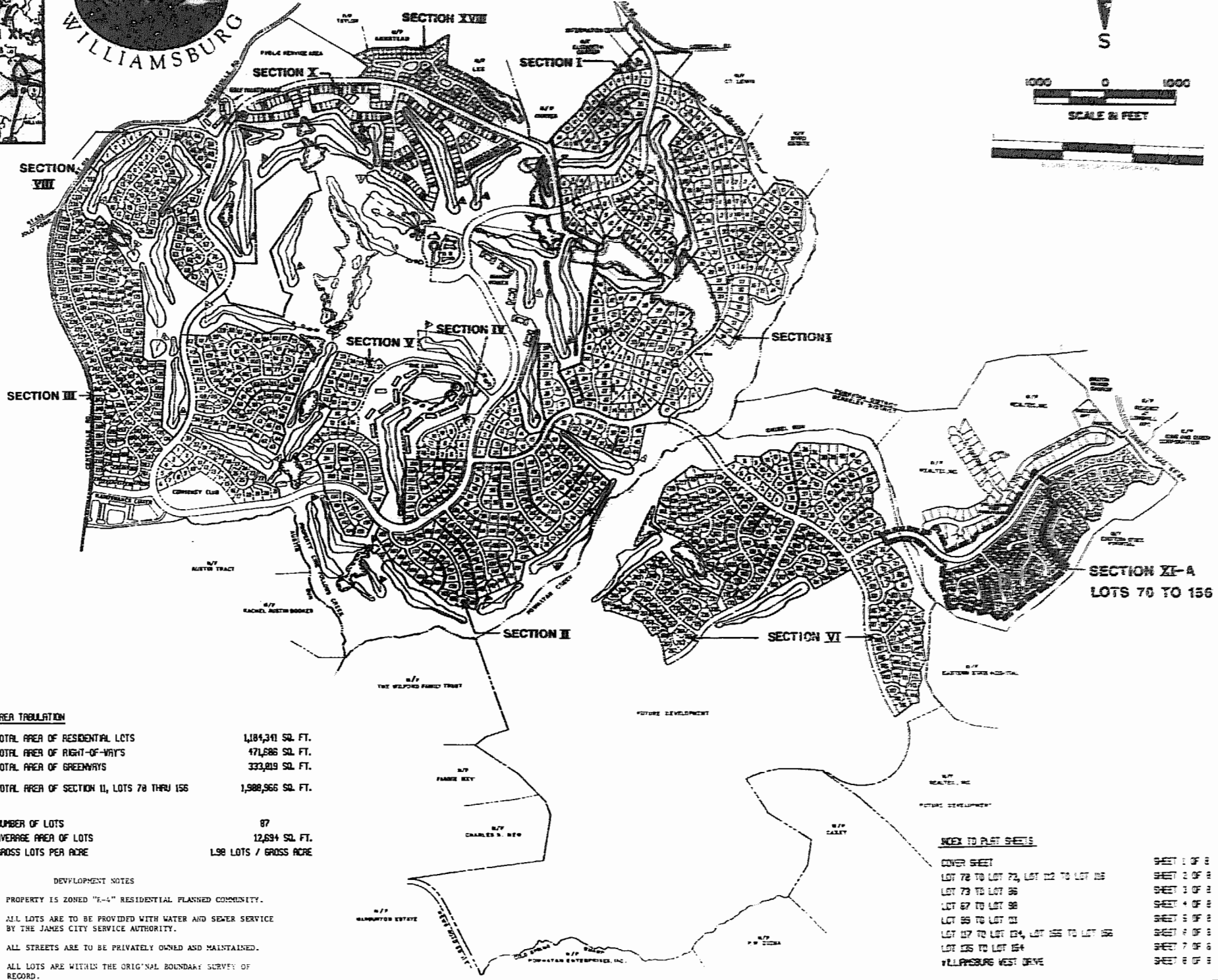

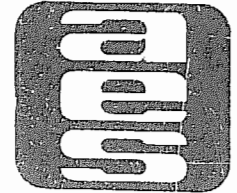
