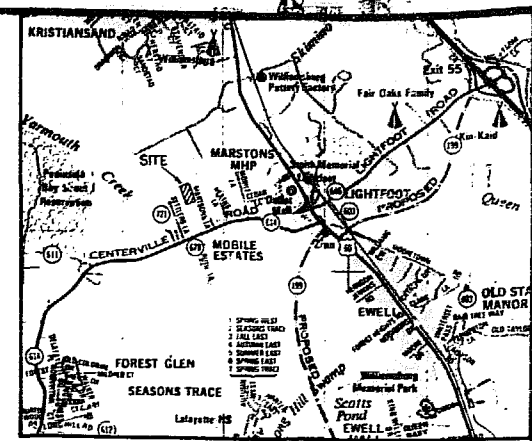
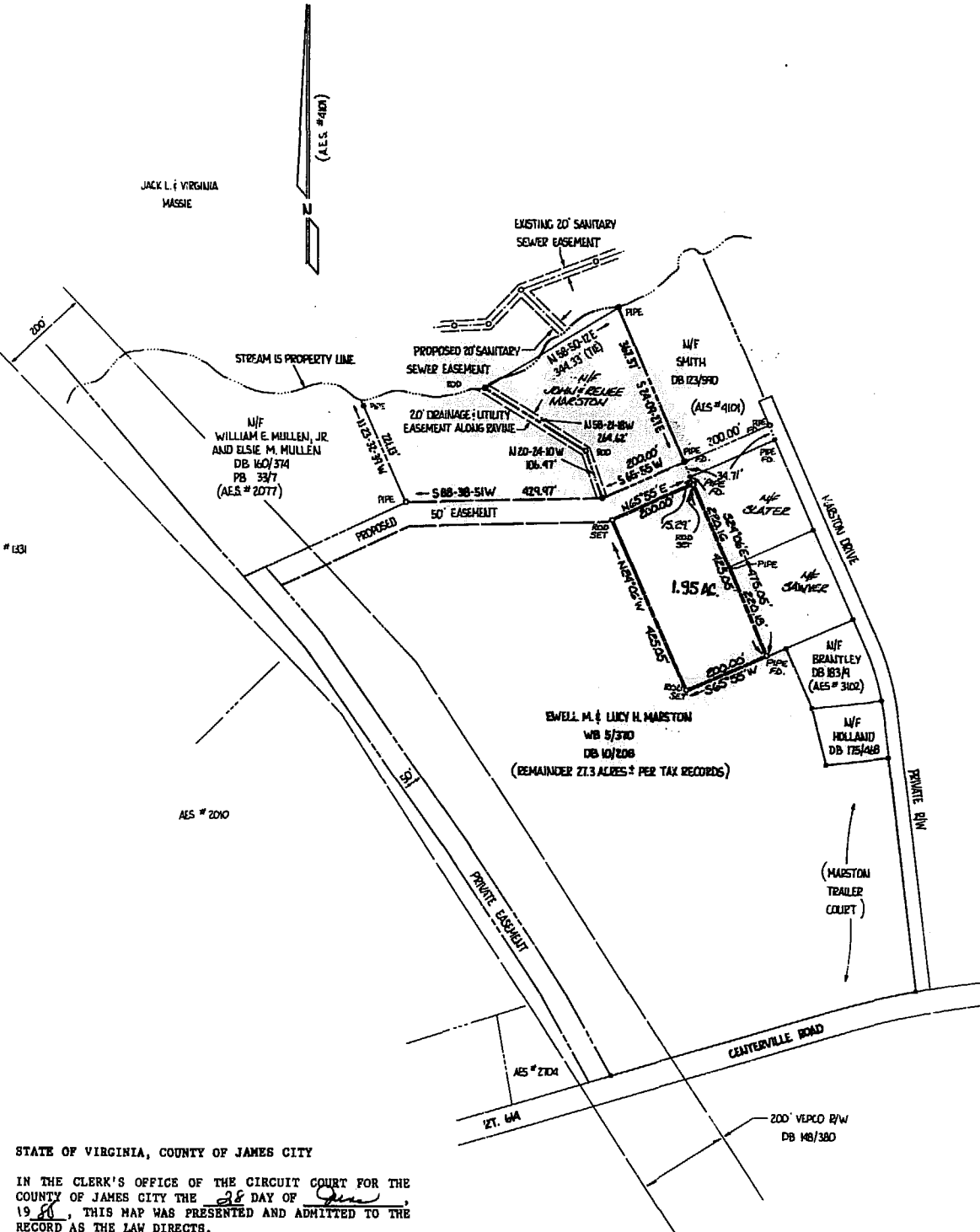

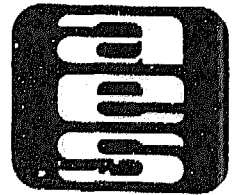


LOCATION MAP
