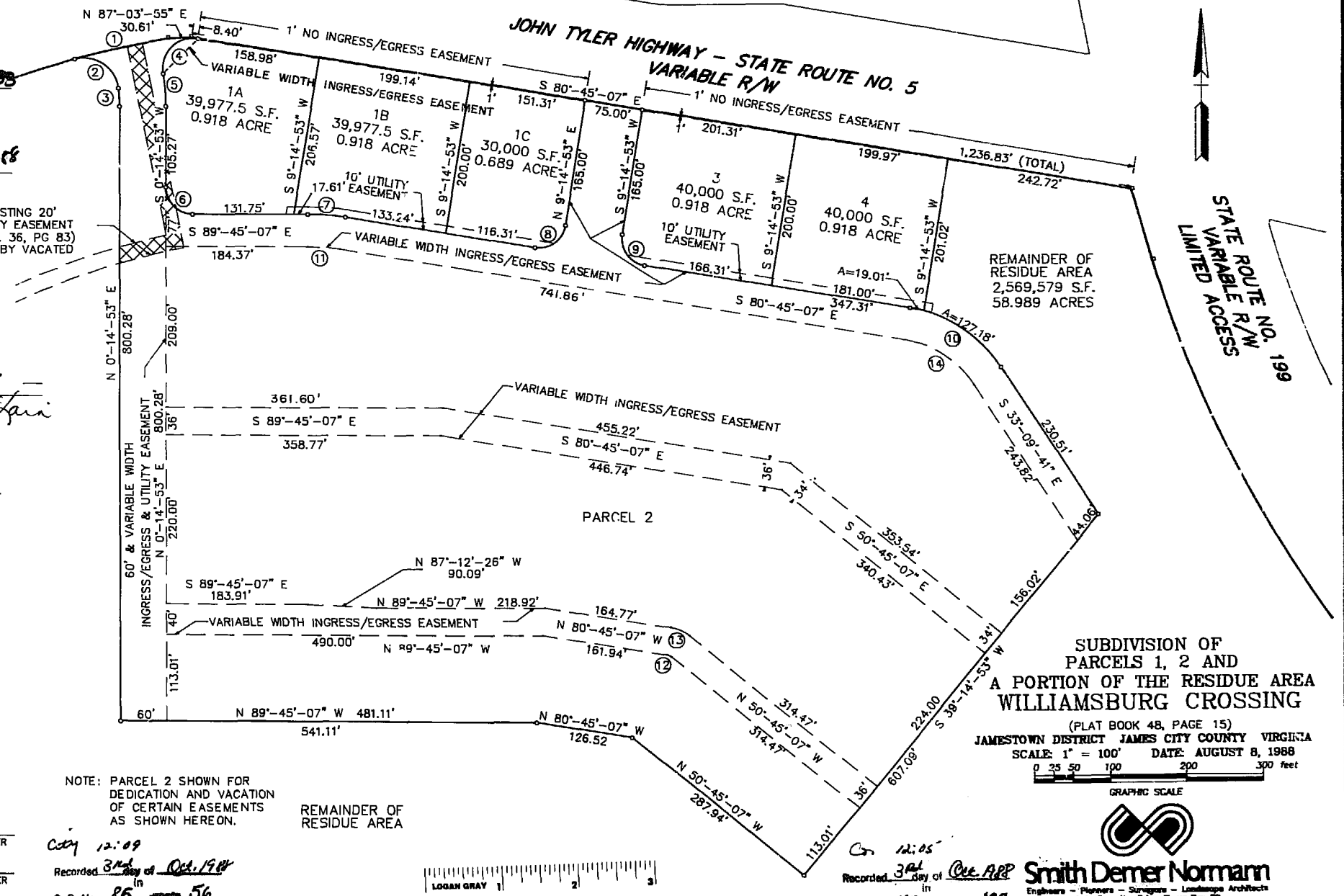

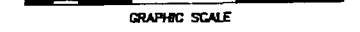


TOTAL AREA ENCOMPASSED BY THIS SUBDIVISION = 4.361 ACRES
