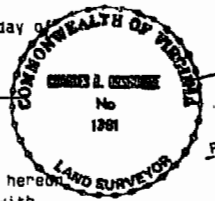

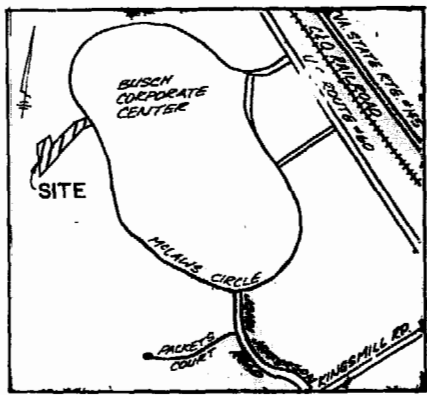

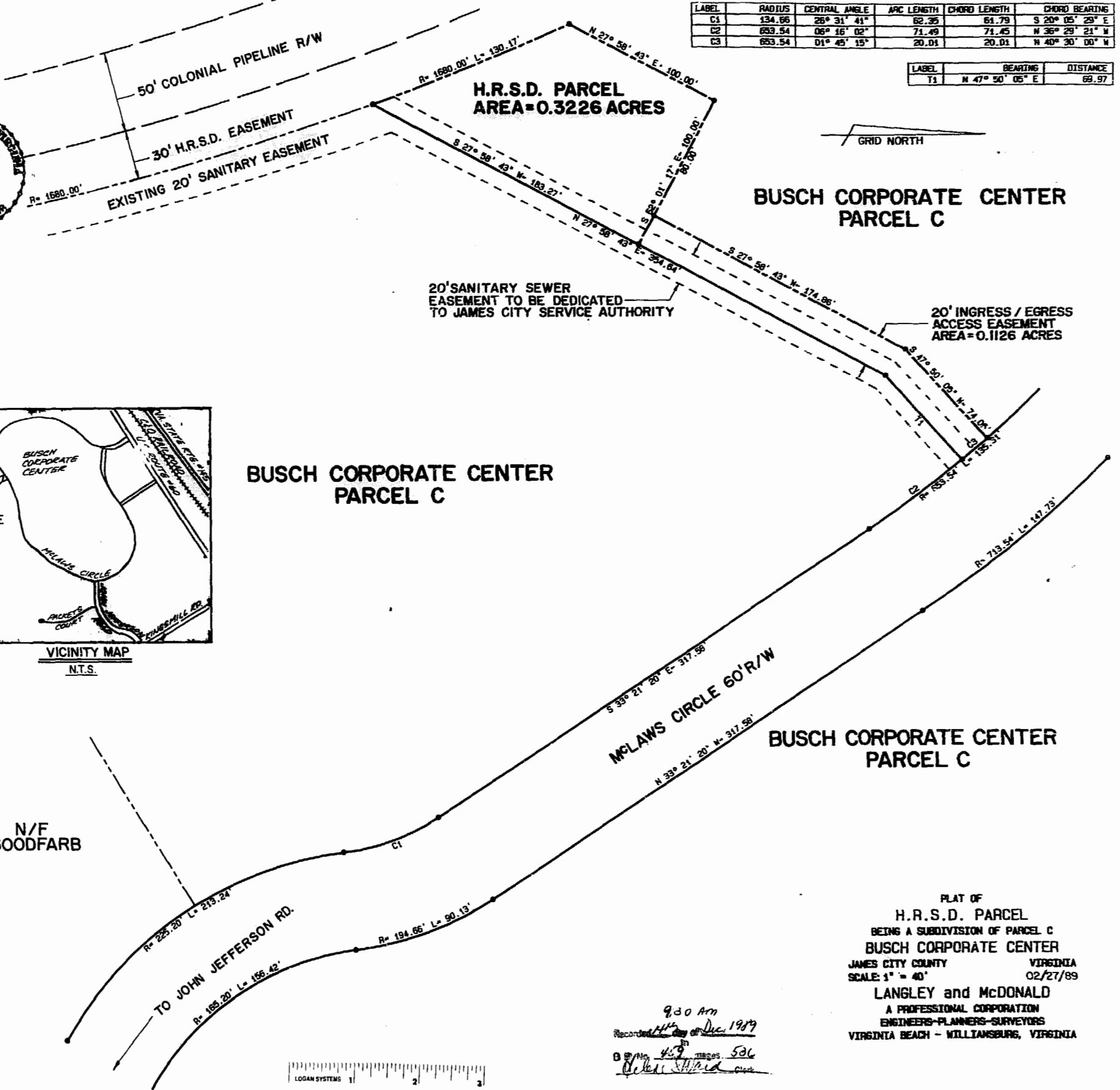


VICINITY MAP
