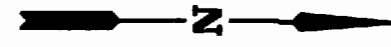


VICINITY MAP 1"=2000'

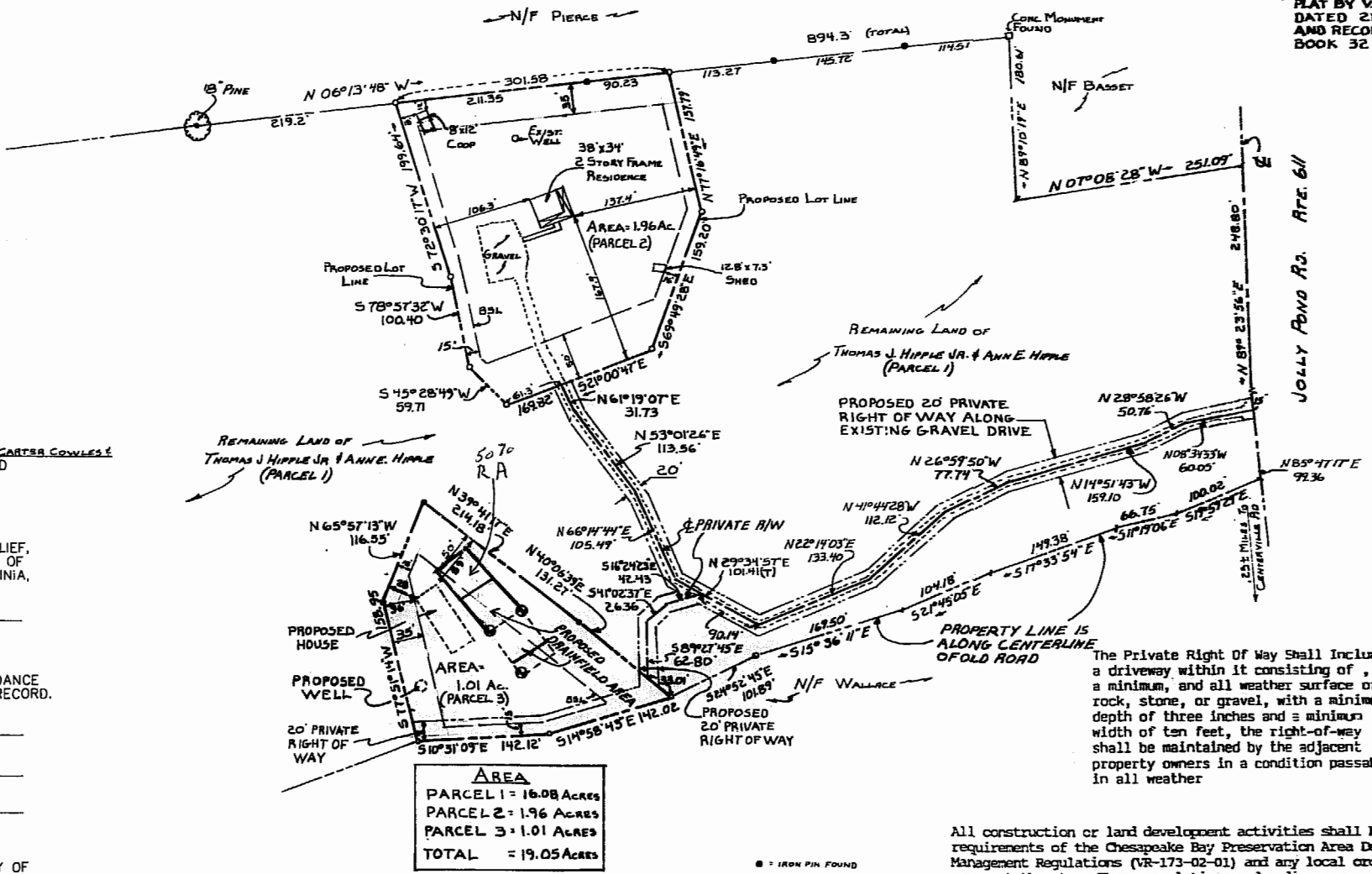

The Private Right of Way Shall include a driveway within it consisting of, at a minimum, and all weather surface of rock, stone, or gravel, with a minimum depth of three inches and a minimum width of ten feet, the right-of-way shall be maintained by the adjacent property owners in a condition passable in all weather

All construction or land development activities shall be subject to the requirements of the Chesapeake Bay Preservation Area Designation and Management Regulations (VR-173-02-01) and any local ordinances adopted pursuant thereto. These regulations and ordinances may place additional requirements on lots recorded after September 30, 1985, and may limit development of lots. Owners should familiarize themselves with the regulations and ordinances and are encouraged to contact the James City County Director of Code Compliance for more information.

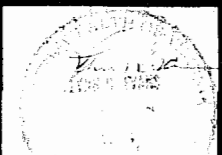
PROPERTY IS ZONED A-1
