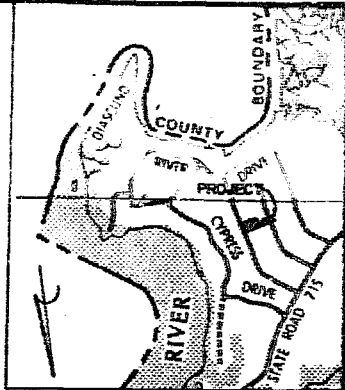


OWNER'S CERTIFICATE

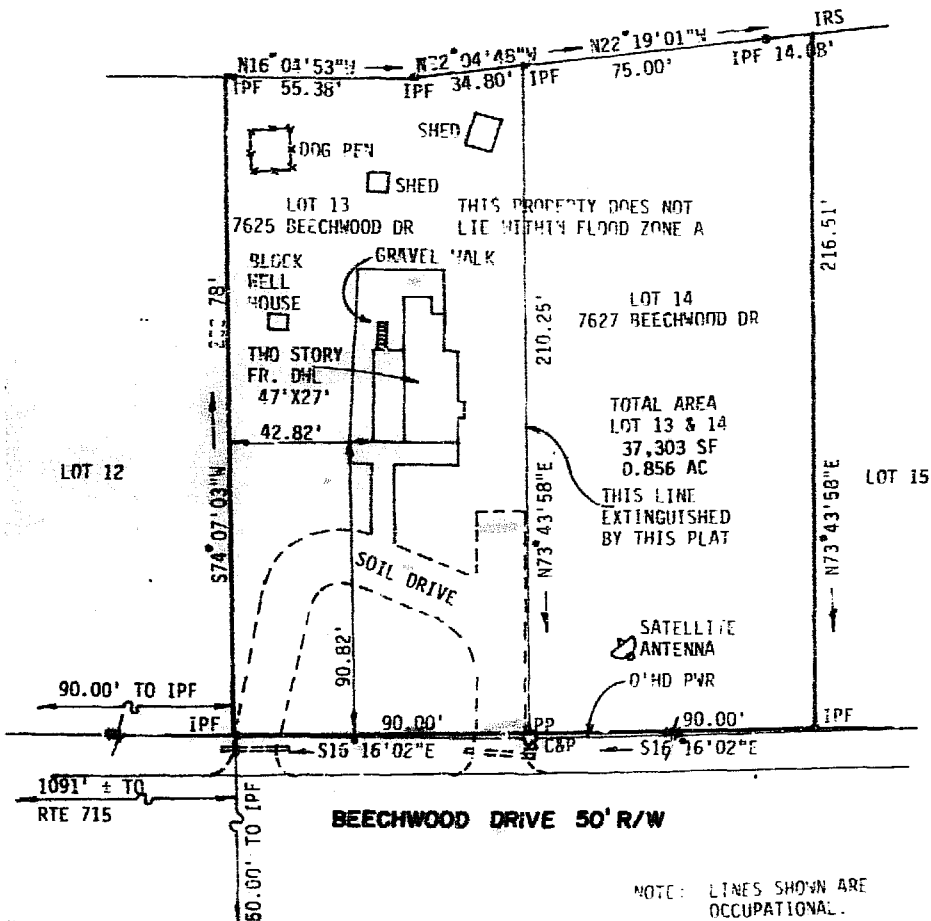
