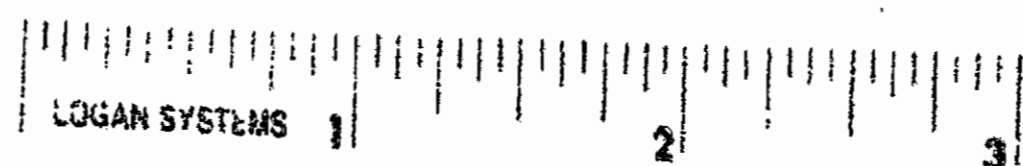
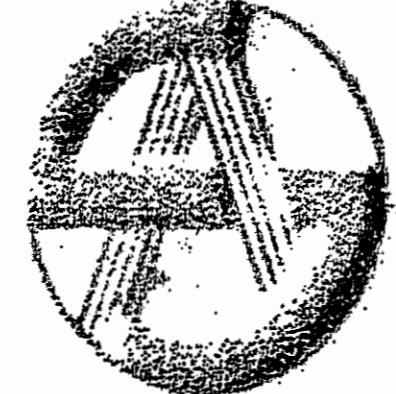
"B" AREA FOR CONVEYANCE TO LOT 16 = 504 S.F. ±
