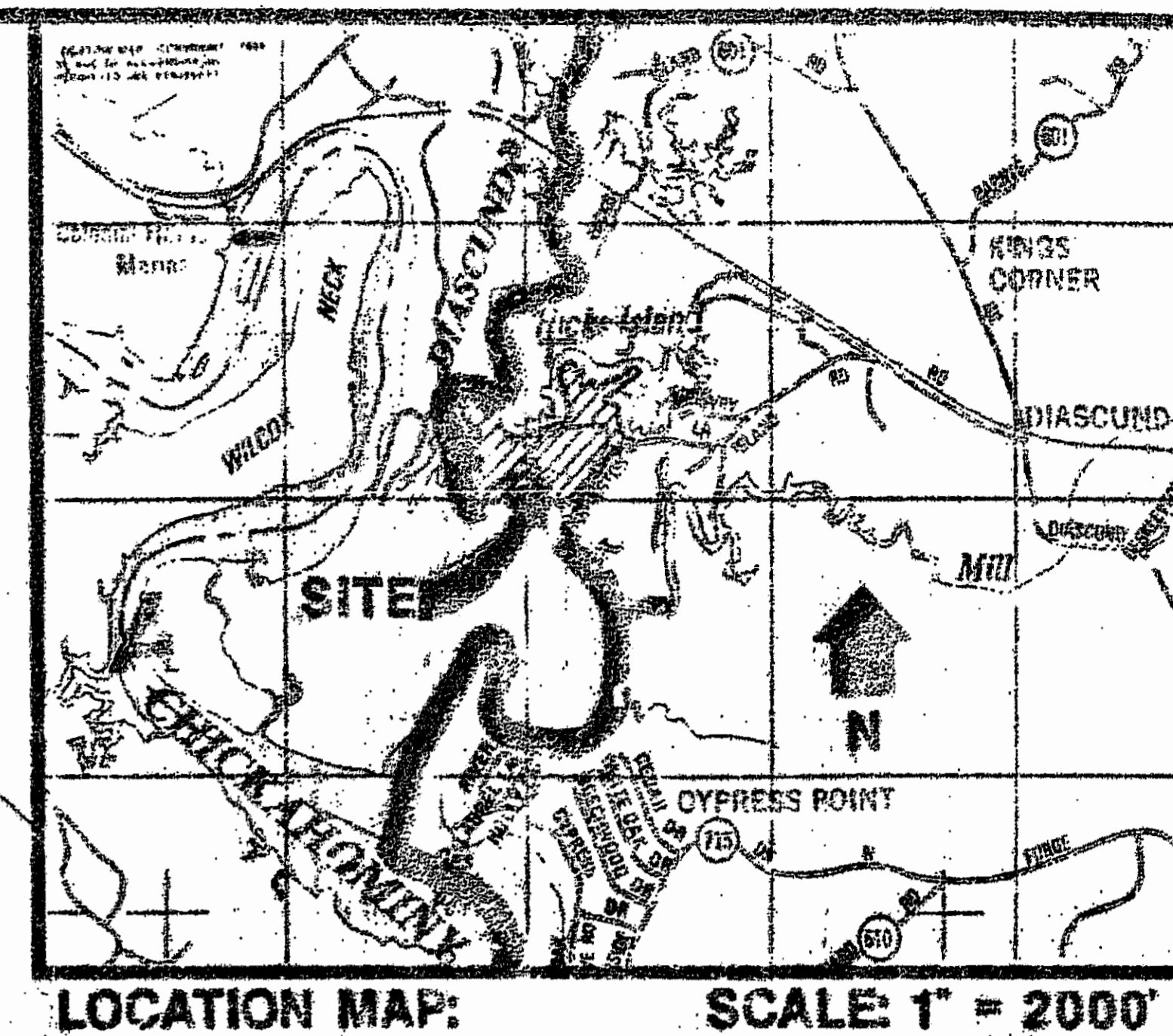
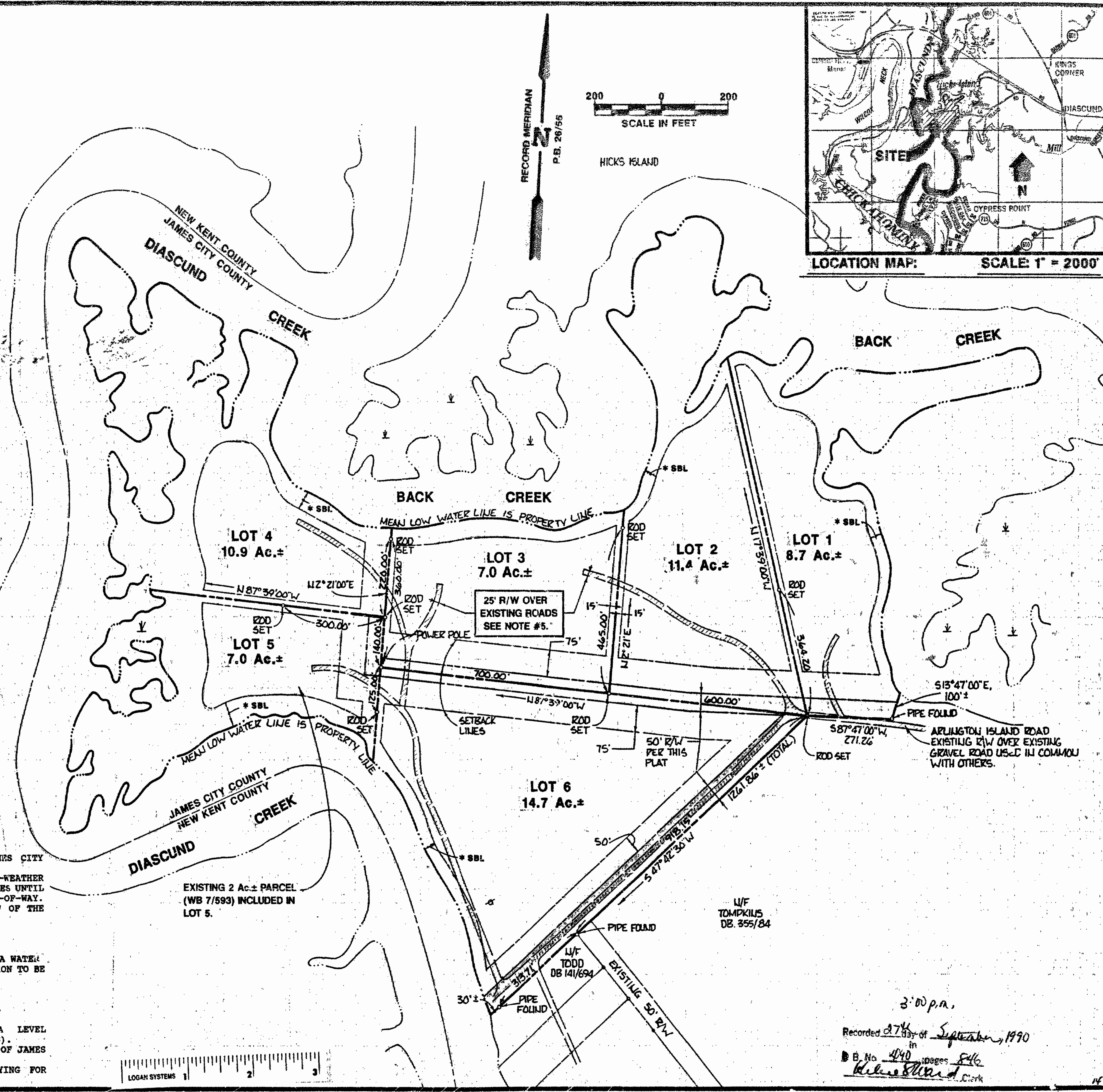

CHESAPEAKE BAY ACT NOTICE

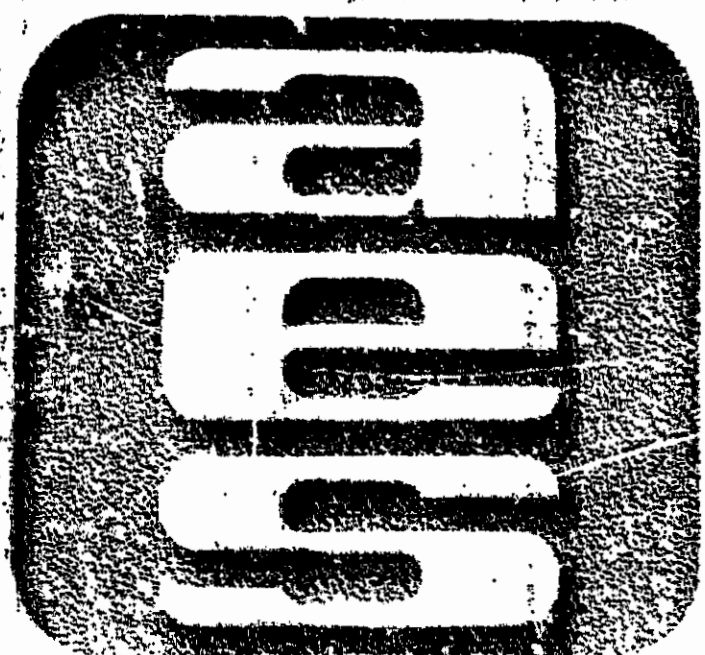

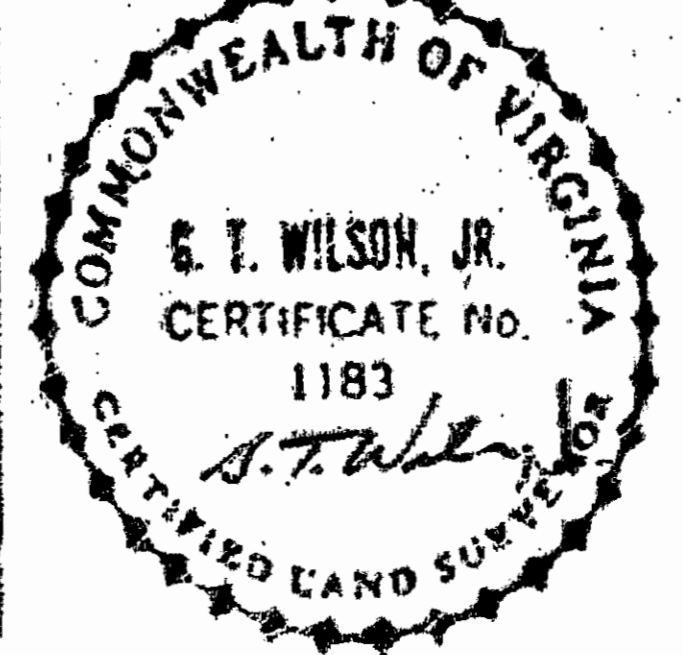
