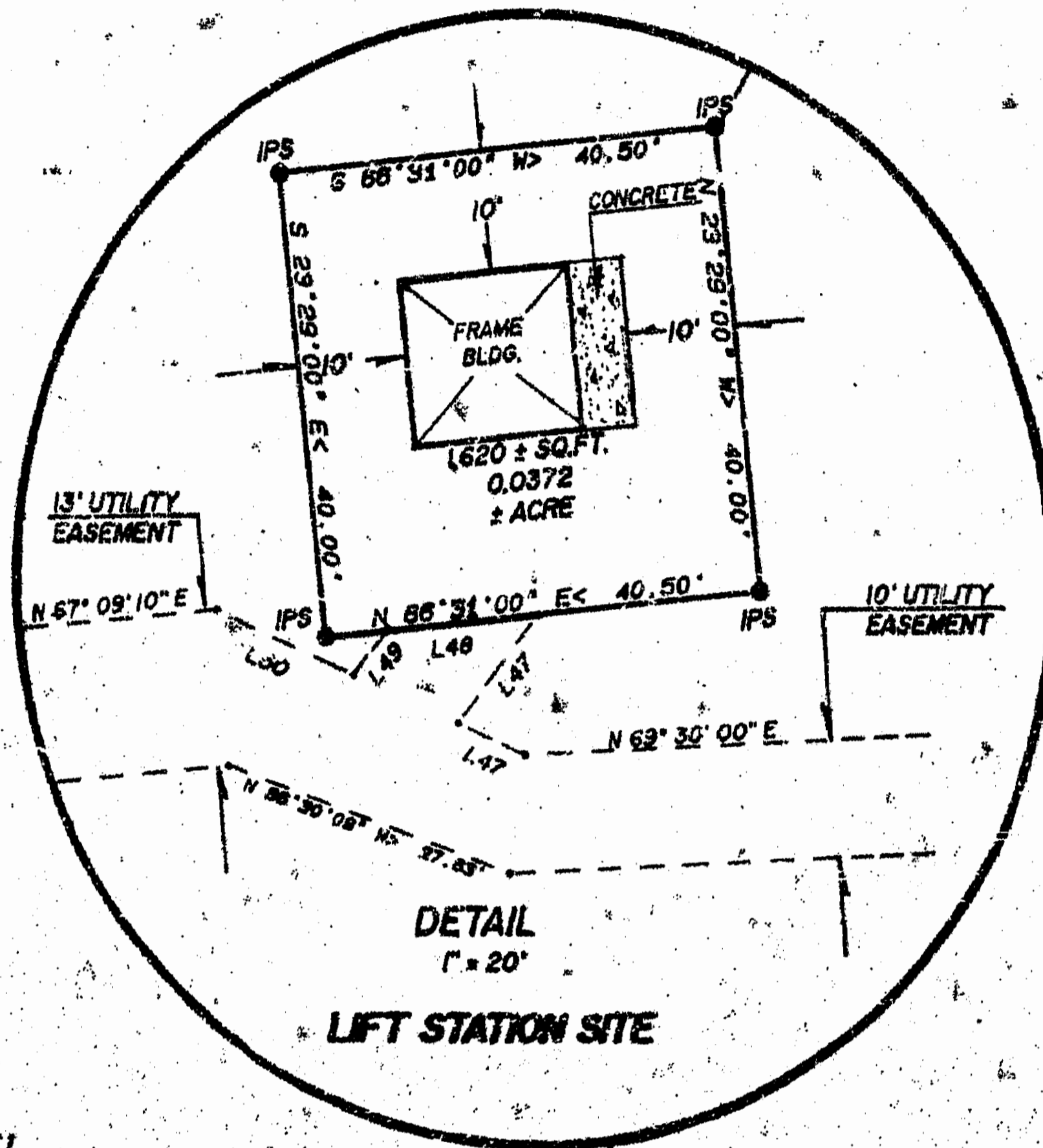
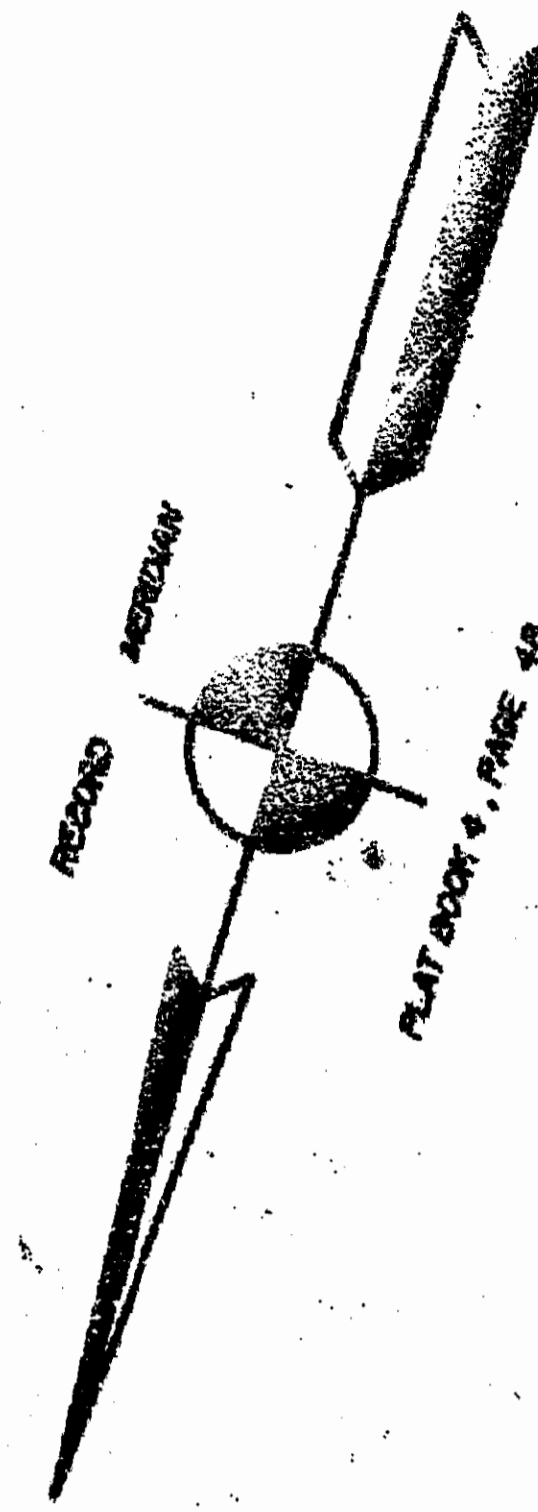

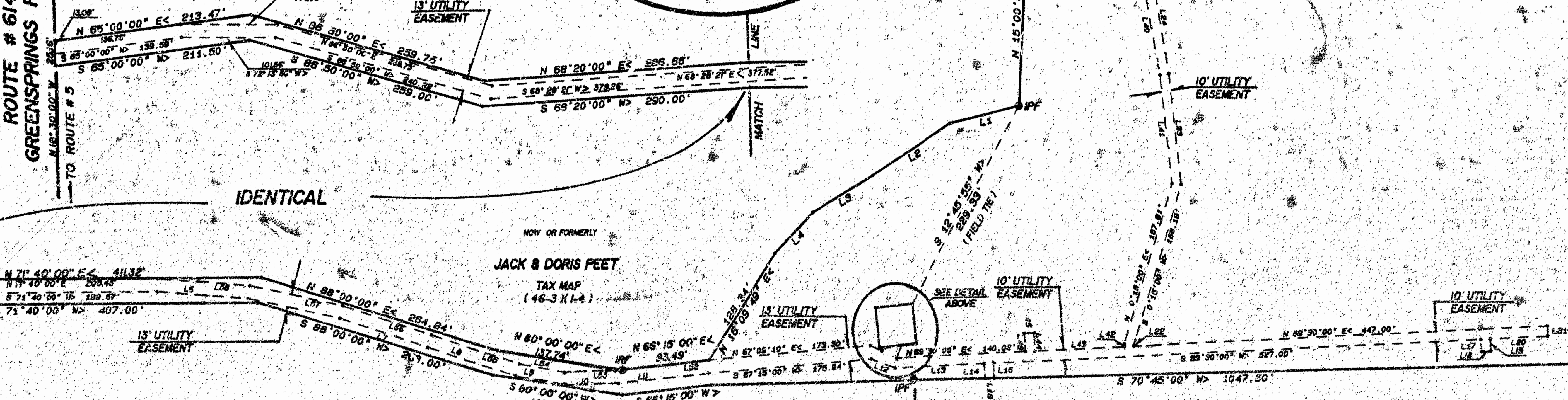


ROUTE # 614

TO RICHMOND

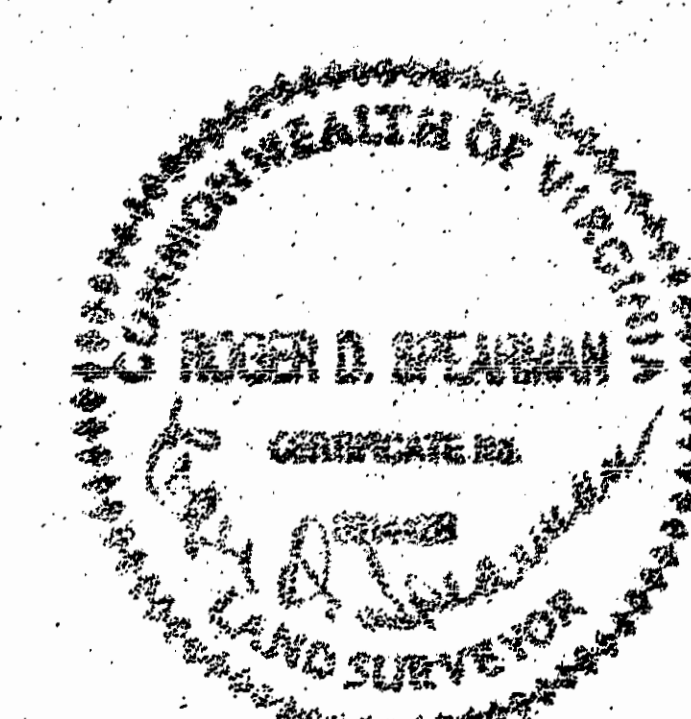
