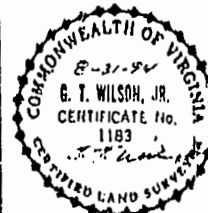

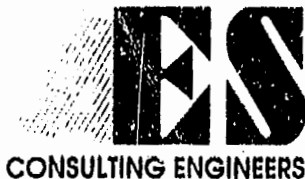
**PLAT OF CONDOMINIUM,
