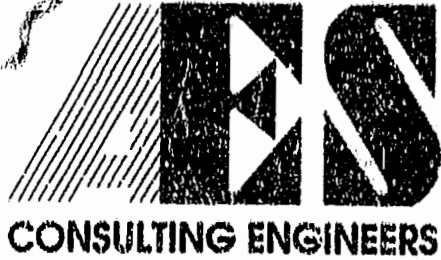


LOCATION MAP:
