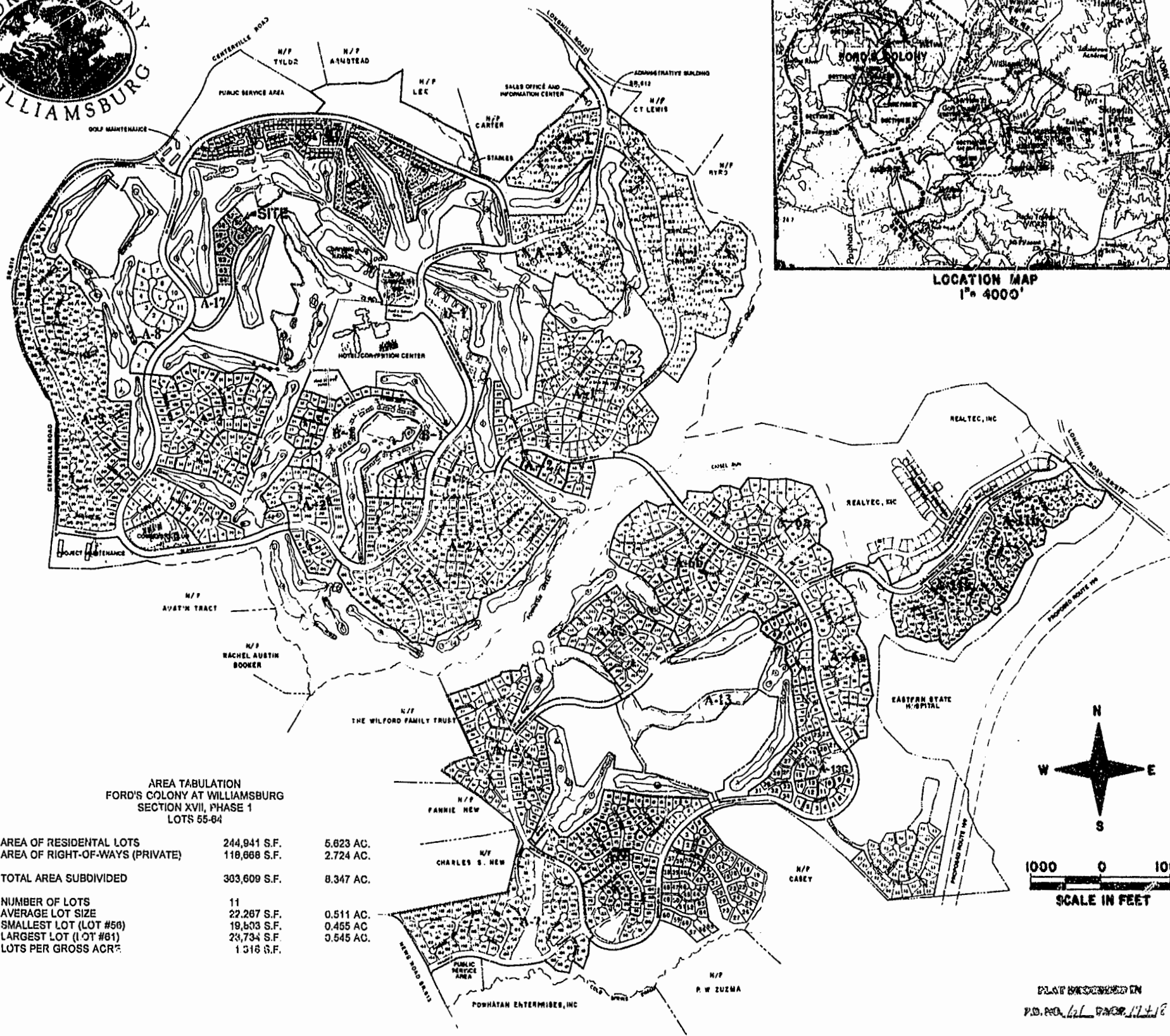

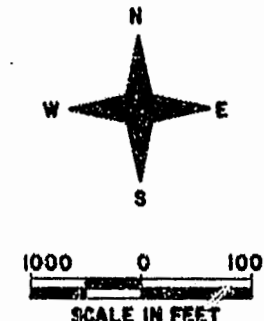
GENERAL NOTES

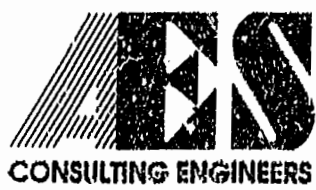
