

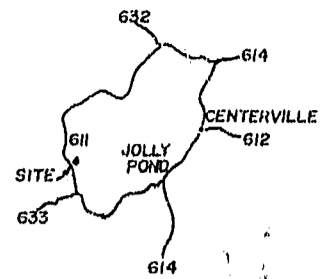

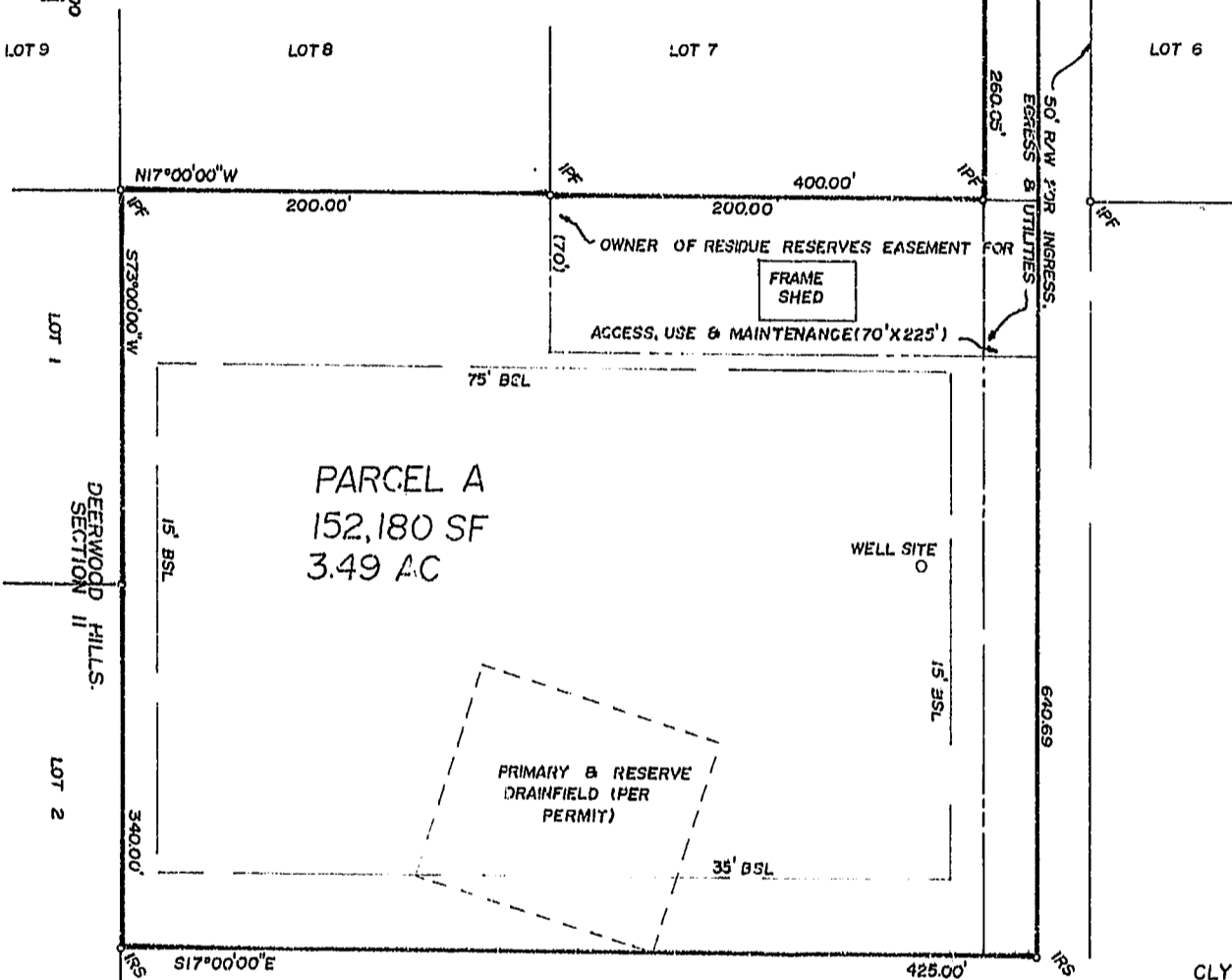


JOLLY POND ROAD
