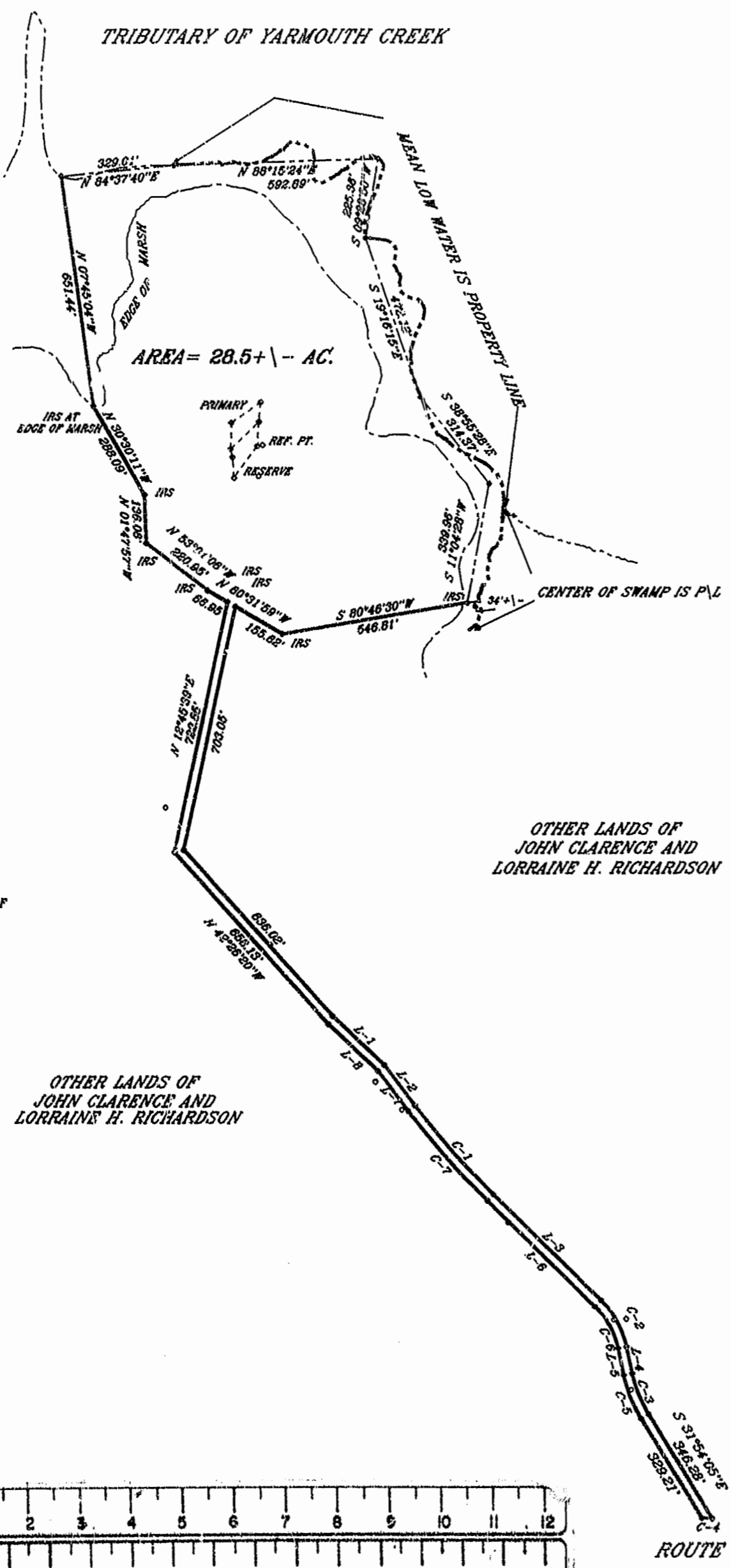
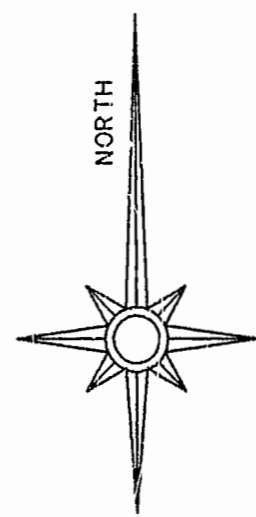


VICINITY MAP

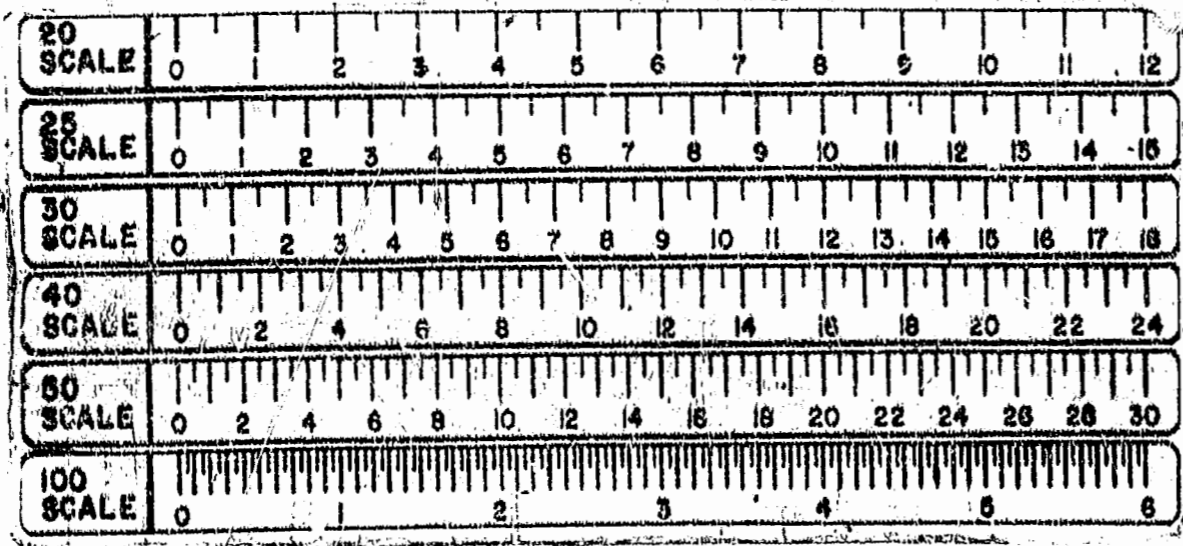
