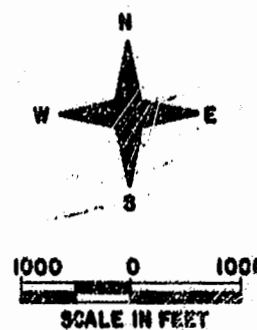

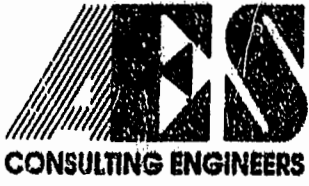
GENERAL NOTES:
