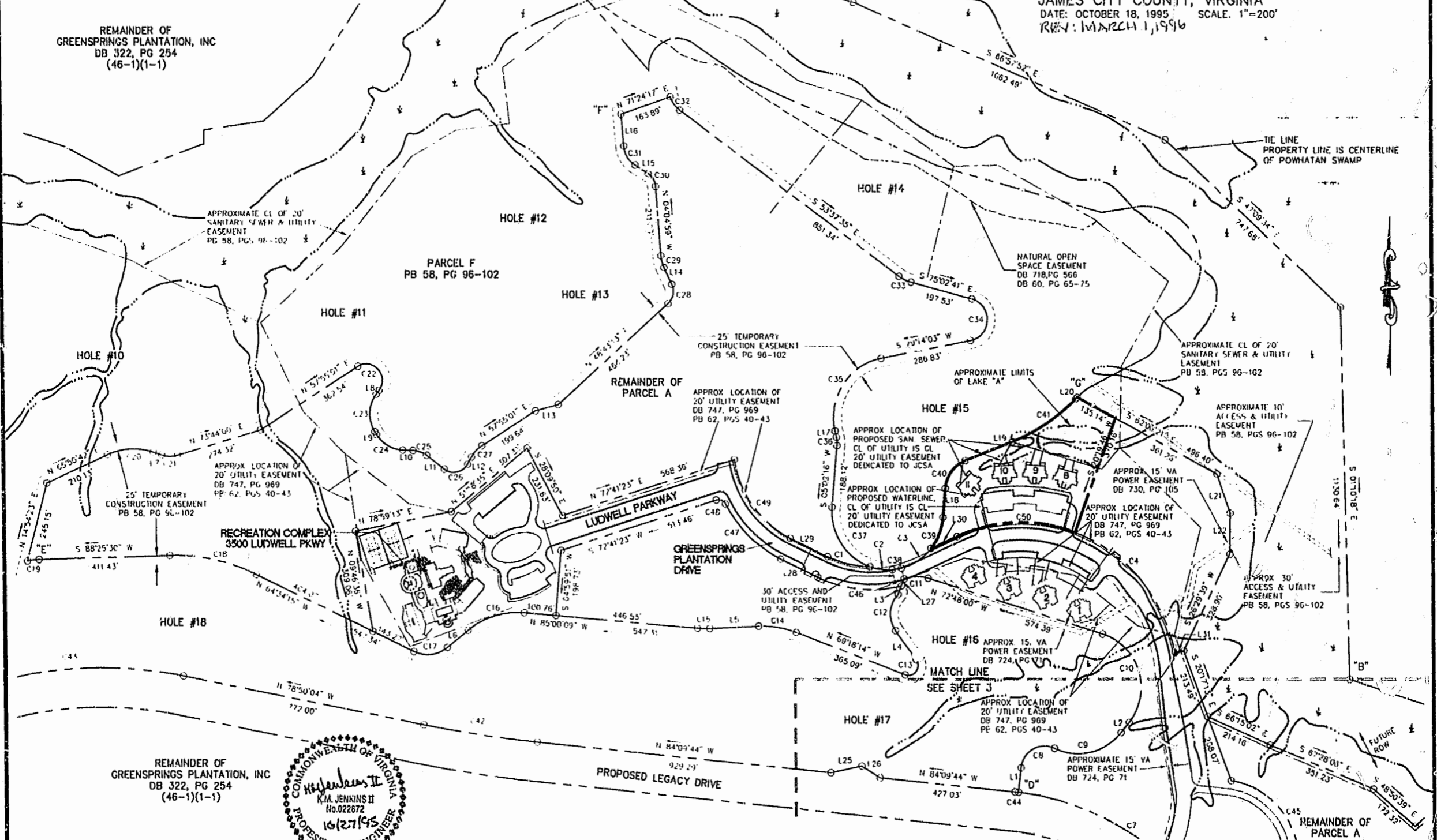


GREENSPRINGS PLANTATION RESORT PHASE II

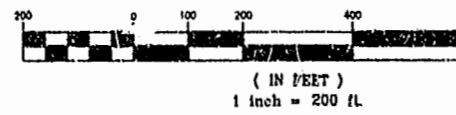
