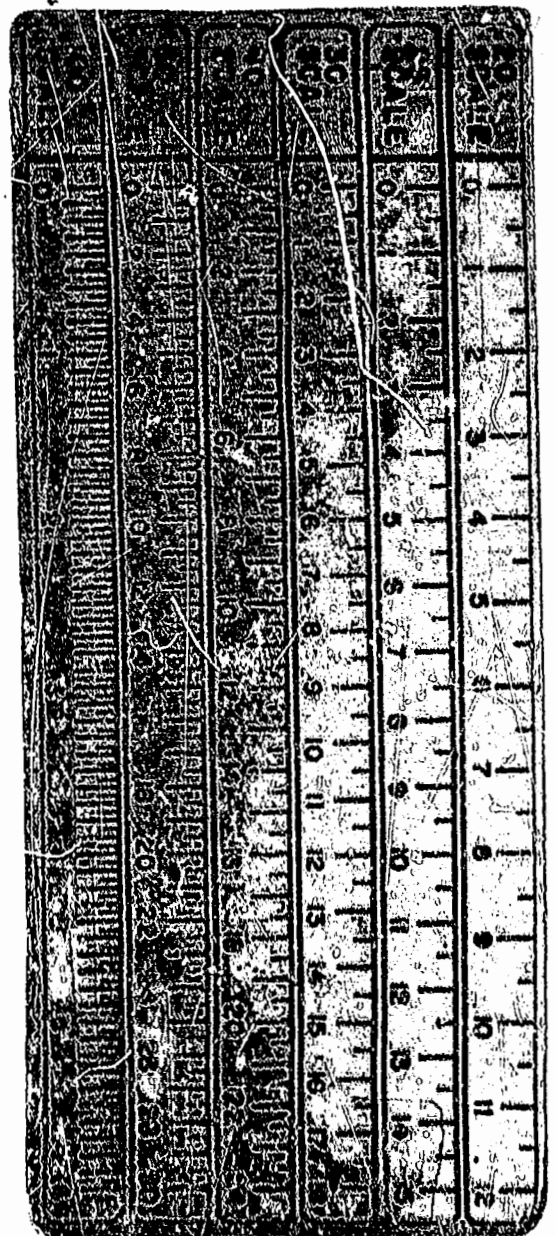
LOCATION MAP:
