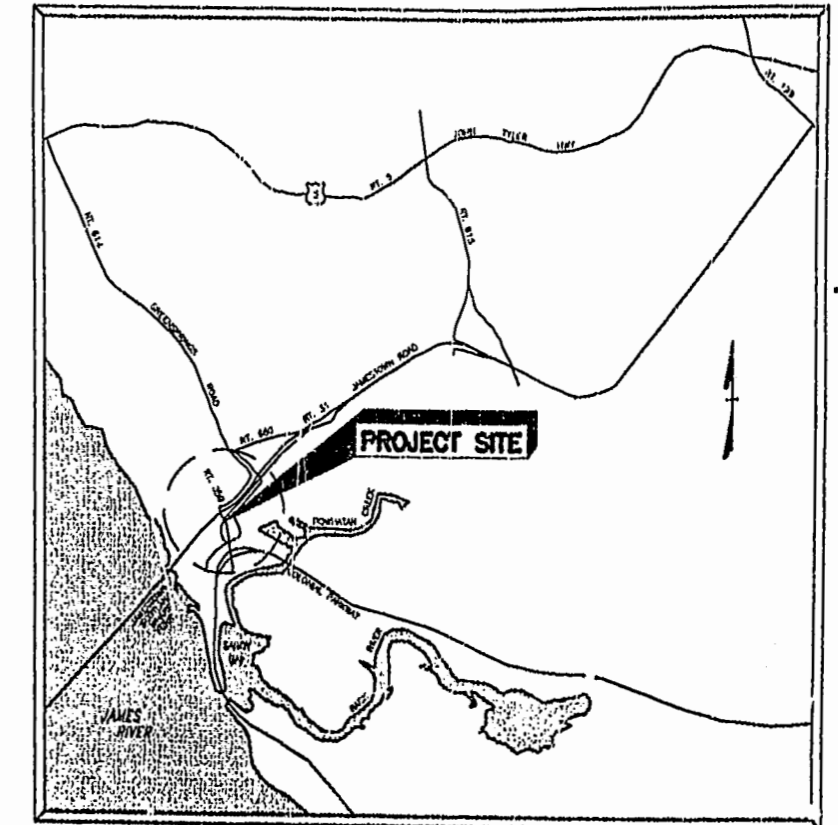

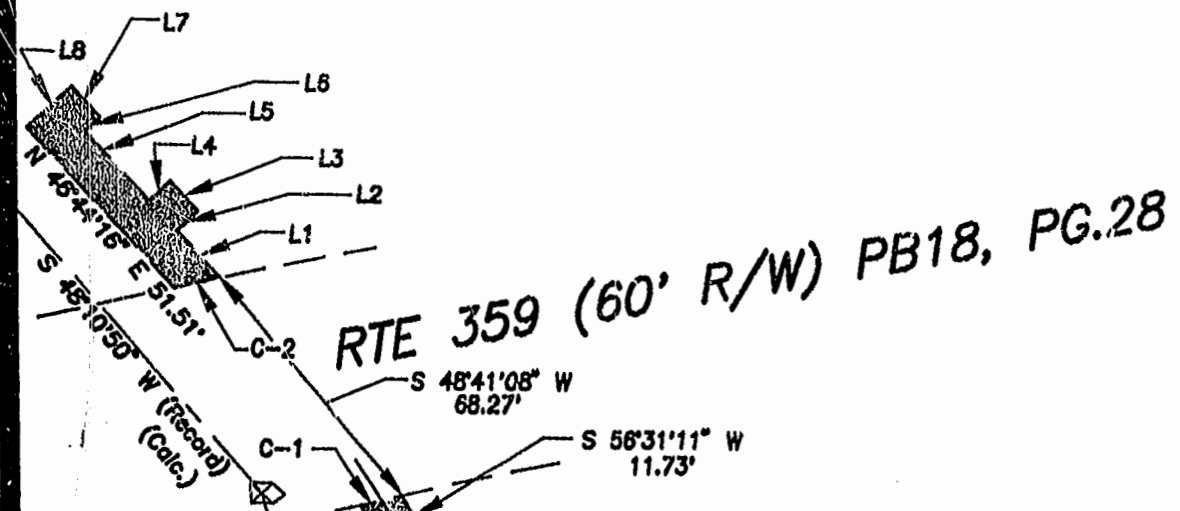
TAX MAP (46-3) PARCEL (1-16) & (1-15)

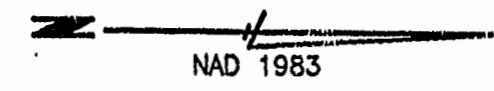

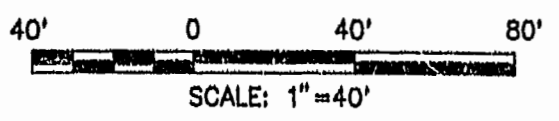
