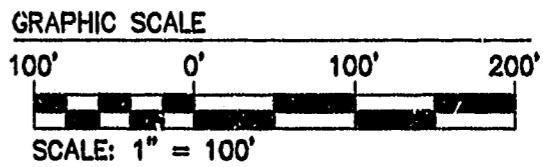
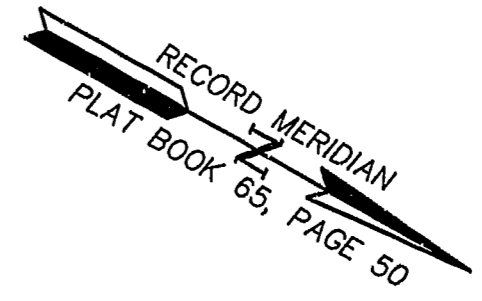

SCALE 1" = 4,000'±

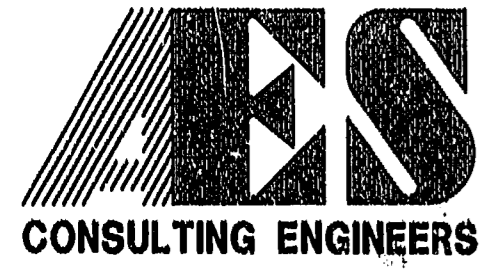
