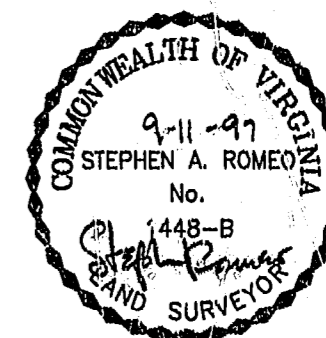

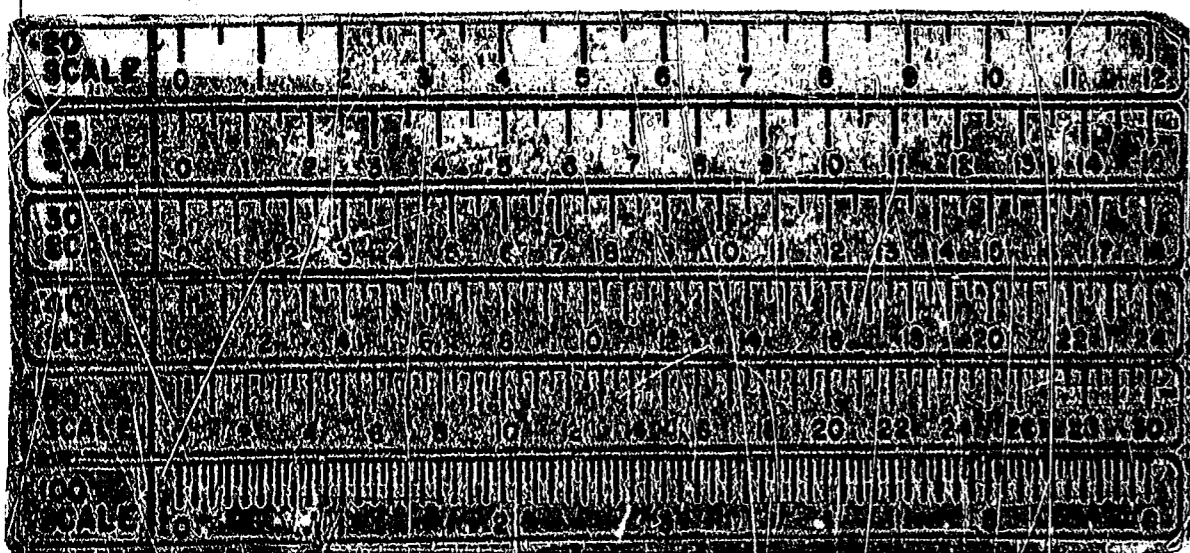


SUBDIVISION PLAT
