

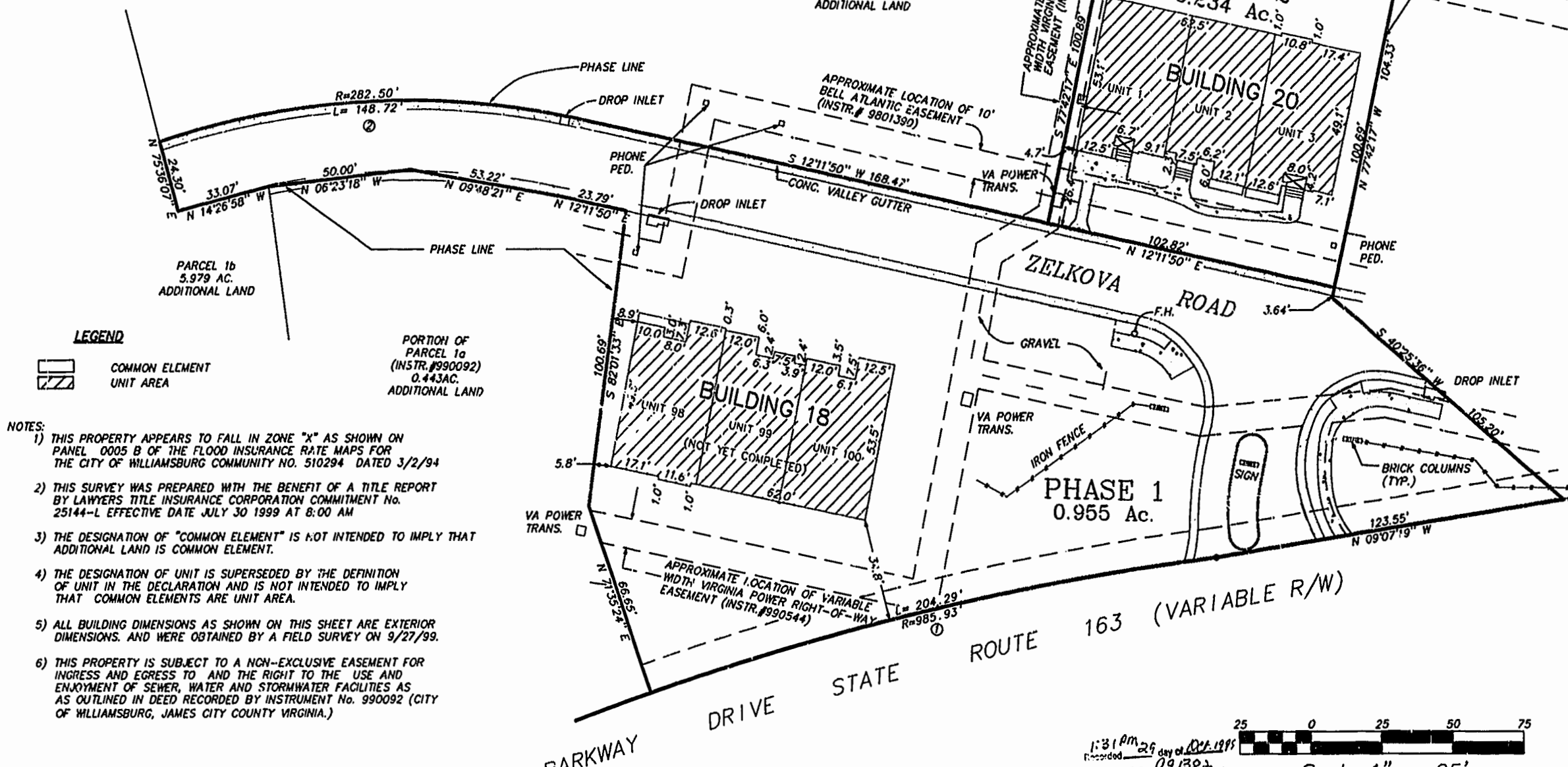
EXHIBIT B CONDOMINIUM PLATS AND PLANS FOR WYNDHAM PLANTATION CONDOMINIUM
