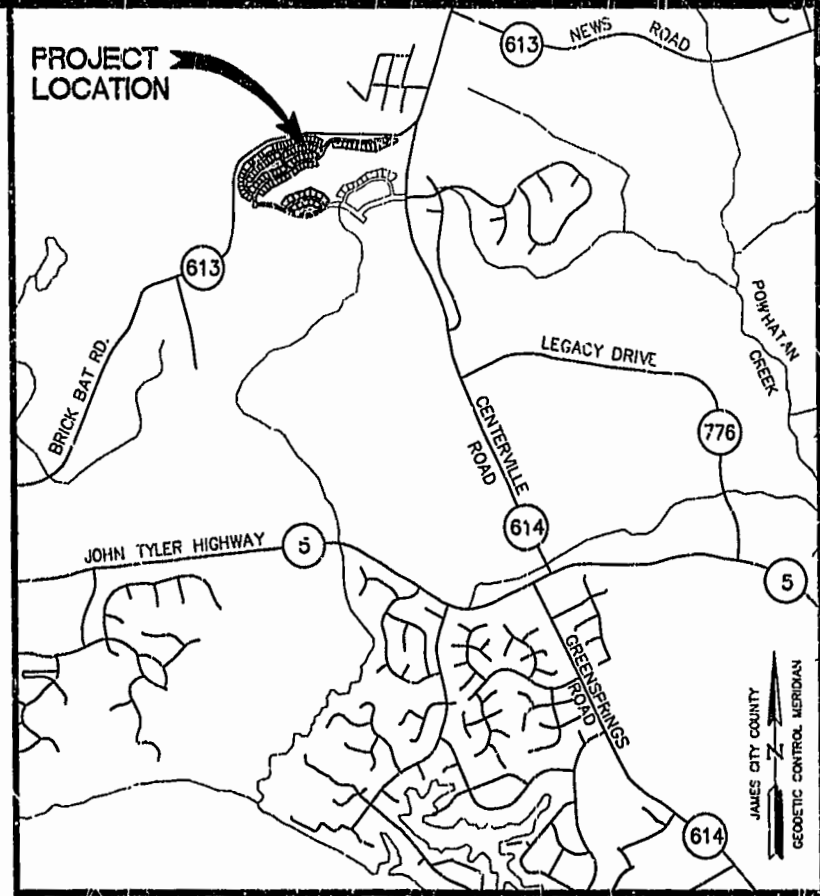

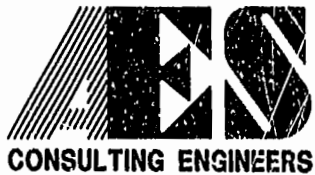


LOCATION MAP
