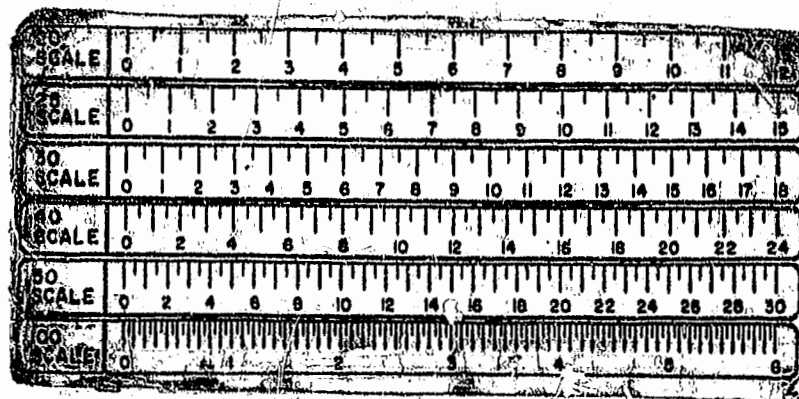


VICINITY MAP

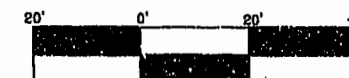


PLAT OF RIGHT-OF-WAY ACQUISITION

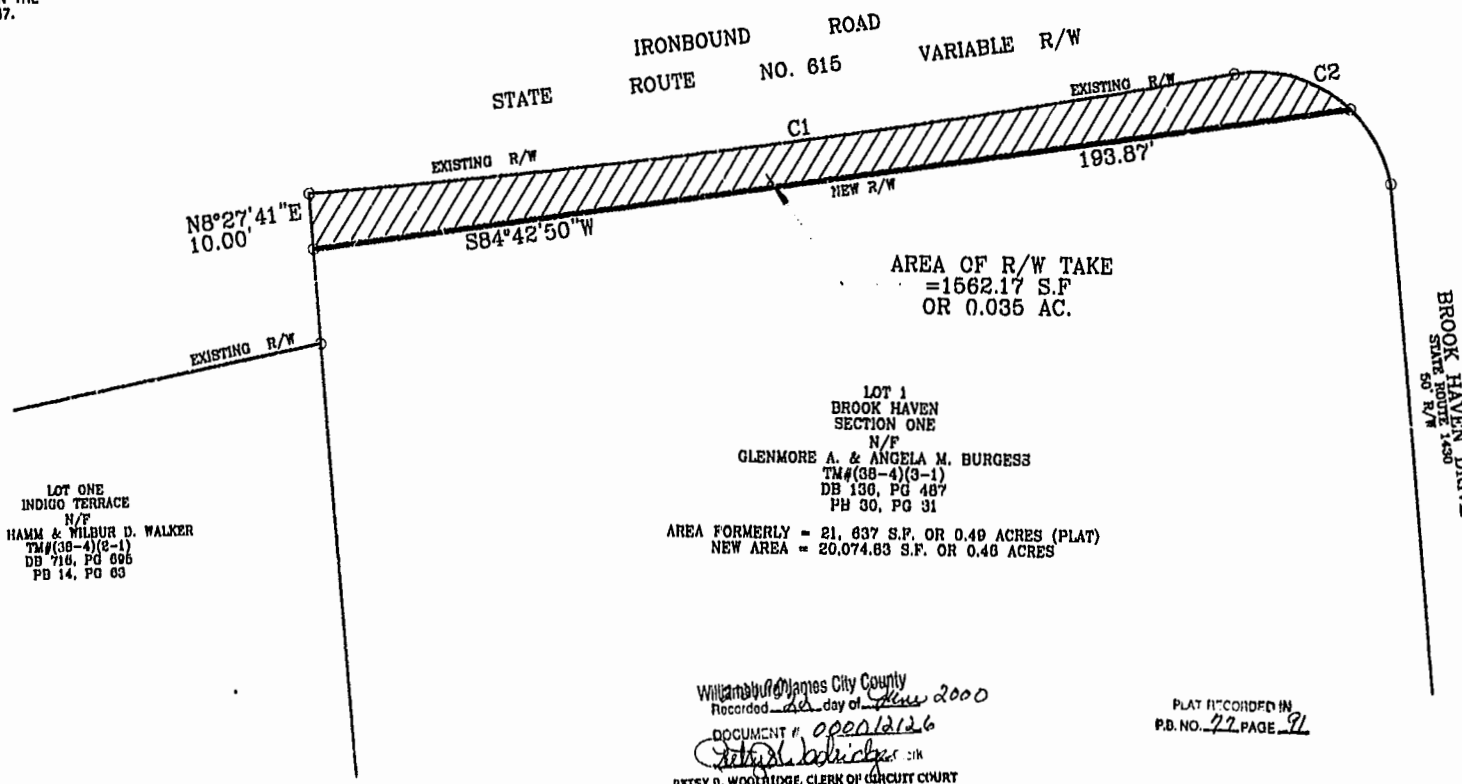
