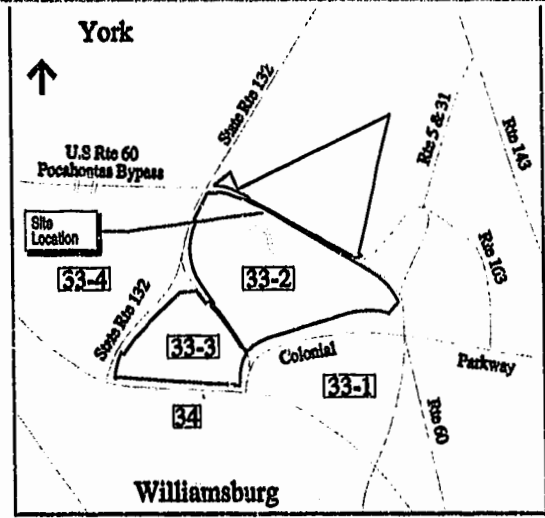


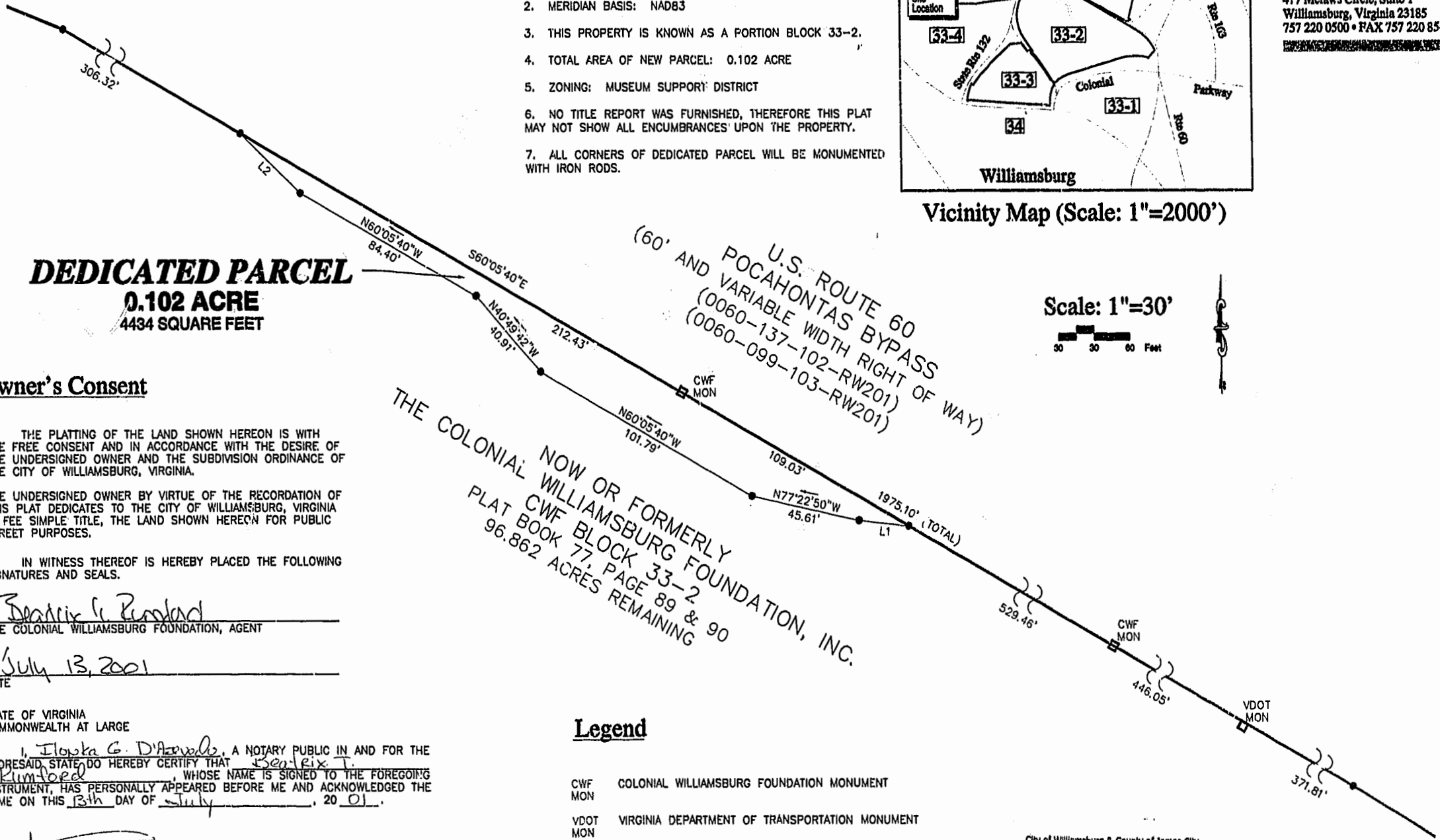
General Notes
